Many Syrians pass away in the prisons of the regime, ISIS, SDF and HTS

The total number of victims documented by the Syrian Human Rights Committee on Monday 1-4-2019, reached 6 people of whom 4 were killed under torture.

In the province of Idlib, a man died of wounds sustained due to a bomb explosion in his car a week ago.

In the province of Hama, a man was killed by the regime forces bombing of the city of Kafr Zeita.

In the province of Deir ez-Zor, a person was killed under torture in the Kurdish SDF militia prisons eight days after his arrest.

Three people were killed under torture in the prisons of the regime forces: one from Latakia province who was killed in Sidnaya military prison, another one from the province of al-Raqqa who was killed after five years of detention, and the third one from Daraa province who was killed two months after taking him to the military compulsory service despite settling his status with the regime.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Haydar Qazrabash / Latakia – Jablah / died under torture in Sednaya prison.

2. Nasser Muhammad al-Shehadat / Daraa – Da’el / died under torture in one of the security branches of the regime forces.

3 – Ahmad Musleh al-Dawas / Deir ez-Zor – Hawayej Thiban / died under torture in a prison of the Kurdish militia of SDF.

4 – Saddam Mahmoud al-Kous / al-Raqqa / died under torture in one of the prisons of the regime forces.

5 – Maher al-Mohbani / Homs / died in an explosive device in his car in Idlib.

6 – Mohammed Abdul Rahman al-Ra'i / Hama countryside – Kafr Zeita / due to the shelling of the city.

The total number of victims documented by the Syrian Human Rights Committee on Tuesday 2-4-2019 reached one person.

In the province of Aleppo, a girl was killed by shelling of rocket launchers by the regime forces which targeted the town of Kfar-Hamra in the northern countryside.

The Syrian Human Rights Committee documented the names of the following victim:

1 – Ndim Faiz Ramadan/ girl / Aleppo countryside – Kafr-Hamra / due to the shelling on the town.

Syria regime and Russian war planes resume their attack on Idlib province

The total number of victims documented by the Syrian Human Rights Committee on Wednesday 3-4, reached 12 people of whom 6 children, one woman and one person killed under torture.

In the province of Hama, 5 people were killed by the bombing of the regime forces, of whom 3 people in al-Hawaija village and 1 in al-Hawash village and 1 in al-Anakawi village.

In the province of al-Raqqa, 3 people were killed, of whom 2 in a landmine explosion in al-Diriyah neighbourhood, west of al-Raqqa city, and 1 person was killed under torture in a prison of the Kurdish militia of SDF.

In the province of Aleppo 3 people were killed due to the bombing of the regime forces that targeted the town of Khan al-Asal.

One person was also killed in the province of Idlib due to the shelling of the town of Maar Shamarin.

The Syrian Human Rights Committee documented the names of the following victims:

Russian and Syrian regime bombing of Kafranbel claimed 14 lives including children and women

The total number of victims documented by the Syrian Human Rights Committee on Thursday, 4-4-2019, reached 17 people, of whom 6 children and 2 women.

In the province of Idlib, 14 people, of whom 13 people (including 5 children and 2 women), were killed by the shelling of the city of Kafranbel and a child was killed by the shelling of the city of Ma'arat al-Nu'man.

Three people, including a child, were killed in the province of Deir ez-Zor due to a landmine explosion under their car in Deir ez-Zor desert.

The total number of victims documented by the Syrian Human Rights Committee on Friday 5/4-2019, reached 3 persons of whom 2 were killed under torture.

In the capital Damascus, two persons from the Yarmouk camp were killed under torture in the prisons of the regime's forces.

In the province of Idlib, a person was killed by a wound caused by the double explosion that targeted al-Qusoor neighbourhood in the city of Idlib about a month ago.

The Syrian Human Rights Committee documented the names of the following victims:

In the spring, people go to the desert to collect truffles, but struck by the landmines or killed by ISIS, SDF, or regime forces

The total number of victims documented by the Syrian Human Rights Committee on Saturday, April 6, 2019 reached 18 people, of whom two children, three women and one person who was killed under torture.

In the province of Deir ez-Zor, 10 people were killed, including 6 who were liquidated by unknown persons in the Khedr al-Maa' area after being lost for a while, while they were searching for the truffle fungus, and 4 were killed in a landmine explosion in al-Badia al-Shamiya and al-Shu'fa town.

In the province of Idlib, 5 people were killed, of whom two children, one a girl, shot by the Turkish border guards in Turlaha district, the other child was killed in the shelling of the city of Kafranabel. One died of his wounds after being shot in the vicinity of Idlib and one was killed in the prisons of the regime forces.

In the province of Hama, 3 people, of whom a woman, were killed by the artillery shelling of al-Sharia town by the regime forces.

The Syrian Human Rights Committee documented the names of the following victims:

Bombing the city of Saraqeb

The total number of victims documented by the Syrian Human Rights Committee on Sunday, April 7, 2019, reached 13 people of whom two children and one woman.

In the province of Idlib, 11 people were killed in the bombing of cities and towns of the province, of whom six people in the town of Nairab, and three in the city of Saraqeb, and one person in both the town of Al-Khoein and the village of Saqeea.

In the province of Deir ez-Zor, one person was killed in the town of Shuf'ah while he was managing to dismantle the landmines left behind by ISIS in the town.

In the province of Hama, one person was killed in the bombing of the town of Kafer Zeita in the province northern countryside.

The Syrian Human Rights Committee documented the following victims:

The car bomb explosion in al-Nour street, al-Raqqa city @ 9th April 2019

The total number of victims documented by the Syrian Human Rights Committee on Tuesday 9th April 2019 reached 16 people of whom 5 children, 2 women and 2 were tortured to death.

In the province of al-Raqqa, 12 people were killed, 10 of whom were killed in a car bomb explosion in al-Nour Street in the city of al-Raqqa, and 2 were killed by unknown persons in Al-Hawra village in the southern countryside.

A child was killed in Idlib province in a mine explosion in front of his house in the village of Ma'arshmarin.

A child in Daraa province was also killed in a mine explosion in the Manshiyya district at Daraa al-Balad.

SHRC also documented the death of 2 persons under torture, one from the province of Hama, his death was notified by the Civil Registry office after a year of his arrest.

The Syrian Human Rights Committee documented the names of the following victims:

The total number of victims documented by the Syrian Human Rights Committee on Wednesday, the 0th of April 2019 reached 15 people of whom 2 children and 2 persons who were killed under torture.

In the province of Deir ez-Zor, 5 people were killed, 3 of them in a landmine explosion left behind by ISIS in al-Shuf'ah town, another one whose body was found in a mass grave in al-Mayadeen city, and the fifth was killed by unknown in the town of Hawaii.

In the province of Hama (5) people were killed on 7-4-2019, of whom a child in a bombing targeted the city of Misyaf by the opposition factions.

In the province of Idlib, 3 people were killed, of whom a girl who died due to her injuries resulted from the regime shelling al-Nairb village. Two people were killed under torture, one in the prisons of the regime forces and the other in the prisons of the Sham Liberation Organisation.

In the province of Daraa, a person died due to the deterioration of his health resulted from his arrest in the regime prisons on charges of belonging to ISIS.. Another person was assassinated in the province of Aleppo on the road to the town of Rajo in the countryside of Afrin.

The Syrian Human Rights Committee documented the names of the following victims:

In the province of Hama, 3 persons were killed, two of them by the bombing of the town of Lahaya, and a woman died of her wounds from previous shelling of al-Hawija town.

In the province of Deir ez-Zor, 3 persons were killed, 2 of them in a mine explosion in the town of al-Shu'fa, and a child who was shot by a stray bullets in the town of Abu Hamam.

In the province of Idlib, a person died of his wounds from a previous bombardment on the city of Kafranbel.

The Syrian Human Rights Committee documented the names of the following victims:

The total number of victims documented by the Syrian Human Rights Committee on Friday 12- 4 - 2019, reached 6 people of whom 3 children.

In Deir ez-Zor province, 4 people, 3 of whom including a girl were killed due to a landmine explosion in al-Bou Badran district and the village of al-Boukhater, and one person was found dead, killed by unknown persons in al-Shuhail area.

In the province of Aleppo, two children were killed in the neighbourhood of al-Hamdaniya, while playing with a shell from the remnants of a bomb.

The Syrian Human Rights Committee documented the names of the following victims:

1) Hamza Sa'id al-Sayer / Deir ez-Zor – Qouriya / Killed by unknown killers and his body was found near al-Shuhail.

Tal Hawash under the Russian fire

The total number of victims confirmed by the Syrian Human Rights Committee on Friday 26th April 2019, including two children, three women and one under torture.

In the province of Hama, 12 people were killed by the Russian shelling, 7 of them in the shelling of the town of Tel Hawash, and five in the shelling of the town of al-Amqiya.

In the province of al-Raqqa, 2 people were killed in an explosion near al-Sharakisah Mosque in al-Raqqa city.

In the province of Deir ez-Zor, one person died of wounds sustained by a landmine left behind by ISIS in al-Shu'fah town.

A person was killed in the province of Daraa by unknown persons, where his body was found near a checkpoint belonging to the regime forces on the way of al-Aradh.

A person from Homs province was also killed under torture in one of the regime's prisons.

Remains of 19 people were found in Daraya

The total number of victims confirmed by the Syrian Human Rights Committee on Saturday, 27th April 2019, reached 30 people of whom 2 children and 2 women.

In the province of Rif Dimashq, the remains of 19 people were found near a farm between Jdaidet Artooz and Daraya after they were lost in late 2012 and were executed by the regime forces on the field after their arrest.

In the province of Hama, 5 people were killed by Russian air strikes on the town of Qalaat al-Madiq.

In the province of Aleppo, 3 people were killed, including 2 by an explosion in the village of Kufr-Kamin, and one by an explosive device in the town of Toqad.

Two people were killed in Idlib province, one in the shelling of the town of Kafranbel, and the other was shot dead by unknown assailants in the town of al-Tmana'a.

One person was also killed when a landmine exploded in al-Bu-Bandran town in the province of Deir ez-Zor.

In Deir ez-Zor province, 3 people were killed, including a child who was killed by unidentified killers in the town of Swedan aljazeera, and one person was killed in a landmine explosion in the town of al-Sousseh, and one person was killed under torture by SDF Kurdish militia.

In the province of Hama, two people were killed by artillery shelling targeting a camp for displaced people near the village of Cher Maghar.

In al-Hasakeh province, a child died in al-Houl camp, which is under the control of SDF militia, due to lack of nutrition and poor health care.

Attack on Kansafrah

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Wednesday 8th May 2019 reached 20 people, including: 6 children , 2 women and 2 persons who were killed under torture.

In the province of Idlib (11) people were killed due to the bombing of the Syrian and Russian war planes on the cities and towns of the province. The victims are distributed as follows: 4 in the city of Khan Shykhun, 3 in the town of Hayish and 2 in the town of Shanan, and 1 each in the towns of Kansafra and al-Haraki.

In the province of Hama, 3 people were killed, including two by landmines in the agricultural land of Morek town, and one person was killed due to the bombing of the city of al-Latamna.

In the province of Aleppo, 3 people were killed by landmine explosions while grazing sheep north of the city of Manbaj.

Two people were killed under torture, one from Latakia province, he was killed under torture in the regime's prisons and the other from al-Raqqa province was killed under torture in the prisons of the

YPD militia. One person was also shot dead by unknown killers in the town of al-Jurzai in Deir ez-Zor province.
