1. Introduction

As of 31st July 2023, the Anti Homosexuality Act, 2023 had officially been in force for a total period of two months. As expected, this period has been particularly difficult for LGBTIQ persons in Uganda and has been fraught with challenges for civil society organisations working with LGBTIQ persons as well. Over the past two months, Human Rights Awareness and Promotion Forum has continued to monitor and document violence and violations of human rights on the basis of real or presumed sexual orientation and/ or gender identity and directly monitoring the impact of the AHA 2023 on the rights of LGBTIQ persons across the country. This report discusses cases involving actions that targeted real or suspected LGBTIQ persons for detrimental treatment on the basis of their real or presumed sexuality in the month of July, and draws comparisons with a similar period in 2022 as well as drawing conclusions about the entire period of the enforcement of the AHA 2023 over the past 2 months.

The report is a continuation from that produced for the period 1st June to 30th June 2023, and as such only details of cases handled in the month of July (1st – 31st July) will be included.

2. Methodology

The data for this report has been collected and verified in the same manner as the previous report. This report contains only information reported to HRAPF through our legal aid network of 132 community paralegals, the central legal aid clinic in Kampala and specialised legal aid desks and regional legal aid centres. The data was collected through a physical review of case files and monitoring registers to ascertain the number of cases handled, the nature and number of violations and incidents of violence reported and the number of persons affected. An in-depth review of documents on the case files was also undertaken for purposes of ascertaining the circumstances under which these cases took place, thus ensuring that only cases in which individuals were specifically targeted on the basis of their SOGIE are included in this report.

It is important to note that this report does not present a comprehensive view of the situation for LGBTIQ people across the country as it contains only the cases that were reported to HRAPF through our legal aid network, and excludes cases reported to other legal aid service providers/ handled through other channels and those not reported at all. The report focuses on cases, which are defined as a separate set of facts involving the violation of laws or rights which are included in one file. Each case can therefore contain more than one violation against more than one individual.

3. Nature and number of cases reported

In the period from 1st July 2023 to 31st July 2023, a total of 84 cases were handled across the legal aid network, with 53 of these containing actions that specifically targeted people for negative treatment on the basis of their sexual orientation or gender identity,

affecting a total of 67 persons. This represents 63.1% of all cases handled. Out of the 53 cases in which actions were taken targeting LGBTIQ persons on the basis of their sexuality, 26 were cases of evictions from homes, villages and rented properties affecting 33 persons; 21 were cases of actual or threatened violence affecting 24 persons; and 6 were cases of arrests affecting 10 persons.

2.1 Evictions from rented property

Between 1st July 2023 and 31st July 2023, HRAPF recorded a total of 26 cases in which evictions of 33 individuals were verified as having been caused by the real or presumed sexuality of the individuals in question. The main perpetrators were landlords, who evicted persons in 20 cases, of which two involved neighbors insisting on the evictions, followed by local council officials (2), then relatives (2), property manager in combination with Local Council I chairman (1) and the host under pressure from *boda boda* riders (1). The majority of the cases (22) happened in the Kampala/ Wakiso metropolitan area, and one case each in Kabarole, Kasese and Mbarara City in Western Uganda and one case in Iganga in Eastern Uganda.

2.2 Cases of violence

HRAPF recorded a total of 21 cases involving violence or threats to violence and affecting 24 persons. Of the 21 cases, 11 cases involved actual violence affecting 12 persons and 10 involved threats of violence affecting 12 persons. Most of these cases were not reported to the police for fear of arrest/ harm as soon as the victims' sexual orientation and/ or gender identity were revealed.

i) Cases of actual violence on the basis of Sexual orientation/gender identity

There were 11 cases of actual violence reported in July 2023. These were mainly cases of beatings/ assaults against LGBTIQ persons (9 cases) and 2 cases involving other forms of violence, that is, online violence and extortion, and affected a total of 12 persons. The perpetrators were mainly unknown persons (8 cases) and in the other four cases, the perpetrators were a neighbour, a fellow student, a partner and a father respectively. Beatings dominate the category of violence as there were 9 cases involving beatings, and the others were 1 case of cyber harassment and one case of extortion. Again, in almost all these cases, the victims did not want the cases reported to the police for fear of what would happen both from the side of the police and the perpetrators, most of whom were unknown. The majority of the violations happened in the Kampala/Wakiso metropolitan area (9) and one case each in Mbarara and Elegu.

ii) Cases involving threats of violence based on sexual orientation and/or gender identity

During the second month of the enforcement of the AHA, a total of 10 cases involving threats of violence against 12 persons were recorded. 4 of these threats were from neighbours, 2 from the police and local authorities, 2 by unknown people, 1 by boda boda riders, and 1 by guests at a party. Again, the majority of the cases (4) were reported from the Kampala/ Wakiso Metropolitan area, two from Busia and one each from Abim, Lugazi, Mbale and Tororo. The details of the threats based on sexual orientation and gender identity in July 2023 are produced below:

2.3 Cases of arrest

There were a total of 6 arrests of people on grounds related to their sexual orientation/gender identity in the month of July 2023, with 10 individuals being affected. The police authorities have continued to actively enforce the law and charge persons under the Anti-Homosexuality Act, 2023, with 3 cases involving charges under the Anti-Homosexuality Act, 2023 and affecting 4 persons. However, none of the cases reported in July were sent to court by the office of the Director of Public Prosecutions. A number of charges are being preferred under other laws, including one charge of indecent practices under the Penal Code Act, one of cyber harassment under the Computer Misuse Act, and one of domestic violence under the Domestic Violence Act, affecting 6 people. Again, most of the cases (4), occurred in the Kampala/ Wakiso Metropolitan area and one each in Busia and Dokolo.

3 Comparison with June 2023

The data presented above shows the continuing impact of the AHA 2023, which is being actively enforced by the law enforcers as well as the general public. July 2023 shows an increase in the number of cases from 46 in June to 53 in July – an increase of 6 cases or 15.2% There was also an increase in the number of victims from 50 in June to 67 in July, an increase of 17 victims (34%).

In July, the biggest number of cases are those of evictions which rose from 19 in June to 26 in July - an increase of 7 cases or 15.8%, and affected more people – 33 individuals in July as compared to 20 in June, a 65% increase. There was a slight reduction in the number of cases involving real or threatened violence, which reduced from 23 to 21, a decrease of 2 cases or 8.7%, although the cases in July affected more people than those in June, 24 compared to 23, an increase of 4.2%. The number of cases of arrests also increased from 4 to 6, an increase of 2 cases (33.33%) and affected more people, 10 compared to 7 in June, an increase of 3 persons (42.9%).

The trend of victims fearing to report cases to the police for fear of being arrested by the police and retaliation by the perpetrators also continues – an effect of the Anti-Homosexuality Act. The trends also suggest that violence and violations get worse every month that passes when the law is in force.

There is clearly active enforcement of the Act by the police and arrests and charges under the Act do continue even when the facts do not support the charges. In June 2023, HRAPF recorded a total of 4 cases involving arrests of 7 persons on sexuality-related charges, and in three of these cases, the charges were under the Anti-Homosexuality Act. Two of these cases under the Anti-Homosexuality Act were resolved at the police and one proceeded to court – the one involving homosexuality and trafficking in persons.

Perpetrators continue to be overwhelmingly non state actors, an intended effect of the reporting obligations imposed on private citizens under section 14 of the Anti-Homosexuality Act. It explains why the cases of evictions continue to rise and dominate. The law is essentially implemented by non-state actors, and the state does nothing to protect LGBTIQ persons.

In terms of locations, there are more cases reported from the Kampala/ Wakiso metropolitan area but nevertheless there are cases from all the regions of the country.

4 Comparison with the period from 1st July 2022 to 31st July 2022

The month of July 2023 has continued to be significantly different from comparable periods in previous years, clearly demonstrating the drastic change that the enactment of the AHA 2023 has had on the landscape for protection of the rights of LGBTIQ persons. For instance, in July 2022, there was a total of 28 LGBTIQ cases reported across the HRAPF legal aid network, and of these, only 6 (21.4%) targeted LGBTIQ persons specifically on the basis of their sexuality, affecting 6 persons. By contrast, a total of 84 cases have been recorded in July 2023, with 53 of those (63.1%) particularly targeting LGBTIQ people for negative treatment and affecting 67 persons. This represents a percentage increase of 783.3% in actions of deliberate homophobia within the same one-month period in 2022 as opposed to 2023, and the single most significant factor in this change is the enactment of the Anti-Homosexuality Act.

5 The first two months of the AHA 2023 in Uganda

As noted above, 31st July 2023 marked the 2-month anniversary of the enforcement of the AHA 2023. The two-month period has been predictably turbulent for LGBTIQ persons as shown by the statistics from cases reported at the clinic. In the first two months of the AHA 2023, a total of 149 cases have been handled across the legal aid network, of which 99 (66.4%) targeted LGBTIQ people on the basis of their sexuality, affecting a total of 117 persons. The breakdown of cases so far is as follows:

In comparison with the same two-month period in 2022, a total of 64 LGBTIQ cases were handled in that period, of which only 21 cases (32.8%) contained actions that deliberately targeted LGBTIQ persons for detrimental treatment. This translates to an increase of 78 cases or a percentage increase of 371.4%.

6. Conclusion

The continuing impact of the AHA on the rights, lives and livelihoods of LGBTIQ people is clear and undeniable. The statistical data available so far clearly highlights the shifting trends, attributable to the public discourse on homosexuality at present and the AHA specifically, and available qualitative data suggests that the majority of the targeted violence and violations against LGBTIQ people is motivated in large part by the AHA 2023: the fear of it, or the enforcement of it.
