

## Midterm report of the Group of Experts on the Democratic Republic of the Congo

## Summary

During the period under review, a new Government was appointed in the Democratic Republic of the Congo. The Group of Experts on the Democratic Republic of the Congo (the Group) has begun to establish working relations with the new authorities at the local, provincial and national levels.

The Group notes that, since the outset of its mandate, there have been increased armed clashes between the armed groups Nduma défense du Congo-Rénové (NDC-R) and the Collectif des mouvements pour le changement (CMC) in Masisi and Rutshuru territories, North Kivu Province. NDC-R continued to recruit and expand while its leader, sanctioned individual Guidon Shimiray Mwissa (permanent reference number CDi.033 on the sanctions list of the Security Council Committee established pursuant to resolution 1533 (2004) concerning the Democratic Republic of the Congo), remained at large and subject to a Congolese arrest warrant. NDC-R continued to receive arms and ammunition from some members of the armed forces, the Forces armées de la République démocratique du Congo (FARDC).

The Allied Democratic Forces (ADF) remained a serious threat to peace and stability in Beni and Irumu territories and continued to attack civilians and FARDC positions. ADF came under pressure following the launch, on 30 October 2019, of FARDC operations against its stronghold. Although Islamic State in Iraq and the Levant (ISIL, also known as Da'esh) had publicly claimed responsibility for several attacks carried out in Beni territory, the Group was unable to confirm any direct link between ISIL and ADF at the time of writing the present report.

In Minembwe, South Kivu Province, a Mai-Mai armed group coalition led by Mai-Mai Yakutumba affiliated with Babembe, Bafuliru, Bavira and Banyindu communities clashed with Ngomino and Twigwaneho armed groups affiliated with the Banyamulenge community. The Group continued to document the activities of the armed group Résistance pour un État de droit (RED)-Tabara in the Democratic Republic of the Congo.

The Group found that, since 10 June 2019, multiple attacks had predominantly targeted the Hema population of Djugu territory, Ituri Province. The Group established that Lendu militias had carried out these attacks, although it remained obscure how many militias there were and how they were structured and organized. Some members of the Congolese security forces who have been deployed in Djugu territory to protect the population from these attacks also committed exactions against the population.

On natural resources, preliminary findings indicated that armed groups including NDC-R, Mai-Mai Yakutumba and Nyatura factions, criminal networks and some members of the Congolese security forces were involved in the illicit production of and trade in minerals, in some cases facilitated by financial networks. The Group further notes that new gold refineries have been established within States members of the International Conference on the Great Lakes Region and that one was planned in the Democratic Republic of the Congo.

The Group observed potential violations of the arms embargo and non-compliance on the part of supplier States with the requirement to notify to the Security Council Committee established pursuant to resolution 1533 (2004) in advance of the delivery of arms, related military equipment and provision of training.

## I. Introduction

- 1. The members of the Group of Experts on the Democratic Republic of the Congo (the Group), whose mandate was extended to 1 August 2020 by Security Council resolution 2478 (2019) of 26 June 2019, were appointed by the Secretary-General on 29 July 2019 (see S/2019/607). The Group began its mandate with a visit to New York from 25 to 30 August 2019 and conducted field investigations in the Democratic Republic of the Congo in September and October 2019.
- 2. In accordance with the request made by the Security Council in paragraph 8 of its resolution 2360 (2017), and as reaffirmed in resolution 2478 (2019), the Group continued to exchange information with the panels of experts on the Central African Republic, the Democratic People's Republic of Korea, Somalia and South Sudan.

## Cooperation with the United Nations Organization Stabilization Mission in the Democratic Republic of the Congo

3. The Group expresses its appreciation for the valuable support and collaboration received from the United Nations Organization Stabilization Mission in the Democratic Republic of the Congo (MONUSCO) during the period under review.

## Compliance with the Group's requests for information

4. Following its appointment, the Group addressed 63 official communications to Member States, international organizations and private entities. At the time of concluding the present report, the Group had received only 21 responses. The Group notes that several scheduled visits to Member States located in the region could not take place. The Group underlines that the lack of timely cooperation from Member States undermines its ability to fulfil its mandate. The Group acknowledges receipt, on 15 October 2019, of the requested copy of the report of an investigation conducted by police in Uganda on gold smuggling (see S/2019/469, para. 184).

### Methodology

- 5. The Group used the evidentiary standards recommended by the Informal Working Group of the Security Council on General Issues of Sanctions (see S/2006/997). The Group based its findings on documents and, wherever possible, on first-hand, on-site observations by the experts themselves. Wherever that was not possible, the Group corroborated information by using at least three independent and reliable sources.
- 6. Given the nature of the conflict in the Democratic Republic of the Congo, there are few documents that provide definitive proof of arms transfers, recruitment, command responsibility for grave human rights abuses and the illegal exploitation of natural resources. The Group has therefore relied on eyewitness testimony given by members of local communities, former combatants and current members of armed groups. The Group has also considered expert testimony given by government officials and military officers of countries in the Great Lakes region and other countries, as well as by United Nations sources.
- 7. The present report covers investigations conducted up to and including 13 November 2019. Investigations relevant to the Group's mandate that occurred after that date will be reflected in the final report.

### Update on sanctioned individuals

8. In the early hours of 18 September 2019, sanctioned individual "general" Sylvestre Mudacumura (permanent reference number CDi.012 on the sanctions list of

the Security Council Committee established pursuant to resolution 1533 (2004) concerning the Democratic Republic of the Congo), also known as Mupenzi Bernard or Pharaon de Poeto, commander of the Forces combattantes abacunguzi (FOCA), and Sixbert Ndajambaje, also known as Soso, chief of staff of the president of FDLR, were killed during a military operation claimed by Congolese armed forces, the Forces armées de la République démocratique du Congo (FARDC). The operation was conducted while the FDLR steering committee was holding a meeting.

## Correction of the 2017 final report of the Group

- 9. In paragraph 108 of its final report of August 2017 (S/2017/672/Rev.1, para. 108), the Group reported as follows: "In October 2016, customs agents in Dubai found 150 kg of undeclared gold in [Ms. Elysée Kanini Chibalonza's] luggage". The weight of the exported gold had been recorded as 150 kilograms in an official customs document in Arabic dated 14 September 2015 provided by the United Arab Emirates to the Group on 7 April 2016 (S/2017/672/Rev.1, annex 42).
- 10. However, based on a second document, an unofficial English translation provided to the Group by the United Arab Emirates after the final report had been published, the Group notes that the correct weight of the gold was 150 grams and the date of the seizure by customs agents in Dubai was 14 September 2015.

## II. Armed groups

## A. Nduma défense du Congo-Rénové

11. The Group has found that the armed group Nduma défense du Congo-Rénové (NDC-R) has remained active in North Kivu and has continued to recruit and expand. NDC-R engaged in fighting with the Collectif des mouvements pour le changement (CMC) comprised of Nyatura factions, the Alliance des patriotes pour un Congo libre et souverain (APCLS) and FDLR-FOCA in Masisi and Rutshuru territories.

#### Leadership

- 12. Sanctioned individual Guidon Shimiray Mwissa (CDi.033) remained the leader of NDC-R (see S/2019/469, para. 53). On 7 June 2019, the Office of the Military Prosecutor of North Kivu issued a warrant for Guidon's arrest (see annex 2). However, the Group notes that the Congolese authorities have not acted on it. During 2019, NDC-R maintained its headquarters in Pinga, Walikale Territory, North Kivu Province, and coexisted alongside FARDC (see S/2019/469, paras. 58–62). The Group documented instances of weapons and ammunition being transferred from certain FARDC officers to NDC-R (see paras. 66–73 of the present report). However, high-ranking NDC-R political leaders in Kalembe, Masisi Territory, North Kivu Province, confirmed that Guidon had not attended FARDC security meetings since the issuance of the warrant.
- 13. NDC-R sources informed the Group that Guidon had appointed Désiré Ngabo Kisuba as spokesperson to replace Charité Bisapo (see S/2018/531, annex, para. 73, and annex 3 to the present report), the former head of external affairs, who had been based in Pinga.
- 14. On 7 September 2019, NDC-R appointed "colonel" Jean Lomingo Kamala as commander of a new unit named the 114th brigade. According to one NDC-R

combatant, the brigade comprised some 250 new combatants deployed in the Kalembe area and was comprised of two battalions. As of 30 October 2019, the brigade was fighting with the coalition of CMC, APCLS and FDLR.

## Recruitment and training

- 15. The Group found that, based on a video it obtained and that has been corroborated by interviews with three NDC-R sources from Kalembe and several civil society representatives, on 7 September 2019, Guidon presided over a graduation ceremony in Pinga for 250 new combatants.
- 16. The recruits in question were trained near Pinga from early July to September 2019. Three NDC-R sources informed the Group that the new recruits were mostly defectors from Nyatura factions<sup>2</sup> and speakers of Kinyarwanda who were familiar with the local terrain and able to interact with local communities. Some Nyanga and Hunde community leaders from Pinga also contributed to their recruitment by conducting a youth-oriented campaign aimed at encouraging potential recruits to defend the lands of their community. Moreover, two former NDC-R officers have stated that civilians had decided to join the movement in order to exempt their families from taxation.
- 17. One source familiar with NDC-R told the Group that NDC-R trainers included FARDC defectors and ex-combatants who had transited from various disarmament, demobilisation and reintegration camps to FARDC training centres at Kamina in Haut-Lomami Province and Kitona in Kongo Central Province. The trainers provided recruits with basic military training and information on international humanitarian law.

#### **Taxation**

18. NDC-R continued to levy taxes on the population as a means of raising funds (see S/2019/469, para. 148). Villagers were being forced to pay the movement 1,000 Congolese francs monthly per adult. In Kitchanga and Kalembe, the Group witnessed people carrying so-called tokens (*jetons*) issued as proof that they had paid the tax (see S/2019/469, para. 190, and annex 4 to the present report). The Group was also informed that truck drivers were being taxed 30,000 Congolese francs to 40,000 Congolese francs at NDC-R checkpoints. Other taxes applied to timber and charcoal dealers. Charcoal dealers were being taxed three bags of charcoal or \$20 per truckload. Failure to pay resulted in punishments including fines, arrest and beatings. In addition, forced labour (*salongo*) continued to be imposed on the population as their contribution to the movement (see S/2018/531, para. 87).

## **Expansion into Rutshuru and Masisi territories**

19. NDC-R maintained its control over the territories of Masisi, Rutshuru and Lubero (see S/2019/469, para. 53). The Group obtained information from a source close to CMC/Forces de défense du peuple (CMC/FDP), confirmed by civil society actors and one NDC-R member, that since 30 October 2019, NDC-R had taken control of several villages in Rutshuru territory following continuous attacks against CMC/FDP. The villages included Katsiru, Kiyeye, Kitunda, Maziza, JTN, Kayangare and Mbuhi at the time of writing. The Group confirmed that on 7 November 2019, NDC-R defeated CMC/FDP combatants and had regained control over Mweso, a major economic crossroads in Masisi Territory.

## **B.** Allied Democratic Forces

20. The Group found that the Allied Democratic Forces (ADF) remained a threat to peace and security in Beni Territory, North Kivu Province, and to the south of Ituri Province. Although Islamic State in Iraq and the Levant (ISIL, also known as Da'esh) publicly claimed that some attacks in the Democratic Republic of the Congo that had been attributed to ADF had actually been carried out by ISIL, the Group was not able to confirm any direct link between ISIL and ADF at the time of writing the present report. The Group spoke with a number of ex-combatants recently captured by FARDC as well as with MONUSCO, national police and civil society sources.

## Leadership and locations

- 21. The Group notes that no major changes have occurred in the ADF leadership since its final report of June 2019 (see S/2019/469, paras. 21–26). Two ADF ex-combatants and two military intelligence sources confirmed that Seka Musa Baluku remained the overall leader of the movement, while Lukwago Rashid Swaibu Hood, also known as "Mzee Meya Pierro" or "Pierro", remained in place as the military commander (see also S/2019/469, para. 26, and annex 5 to the present report).
- 22. ADF positions remained largely stable (see also \$\sigma'2019/469\$, paras. 16–19). Several ADF ex-combatants and FARDC confirmed to the Group that, since the September 2019 announcement of FARDC military operations, ADF leaders had begun to move materiel and combatants from some camps, including Mayangose and Kididiwe, to Kajaju, Whisper and Bango in the Madina complex (see \$\sigma'2019/469\$, para. 17). They informed the Group that some combatants had moved towards Mamove, west of Oicha, while children and the elderly had been transferred northwards from Mwalika camp. Around 20 combatants were left in the smaller camps with a few AK-pattern assault rifles.

## Incursions into Boga and Chabi

23. The Group was informed that at least two ADF incursions into Ituri Province occurred. In August 2019, ADF combatants crossed into the south of Irumu Territory and attacked villages in Boga following a May 2019 incursion into Chabi. Three former ADF combatants who took part in the August raid confirmed that ADF was seeking food and medical supplies. They added that ADF had taken approximately 100 hostages and forced them to carry looted goods. Some were detained at the Mwalika camp, while others were released after paying ransom. ADF ex-combatants as well as MONUSCO and FARDC sources told the Group that while there were no ADF camps in South Irumu, some ADF members might have transferred dependants to the area.

## Recruitment and training

24. ADF ex-combatants, civil society actors, FARDC and national police sources told the Group that since July 2019, the ADF recruiting network had faced difficulties. ADF ex-combatants recalled that in the last three months, no more than 15 new recruits arrived, whereas in the past, the network had been able to deliver close to 100 to 200 new combatants in the same amount of time. Two FARDC officers and one ex-combatant who spent 10 years with ADF and escaped the movement in July 2019 told the Group that ADF recruiters targeted relatives in Uganda. According to the same sources, ADF leaders had travelled to Uganda in June 2019 to set up new recruitment networks. Many sources indicated that the recruitment of foreigners had continued, albeit in small numbers. The Group notes that ADF continued to use false job promises to lure new recruits into its ranks. ADF also continued to use threats and

intimidation to dissuade recruits from leaving the camps. New recruits were systematically subjected to Qur'anic teaching (see S/2019/469, para. 37).

## Possible links between the Allied Democratic Forces and Islamic State in Iraq and the Levant

25. At the time of writing the present report, the Group had not found any direct links between ADF and ISIL, as claimed by ISIL, such as would be indicated by the use of similar tactics, techniques and weaponry. The modus operandi of the attacks attributed to ADF did not change. Claims made by ISIL did not consistently correspond with attacks on the ground, although a flag similar to the ISIL flag was displayed during ADF training, meetings or combatant parades.

## Operations of the Congolese armed forces

26. On 30 October 2019, the Government launched operations against armed groups in North Kivu Province. According to officers, since the beginning of operations, FARDC had gained control of ADF camps including Mayangose, Kididiwe, Vemba, Kadohu, Point 46, Masulukwede, part of Mwalika, Mabeto and Karuhamba, and at least 25 ADF combatants were killed. The Group will continue to monitor the situation.

## C. Résistance pour un État de droit-Tabara

- 27. Since mid-July 2019, Résistance pour un État de droit (RED)-Tabara combatants have moved progressively from the Democratic Republic of the Congo into Burundi. On 20 and 22 October 2019, armed elements carried out two armed attacks on Musigati, Bubanza Province, Burundi.
- 28. A civil society actor in Burundi and three officers of the armed forces of Burundi (Forces de défense nationale FDN) told the Group that the assailants had targeted military and police positions in Musigati. The Group wrote to the Government of Burundi and looks forward to its response.
- 29. The Group interviewed local civil society organisations, residents and local workers of non-governmental organizations in South Kivu Province and confirmed that RED-Tabara was still active in the Moyens Plateaux of Uvira, South Kivu (see S/2019/469, para. 84). Sources informed the Group that, in October 2019, RED-Tabara combatants were seen along the border between the Democratic Republic of the Congo and Burundi.

## D. Crisis in Minembwe

- 30. Since September 2019, civilians in Minembwe, Uvira Territory, experienced an upsurge in violence between communities backed by armed groups. A Mai-Mai armed group coalition led by Mai-Mai Yakutumba supported the Babembe, Bafuliru, Bavira and Banyindu communities in clashes against the Banyamulenge community, which was supported by Ngomino and Twigwaneho armed groups.
- 31. The Group visited Minembwe and spoke with one Twigwaneho combatant, six Banyamulenge leaders and one Ngomino combatant, as well as with six members of the Babembe, Banyindu and Bafiliru communities.
- 32. The Banyamulenge members reported that since February 2019, the Mai-Mai coalition had targeted their community in the Moyens Plateaux of Uvira and carried

out various attacks during which people were killed, cows were looted and housed were burned down.

33. Members of the Bafuliru, Babembe and Banyindu communities reported that since May 2019, their leaders had been killed by Banyamulenge-affiliated armed groups. There was mass displacement of civilians and destruction of property in the villages around Minembwe. The Group notes with concern the deterioration of the security and humanitarian situation and will monitor further developments.

## III. Natural resources and finances

- 34. The Group conducted preliminary investigations into the illegal exploitation and smuggling of tin, tantalum, tungsten, gold and timber (see para. 18) involving armed groups, criminal networks, government officials, and local and foreign individuals and entities. These activities, some of which were supported by international supply chains and financing, contributed to instability and conflict in the Democratic Republic of the Congo and the region.
- 35. NDC-R, Mai-Mai Yakutumba, Mai-Mai Malaika and Nyatura factions used revenue generated from the production, illegal taxation and the sale of natural resources, including through regional trade, for their survival and, in some cases, for the purchase of arms and ammunition including from members of FARDC, as previously reported by the Group (see S/2019/469, para. 60).

## A. Gold

### Nduma défense du Congo-Rénové

- 36. NDC-R taxed artisanal miners in areas under its control and used the proceeds of gold sales to finance its fighters, carry out attacks and purchase weapons and ammunition, in some cases from FARDC members, according to seven sources including senior NDC-R ex-combatants, and consistent with the Group's previous findings (see S/2019/469, paras. 187 and 188, and paras. 66–73 of the present report). Gold mines in areas under NDC-R control included Kasugho in Lubero Territory (see also S/2018/531, paras. 92–93). Coltan mines included Mahanga in Masisi Territory.
- 37. The Group notes that NDC-R received significant revenue from gold taxation. A former senior NDC-R officer, whose account has been corroborated by two other former NDC-R members, described how gold diggers were being taxed 1,000 Congolese francs to access mine sites and issued tokens (*jetons*) as proof of payment. This system generated more than 30 million Congolese francs (\$18,000) monthly (see S/2019/469, para. 190 and annex 55). NDC-R levied a tax of 10 per cent on large gold finds, which miners paid directly to Guidon. NDC-R also imposed a tax known as "savon militaire" ("military soap") on mine site representatives, a contribution to the movement amounting to between 55 g and 60 g of gold monthly. During 2019, between 35 and 40 dredging machines operated by private individuals along the river Ulindi were taxed 10 g to 15 g of gold monthly, according to independent testimony given by three senior NDC-R ex-combatants.
- 38. A senior NDC-R combatant with first-hand knowledge of the matter and three NDC-R members recounted that gold sales brokered by close relatives of Guidon, who sold to gold buying houses in Goma, also generated cash for the movement. Sales were cash-based and were not usually documented. The Group is aware of two occasions on which senior NDC-R ex-combatants sold gold to buyers in Uganda and one on which they did so in Burundi.

#### Mai-Mai Yakutumba

- 39. Nine independent sources confirmed that Mai-Mai Yakutumba derived financial benefits from gold, which is consistent with the Group's previous findings (see S/2018/531, para. 63). Between April and May 2019, Mai-Mai Yakutumba occupied gold mines around Misisi town in South Kivu Province for several weeks. Three Mai-Mai Yakutumba coalition ex-combatants have stated that the movement was taxing gold miners around Misisi, two of whom independently confirmed that the gold was being used to purchase arms.
- 40. While mining authorities interviewed by the Group in South Kivu expressed the view that Mai-Mai groups had not controlled gold mining sites around Misisi during 2019, the Group established, on the basis of six eyewitness accounts obtained in Misisi and Uvira, that between April and May 2019, Mai-Mai Yakutumba combatants had occupied at least four gold mining sites around Kachanga hill, near Misisi town.
- 41. In the same period, the armed group occupied one mine for 12 hours and occupied a second for more than two weeks. At both mines, armed men received the gold produced. A digger worked for "hours" for the armed men, handing over his production on three occasions before fleeing. Several armed individuals taxed mine sites from a distance and demanded a share of gold equivalent to "hours" worked, or a part of a mine's production. This practice rendered their involvement more difficult to detect because those responsible were not always physically present at the mines.
- 42. Gold ore produced at the occupied mines was brought to Misisi centre for crushing and processing, and was sold to established *négociants* operating in the town, according to three miners and two businessmen in Misisi. The Group continues to investigate downstream recipients of this gold.<sup>3</sup>

#### Mai-Mai Malaika, led by Sheikh Hassani

43. The Group notes that in Maniema province, combatants of the Mai-Mai Malaika faction, led by Sheikh Hassani, had claimed a part of an industrial gold mining concession at Namoya Mining SA, belonging to Banro Corporation Ltd., to allow artisanal mining based on an agreement that is now being contested, according to documents seen by the Group. Prior to the agreement, in July 2019, Mai-Mai Malaika combatants took four Banro staff members hostage. This and a series of other events led Banro Corporation Ltd. To suspend its operations at four of its entities in the Democratic Republic of the Congo, including Namoya Mining SA, on 24 September 2019 (see annex 6).

## B. Tin, tantalum and tungsten

44. In Masisi Territory, two validated mine sites, Kibanda (coltan) and Rubonga (coltan and cassiterite), remained under the control of disputing Nyatura factions and NDC-R combatants. Kibanda and Rubonga had last been validated by the Ministry of Mines in February 2016 and have held "green" status since that time, despite the presence of armed elements, according to an official list of mines validated between 2012 and 2019 (see annex 7 to the present report; see also S/2018/1133, para. 51). A failure to renew the validation of mines every six months, as required by Congolese law, undermines the reliability of validation information as do long delays between qualification missions and issuance of governmental validation decrees (see annex 8).

- 45. In September 2019, the Group visited two clandestine depots in the Mabanga and Katindo suburbs of Goma. Two smugglers who had temporarily stored untagged coltan and wolframite there, told the Group that they sold the minerals in Goma or across the border in Gisenyi (Rubavu), Rwanda. Three officials of the Business Federation of the Congo (Fédération des entreprises du Congo FEC) and two officials of the National Commission on Mining Fraud (Commission nationale de lutte contre la fraude minière CNLFM) independently informed the Group that increased royalty taxes included in the 2018 revised Congolese Mining Code may have promoted coltan smuggling. FEC wrote to the Minister for Mines requesting a moratorium on the new royalty tax (see annex 9).
- 46. Two officials of CNLFM, two officers of the mining police (Polimine) and a member of the judiciary informed the Group that smuggling across the border into Rwanda had continued. The Group also independently interviewed two smugglers, who confirmed this information. In Katindo, a smuggler dealing in wolframite showed the Group untagged wolframite stored in bags in varying quantities together with potatoes, and loose wolframite pellets laid out on the ground (see annex 10). The smuggler informed the Group that every week, he obtained wolframite from mines in Masisi territory in bags weighing between 20 kg and 40 kg. The Group notes that mineral trafficking routes from the Democratic Republic of the Congo to Rwanda remained in place as previously documented (see S/2019/469, paras. 152–156). The Group continues its investigations to establish the identities of other actors in these supply chains.
- 47. On 12 September 2019, an agreement covering mining and trading activities between the Société minière de Bisunzu (SBM) and the Coopérative des exploitants artisanaux miniers de Masisi (COOPERAMMA) expired. After that, the two parties engaged in negotiations about new trading arrangements (see annex 11). The Group is aware of continued mineral smuggling that undermine the integrity of some coltan supply chains linked to minerals from the Masisi area, as previously reported (see S/2019/469, paras. 153–160; and S/2018/1133, paras. 53–55). The Group continues to investigate.

## C. Illegal involvement of some members of the Congolese armed forces

48. The Group acknowledges the efforts made by the Congolese judiciary to prosecute cases involving mineral fraud. However, members of FARDC, including high-ranking officers, benefited directly or indirectly from mineral trading in contravention of Congolese law (see annex 12). Fifteen eyewitnesses, including mining officials, diggers, traders and representatives of civil society, confirmed this trend. The Group is investigating and will document the frequency and scale of such cases. Annex 13 provides four examples.

## D. Regional developments

49. The Group is aware of new mineral processing, refining and service provision entities in the area covered by the International Conference on the Great Lakes Region (ICGLR) and notes that those commercial operations that are conducted in adherence to supply chain due diligence laws could add value to and increase the transparency

of regional mineral trading.<sup>5</sup> The Group notes that traders and service providers, including those offering brokerage services, have a responsibility to conduct supply chain checks.

- 50. In July 2019, the Governor of Ituri Province announced plans for a new gold refinery. In Rwanda, Aldango Entity Ltd., a new gold refinery located in the Kigali Special Economic Zone, officially began exporting in March 2019 (see also S/2019/469, para. 184), and a new tin refinery in Rwanda, LuNa Smelter, started producing in the same period.
- 51. In Uganda, the Group notes the presence of four gold refining and service provision entities. These are African Gold Refinery, Bullion Refinery Ltd. and Simba Refinery Ltd. (see S/2018/1133, paras. 97–98) and Metal Testing and Smelting Company Co Ltd. The Group contacted the entities asking for a list of their suppliers and for evidence that they had completed supply chain due diligence checks, including on second-tier suppliers (i.e., their suppliers' suppliers) in order to verify whether the companies were involved directly or indirectly in any sanctionable acts in the Democratic Republic of the Congo.
- 52. The Group is aware of efforts by some government authorities in Uganda to improve the transparency of gold refiners and service providers. In a letter dated 24 September 2019 obtained by the Group from multiple sources and addressed to the four companies mentioned above (see annex 14), the Uganda Revenue Authority laid down new reporting requirements, including those regarding supply chain activities and ultimate beneficial ownership information, to be reported to the Commissioner of Customs.
- 53. Six traders and multiple officials in Ituri, North Kivu and South Kivu provinces confirmed to the Group that cross-border mineral smuggling, including the smuggling of gold, had continued along established trading routes (see para. 46 of the present report; see also S/2019/469, paras. 178–181). The Group reiterates that regional gold export statistics do not reflect trading on the ground, given the volumes of minerals being smuggled through neighbouring countries (see S/2019/469, para. 183). The Group has not yet received the information from authorities in Uganda about gold production figures for that country, officially requested since May 2019. Trade statistics made public by the URA show that Uganda exported over \$515 million in gold in 2018.8 The Group notes that disaggregated export data for coltan, cassiterite and wolframite are published by the National Bank of Rwanda, while gold export figures are not published.9
- 54. The Group notes that the ICGLR database is now in use at the provincial mining offices that the Group visited in South Kivu and Ituri provinces. The Group has copies

- of the 15 ICGLR certificates for legal gold exports to international buyers between 2018 and October 2019 from these provinces.
- 55. At the same time, cross-border smuggling and attempts to use forged ICGLR certificates continued to undermine the integrity of Congolese and regional supply chains (see S/2017/1091, paras. 50–56). On 20 May 2019, authorities in the Democratic Republic of the Congo arrested an intermediary in a gold smuggling deal that was accompanied by a forged ICGLR certificate for the export of 18 kg of gold from an unknown mine site in South Kivu Province to CHI Precious Metal Trading in the United Arab Emirates (see annex 15). <sup>10</sup>
- 56. The forged certificate carried the name Andreas Wildt, CEO of CHI Precious Metal Trading. The intermediary in the sale informed the Group that he had met Wildt in Gisenyi, Rwanda, in early March 2019 to plan the sale. Mining authorities in the Democratic Republic of the Congo confirmed that the ICGLR certificate was indeed fraudulent. The Group wrote to Wildt and CHI Precious Metal Trading and has yet to receive a response. The Group reiterates that proper use of ICGLR certificates and company supply chain due diligence reporting <sup>11</sup> is critical to effective regional traceability efforts.
- 57. The Group has contacted relevant Member States in writing to request information regarding the use of ICGLR certificates at import. Gold importers interviewed by the Group had little awareness of the certificates. On 1 October 2019, Burundi launched its ICGLR certification process for natural resources, in accordance with the 2010 Lusaka Declaration of the ICGLR Special Summit to Fight Illegal Exploitation of Natural Resources in the Great Lakes Region (see annex 16).
- 58. The memorandum of understanding to prevent and detect the smuggling of gold between the United Arab Emirates and the Democratic Republic of the Congo appeared stalled at the time of writing the present report (see S/2019/469, para. 186).

## IV. Arms

- 59. During the first part of its mandate, the Group investigated the delivery of materiel and training to the Congolese security forces by Member States that appear not to have notified the Committee. The Group also continued its efforts to trace materiel that had been trafficked illicitly to armed groups.
- 60. The Group notes that some of the notifications addressed to the Committee did not contain sufficient details such as the batch and year of production of the

ammunition and the model of the weapons – to allow the Group to effectively monitor the implementation of the arms embargo. 12

## A. Failure to notify

### Transfers of materiel and provision of training to Congolese security forces

- 61. The Group is evaluating the compliance of Member States with the requirement to notify the Committee prior to the shipment of military equipment to the Democratic Republic of the Congo and the provision of military training. The Group observed new materiel in the hands of the Congolese security forces that appears not to have been notified to the Committee. The Group notes that, between 2016 and 2018, the Congolese security forces had already been supplied with new materiel (see S/2019/469, paras. 205–208; S/2018/1133, paras. 105–110; S/2018/531, para. 193; S/2016/466, paras. 230–231; S/2015/19, para. 153).
- 62. The Group was further informed by multiple sources that several Member States have provided training to FARDC. The Group is investigating whether this training was notified in advance of its having been provided.
- 63. The Group wrote several official letters to the authorities of countries producing and/or exporting documented materiel and/or that have provided training and is awaiting replies.

## Foreign registered civilian aircraft providing support to Congolese security forces

- 64. The Group was informed that on two occasions, on 16 and 19 June 2019, an Ilyushin 76 cargo aircraft with registration number YI-BAT (Iraq) caught fire at Goma airfield (see annex 17). The Group is aware that this aircraft was used to transport military personnel and material of the Democratic Republic of the Congo.
- 65. The Group gathered evidence that cargo aircraft belonging to foreign civilian airlines have supported the Congolese security forces by transporting military and police personnel, as well as materiel, since at least January 2013. The Group has sent letters to the cargo companies concerned.

## B. Violations of the arms embargo

#### Diversion of materiel to Nduma défense du Congo-Rénové

- 66. The Group found that transfer of materiel from FARDC members to NDC-R has continued, which is consistent with previous reports (see S/2019/469, para. 60; S/2018/531, para. 78).
- 67. The Group has obtained three videos that were recorded between June and July 2019 and late in December 2018 that the Group and a source familiar with NDC-R

have authenticated. The Group also interviewed 14 present or recently demobilized NDC-R combatants.<sup>13</sup>

- 68. In the first video, a policeman stationed in Masisi centre asserted that in May 2019, NDC-R combatants spent a day at an FARDC position near the village of Mukohwa, and that on 10 May 2019, FARDC members handed over five boxes of ammunition<sup>14</sup> to NDC-R elements based in Loashi.
- 69. The policeman also stated that FARDC members and NDC-R combatants jointly operated in pursuit of APCLS combatants in Buabo. The Group believes that this joint operation related to combat that occurred in the second half of May 2019 between NDC-R and APCLS in the Biiri, Bapfuna, Buabo and Banyungu groupements.
- 70. In a second video, an NDC-R officer explained the prior purchase of military uniforms from FARDC and the future integration of his group's combatants into FARDC (see annex 18).
- 71. A third video dated 25 December 2018<sup>15</sup> displayed a group of approximately 100 individuals consisting of civilians, some of whom were women, and NDC-R combatants, carrying, among other things, ammunition and weapons prior to the decisive attack on the headquarters of the Conseil national pour le renouveau et la démocratie (CNRD), stationed in Faringa<sup>16</sup> (see S/2019/469, para. 45).
- 72. The Group confirmed that those named in the video were part of the command and control structure of NDC-R:
  - Deputy T1 (administration and finances): "lieutenant-colonel" Eric Kitwana,
  - Deputy T3 (operations): Aradjabu Alfani, also known as Alpha,
  - Chief T1 headquarters sector: Ragi Hakizumwami,
  - Chief T4 headquarters sector (logistics): "colonel" Engulu Mwanabu Georges.
- 73. The Group observed that at least two 82 mm mortars and one 12.7 mm heavy machine gun were among the materiel delivered to NDC-R in Kashuga (see annexes 19 and 20). The Group is of the opinion that, in addition to being a clear violation of the arms embargo, the transfer of heavy weapons from FARDC to an armed group, in the guise of NDC-R, is particularly concerning, especially given the risk associated with the use of such weapons in an area densely populated with civilians.

## Members of the armed forces of Burundi operating in South Kivu Province

74. The presence in the first quarter of 2019 of FDN members in the Democratic Republic of the Congo is referenced in an FARDC document dated April 2019 that was obtained by the Group (see annex 21). A second FARDC document from the same period refers to an operation directed by the intelligence services of Burundi to collect weapons purchased in the Democratic Republic of the Congo by an individual from Uvira linked to those services. The Group reported previously that FDN members had operated in South Kivu Province see S/2019/469, paras. 66–79; S/2017/672/Rev.1, paras. 148–150; S/2015/19, paras. 83–87).

he According to two former NDC-R officers interviewed by the Group, two unsuccessful attacks had been carried out in the days before. This had justified the support in weapons and ammunition needed to lead a decisive effort against the CNRD headquarters. CNRD fighters also told the Group that the attack had involved unprecedented firepower.

#### Transfer or diversion of materiel to unidentified armed assailants

75. The Group received materiel that had been recovered following the attack carried out against MONUSCO peacekeepers near Dhedja/Kasseli in Djugu Territory, Ituri Province, on 28 July 2019 by unidentified attackers (see para. 83). The materiel consists of a component of a PG7-V rocket and empty 7.62 x 39 mm cartridges. The PG7-V is similar to rockets produced in the Islamic Republic of Iran and its markings indicate that it was produced in 2018 (see annex 22).

## V. Serious violations of human rights and/or international humanitarian law in Djugu Territory

76. The Group has found that, since 10 June 2019, multiple attacks targeted predominantly the Hema population of Djugu Territory, Ituri Province. The Group established that Lendu militias were responsible for many of the attacks, although it remained obscure how many militias there were and how they were structured and organised. The killing, maiming, forced displacement, rape, abduction, destruction and looting committed during these attacks constitute sanctionable acts under paragraph 7 (e) of Security Council resolution 2293 (2016), as renewed by paragraph 2 of Council resolution 2478 (2019). In parallel, some members of the security forces of the Democratic Republic of the Congo deployed in Djugu Territory committed sanctionable acts that included rape, ill-treatment and destruction

77. These findings are based on individual interviews the Group conducted during the reporting period with 90 persons, including 51 internally displaced persons from several communities, local authorities, prisoners, medical staff, representatives of civil society, representatives of humanitarian agencies and non-governmental organizations, FARDC officers, peacekeepers and staff of MONUSCO, as well as in telephone conversations and messages exchanged with alleged representatives of a Lendu militia, photographs, audio and video recordings, documentary evidence and direct observations by the Group.

## A. Attacks by Lendu militias

#### Patterns of the attacks

78. The mass attacks mainly targeting the Hema population, which started on 10 June 2019, constituted the second wave of violence that occurred in Djugu Territory (see annex 23)<sup>17</sup> since the conflict between the Hema and Lendu communities that occurred from 1999 to 2003 (see S/2018/531, paras. 158–164; and annex 24 to the present report).

79. At least 197 Hema and Alur civilians were killed between 1 June and 20 September 2019, according to the Office of the United Nations High Commissioner for Human Rights. Women, men and children, regardless of age, were indiscriminately targeted and brutally killed with bladed weapons and/or by gunshot. The attacks involved systematic and widespread looting, and the destruction and burning of houses, health centres, schools and churches (see annex 25). Hema civilians were routinely abducted to serve as carriers to transport the loot.

- 80. These attacks led to massive displacements of all communities (see annex 26). According to the Office for the Coordination of Humanitarian Affairs, in October 2019, more than 400,000 people were displaced within Ituri Province or into Uganda. Attackers often threatened to kill Hema civilians if they did not leave their villages and declared that this was "not Hema land, but Lendu land". Internally displaced members of the Hema community who returned to their villages or fields were often attacked and/or chased away. From September 2019, attacks targeted camps for internally displaced persons at night.
- 81. Rape, including gang rape, occurred while people were escaping, were being abducted and/or returned to their villages to collect food. <sup>20</sup> The Group interviewed six civilians who were raped by Lendu attackers around Wago, Laudjo, Dhendro and Lera between February and September 2019. One recounted that in the course of two days in February 2019, Lendu attackers detained and raped six abducted Hema women, including herself and two girls between 16 and 18 years of age, in their camp near Laudjo.

#### Perpetrators of the attacks

- 82. Almost all interviewed Hema witnesses and victims stated that their attackers belonged to the Lendu community, in particular because they had come from Lendu villages and spoke Kilendu. Many recognized and identified Lendu neighbours as their attackers. For instance, two eyewitnesses recognized a certain Lokana, the chief of Lyio/Lidjo, among the attackers at Tche village on 10 and 11 June 2019. An independent source confirmed that several witnesses and victims had mentioned Lokana's involvement. One Lendu chief and two Lendu prisoners cited the complicity of certain Lendu personalities with the attackers.
- 83. Some attackers were military fatigues and carried firearms, including light machine guns ("SMG" according to witnesses) and AK-47-pattern weapons, while most used machetes, axes, arrows and/or spears. Witnesses and FARDC members observed a few mortars, RPG-7 rocket launchers and PKM machine guns. On 28 July 2019, a MONUSCO peacekeeping patrol was fired at with an RPG-7 (using PG7-V ammunition) while it was rescuing civilians under attack in Dhedja/Kasseli (see para. 75).
- 84. The similar patterns and simultaneous occurrence of the attacks, and the involvement of attackers from several localities, indicate some level of coordination, organization and planning. One internally displaced member of the Hema community told the Group that, three days prior to the 10 June 2019 attack on Sombuso, Lendu women had warned him that several Lendu chiefs had met in Dhendo to organize the attack.
- 85. FARDC and the provincial government referred to the Lendu attackers as "the Assailants" and a certain Ngudjolo as their leader, <sup>22</sup> and made public his alleged electoral card (see annex 27). Among the eight interviewees who saw Ngudjolo, only

two recognized him as the man in the photograph on the electoral card as Ngudjolo. One stated that Ngudjolo was a different person. They all confirmed that the Ngudjolo they knew was the leader of "the Assailants".

- 86. The Group has entered into contact with individuals who said they belonged to Ngudjolo's movement. According to them, the movement was named "Union des révolutionnaires pour la défense du peuple congolais (URDPC)" and Ngudjolo Mapa Innocent was their leader. The main objective was to fight harassment of the Congolese population by the police and FARDC. That was the movement's reason for launching attacks against FARDC in Djugu Territory, including on Kparanganza, <sup>23</sup> although the movement claimed that it had not conducted all of them. The individuals denied any involvement of URDPC in attacks against Hema civilians or the abduction of seven Hema civilians in Lokpa/Lichi on 12 September 2019, and instead claimed to have liberated them from their Lendu abductors.
- 87. They described URDPC as a "self-defence movement" whose structure was not military and comprised 1,853 combatants, all of them Lendu, and under the effective control of Ngudjolo. At the time of drafting the present report, its base was in Loe Groupement next to Jiba, with combatants spread across various locations in Djugu Territory. They possessed 148 AK-47-pattern assault rifles, 5 PKM machine guns, 7 rocket-propelled grenades and 3 mortars acquired in combats with FARDC.
- 88. A part of this information is consistent with evidence from other sources, in particular where it concerns the motivation for the attacks against FARDC, diversion of weapons and ammunition from FARDC stock, the limited organizational structure of the movement, the spread of troops across locations and their presence close to Jiba. These sources included audio recordings allegedly made by the movement and a directive from "Ngodjolo" addressed to the Lendu population with the reference "MVMT: URRDPC" in the heading (see annex 28).
- 89. However, the movement's denial of any involvement in attacks against Hema civilians was contradicted by most of the Group's sources. In particular, three of the Lokpa/Lichi abductees reported that their Lendu abductors said they had come to the village on Ngudjolo's instructions. Another source familiar with the abduction confirmed that Ngudjolo had agreed to release the abductees. Two abductees declared that their armed guards in Ngudjolo's camp had said that members of the movement had attacked the Roe camp for internally displaced persons.<sup>24</sup>
- 90. Five independent sources told the Group that several combatants had left the movement when Ngudjolo announced his readiness to cease hostilities under certain conditions (see annex 29), because they wanted to continue fighting, and that Ngudjolo had sent representatives to convene resisting combatants.

## Impact on the Lendu population

- 91. Based on eight independent sources, the Group found that the Lendu militias forced the Lendu population to financially contribute to the war effort in several areas, including Ndr'li, Andri, Ndjalo and Jiba, through the payment of taxes or percentages on goods (see annex 30).
- 92. Lendu civilians unsupportive of the militias risked retaliation. One Lendu chief admitted the existence of reprisals and of risks for any Lendu civilian who denounced "the Assailants". Another Lendu source said "neutral" behaviour was essential. Seven sources explained that a Lendu priest was abducted from Jiba from 4 to 7 June 2019

because of his opposition to the movement. Two sources confirmed that the Lendu population was caught between the militias and FARDC.

## B. Attacks by members of the Congolese security forces

93. The Group found that members of the Congolese security forces deployed in Djugu Territory abused the civilian population.

#### **Burning of Lendu houses**

- 94. Many independent sources stated that Congolese security forces deployed in Djugu Territory considered the entire Lendu population as "the Assailants". One high-ranking FARDC officer professed to the Group that "every Lendu community supports the Assailants", and another that the Lendu are "really lazy".
- 95. According to seven sources, including four eyewitnesses, troops of the 3201st FARDC regiment troops in Jiba and Ngudjolo's combatants engaged in combat in Jiba in July 2019. The eyewitnesses saw FARDC burning and destroying about 25 houses, which forced the population to flee the village (see annex 31). Two eyewitnesses reported that there had been no fighting when FARDC burnt the houses. One of these two eyewitnesses and another stated that the burning was a reprisal for the killing of an FARDC soldier or scout.

## Rape

- 96. Based on the testimonies of six Hema and Mambisa women, the Group found that some members of the Congolese security forces deployed in Djugu Territory had committed rape in Rule, Largu, Blukwa, and Liko, as well as around Djugu centre, between April and October 2019. The rape victims identified their attackers based on their uniforms, ethnicity and languages (Lingala and Swahili).
- 97. One rape victim explained that all women in Largu had taken to sleeping away from their houses for fear of rape by FARDC members. On one night in June 2019, FARDC members speaking Lingala raped her and at least 10 other women around Largu. The source was raped by two soldiers. The FARDC 1301st regiment was deployed in Largu at that time. A victim raped in Blukwa, close to Largu, stated that whenever FARDC soldiers entered a house, it was to rape or to loot.
- 98. Six sources mentioned rape cases of Lendu women by FARDC members, but the Group could not gain access the victims.

### Mistreatment of prisoners

- 99. Six Lendu and Alur prisoners told the Group that Congolese security forces had seriously mistreated them following their arrest at several locations in Djugu Territory from June 2019, as well as during the first days of detention (see annex 32).
- 100. The Group welcomes steps taken by FARDC and the Lendu community to improve relations (see annex 33), and by the military justice system to investigate crimes in Djugu Territory, including by FARDC members.

## VI. Recommendations

101. The Group makes the recommendations set out below.

## Government of the Democratic Republic of the Congo

102. The Group recommends that the Government:

- (a) Execute the arrest warrant issued on 7 June 2019 against sanctioned individual Guidon Shimiray Mwissa (CDi.033) by the North Kivu Military Prosecutor's Office (see para. 12);
- (b) Take urgent action to prevent FARDC members from providing any further support to NDC-R (see paras. 12 and 66–73);
- (c) Take all necessary measures to protect the civilian population of Djugu Territory, in compliance with international human rights and international humanitarian law standards, regardless of community membership. This includes ensuring that communities are not collectively punished for the actions of certain individuals or groups (see paras. 76–100);
- (d) Continue to investigate and prosecute, as appropriate, individuals, including FARDC members, responsible for serious violations of international humanitarian and/or human rights law in Djugu Territory in proceedings that fully guarantee fair trial rights, regardless of community membership (see paras. 76–100);
- (e) Establish a high-level inter-agency mechanism in the country's administration to investigate any loss or theft of weapons, ammunition and associated materiel in support of legal proceedings and provide the necessary recommendations to effectively secure the materiel (see paras. 66–73).

## Security Council Committee established pursuant to resolution 1533 (2004) concerning the Democratic Republic of the Congo

- 103. The Group recommends that the Security Council Committee established pursuant to resolution 1533 (2004) concerning the Democratic Republic of the Congo:
- (a) Encourage Uganda to adopt legislation in line with the 2010 Lusaka Declaration implementing the compulsory use of ICGLR certificates (see paras. 55–57);
- (b) Request Member States to provide, in their arms embargo notifications to the Committee, all relevant technical specifications of the shipped equipment outlined in the Committee guidelines, including the type of the equipment; the name of the items following the nomenclature used by the manufacturing company; the state of the equipment (newly manufactured or, if second-hand equipment, year of manufacture); and marking numbers or codes of each shipped item (see para. 60).

## **International Conference on the Great Lakes Region**

104. The Group recommends that ICGLR encourage its Member States to enforce the requirements of the regional chain of custody and due diligence standards for companies, including brokers and service providers, operating in the minerals sector (see paras. 51–52 and 55–57).











L'an deux mille dix-neuf, le septième jour du mois d'octobre, s'est tenue dans la salle de réunion du Gouvernorat de la Province du Nord Kivu, une réunion du Comité de Suivi des Activités Minières, sous la modération de son Excellence Monsieur le Ministre Provincial en charge des Mines, Président de ladite commission.

### Des points à l'ordre du jour

Quatre points étaient inscrits à l'Ordre du jour, à savoir :

- ✓ Lecture et adoption du compte rendu de la réunion du 11 septembre 2019 ;
- ✓ La présentation synthèse des cahiers des charges SMB sarl et COOPERAMMA GIE;
- ✓ Lecture des dispositions légales en rapport aux revendications soulevées dans les cahiers des charges;
- ✓ Echange et dispositions finales.

# 1. De la Lecture et adoption du compte rendu de la réunion du 11 septembre 2019.

Ayant constaté l'absence du Chef de Division des Mines et Géologie, Rapporteur de la CSAM, le Ministre Provincial a rappelé les trois grandes recommandations faites lors de la réunion du 11 septembre 2019 à savoir :

- L'élaboration des cahiers des charges par les deux parties (SMB sarl et COOPERAMMA GIE);
- La descente sur terrain pour faire l'état des lieux des activités minières dans le périmètre couvert par le PE 4731 de la SMB sarl;
- L'organisation d'une rencontre entre les décideurs de deux parties.

Pour l'ensemble de ces recommandations, il a été constaté que seules les deux premières étaient déjà réalisées.

Signalons qu'au cours de ce débat, la SMB sarl a proposé que soit mise en place une commission ad hoc pour certifier les dettes et les avancées en paiement entre la SMB sarl et la COOPERAMMA GIE. Pour cette question, il a été proposé que par une décision du Ministre Provincial en charge des Mines et Finances soient nommés les membres de cette commission qui sera composé de sept membres dont :

- Un délégué du cabinet du Gouverneur, Monsieur NKOKORI Roger;
- Deux délégués du Ministère Provincial des Mines en la personne de monsieur John SAIDI et Mr. MACHO;
- Un délégué de la division provinciale des Mines en la personne de Monsieur KAMBALE MUSAYI;
- Un délégué du SAEMAPE, Monsieur BASOSHI IUBWE Théophile;
- Un délégué de la COOPERAMMA, Monsieur MUNEZA Aimable;
- Un délégué de la SMB sarl, Monsieur Janvier MWANGACHUCHU.

# 3. De la lecture des dispositions légales en rapport aux revendications soulevées dans les cahiers des charges.

- La circulation des agents de la SMB sarl dans tous son périmètre doit être garantie ;
- La SMB sarl doit présenter au Ministre Provincial l'avis favorable ou défavorable de sa demande d'extension d'exploitation d'autres substances dont la tourmaline;
- Que soit mise en place une commission ad hoc de certification des dettes et des paiements.

Commencée à 09h30', la réunion a pris fin à 12h 30'.





# Four case studies of illegal involvement of some FARDC elements in mineral trading

# Quatre cas d'implication de certains éléments des FARDC dans le commerce illicite de minerais

Case Study #1: On the evening of 24 October 2019 the Congolese mining police seized 17 bags of untagged coltan of unknown total weight at the Mushake roadblock, 12 km from Sake along a known smuggling route that is the road connecting Goma and Masisi, North Kivu (see S/2019/469, paras. 162-163). According to eyewitnesses interviewed by the Group, the bags of minerals were transported by armed FARDC elements in a military vehicle. A trader interviewed by the Group confirmed that the coltan originated from a mine in the Rubaya area, North Kivu. At the time of drafting, the ultimate owner and location of the minerals were unknown. Three representatives from the military justice in Goma confirmed to the Group that investigations into the case were ongoing. The Group is aware of several similar incidents along the same route, including one case that occurred on night of 22/23 October 2019. The Group continues to investigate.

Affaire n° 1: Dans la soirée du 24 octobre 2019, la police congolaise des mines a saisi 17 sacs de coltan non étiquetés d'un poids total inconnu au barrage routier de Mushake, à 12 km de Sake, sur une route connue pour le trafic de minerais, à savoir la route reliant Goma à Masisi dans le Nord Kivu (voir S/2019/469, par. 162-163). D'après les témoins oculaires interrogés par le Groupe, les sacs de minerais étaient transportés par des éléments FARDC armés à l'intérieur d'un véhicule militaire. Un commerçant interviewé par le Groupe a confirmé que le coltan provenait d'une mine de la zone de Rubaya, Nord Kivu. Au moment de la rédaction du rapport, le destinataire final et le lieu où se trouvaient les minerais étaient inconnus. Trois représentants de la justice militaire à Goma ont confirmé au Groupe que les enquêtes étaient en cours dans cette affaire. Le Groupe a connaissance de plusieurs incidents similaires qui se sont produits sur la même route, y compris un incident dans la nuit du 22 au 23 octobre 2019. Le Groupe continue d'enquêter.

Case Study #2: The Group documented the ongoing occupation of an unvalidated gold mine in Mwenga territory, South Kivu by at least nine FARDC elements who dug for gold. On 24 September 2019, at Kibe, Kabondo mine, Major Olivier Mazala and around nine other FARDC elements entered the site, of which the ownership is under dispute. Two eyewitnesses confirmed to the Group that the military elements were in the mine and undertaking mining activities. The Group saw official court documents held by the mine owner regarding the case. The Group contacted Mazala by phone several times but did not receive an answer. The Group continues to investigate the onward supply chain of the gold.

Affaire n° 2: Le Groupe a documenté l'occupation en cours d'une mine d'or non-validée dans le territoire de Mwenga, Sud Kivu, par au moins neuf éléments des FARDC qui creusaient pour trouver de l'or. Le 24 septembre 2019, le Major Olivier Mazala et environ neuf autres éléments des FARDC sont entrés dans la mine de Kabondo à Kibe, dont la propriété est disputée. Deux témoins oculaires ont confirmé au Groupe que des éléments militaires étaient effectivement dans la mine et se livraient à des activités minières. Le Groupe a consulté des documents (officiels) judiciaires détenus par le propriétaire de la mine concernant cette affaire. Le Groupe a contacté Mazala par téléphone à plusieurs reprises mais n'a reçu aucune réponse. Le Groupe continue d'enquêter sur la chaîne d'approvisionnement de l'or.

Case Study #3: In a third case, the Group documented how on 17 June 2019 an FARDC element providing off-budget security for an unregistered gold mining company in Ituri province was ambushed by a separate group of FARDC elements in an attempted heist of just over 6.5 kg (6539.16 g) gold, according to official documents. The gold, which was in the form of ingots, was being transported by vehicle from an unvalidated mining site in Adisoma, Irumu, Ituri, to an unknown destination by a representative of Xin Ding Yuan, a company belonging to Chinese investors. Both the representative of Xin Ding Yuan and the FARDC element providing off-budget security were killed in the ambush, according to official records of the event seen by the Group. Investigations by military and provincial authorities, reviewed by the Group, revealed that the heist was orchestrated by Honorable Didier Boyoko Kabange, a provincial politician who has since been removed from office. The Group tried to contact Honorable Kabange, who was sentenced to a USD \$ 20,000 fine and life-long hard labour and who is appealing the case, but was unable to do so by time of publication. The seized gold was valued at USD 235,911.6 and was sold to Muungano na Maendeleo (MNM) a registered gold buying house based in Bunia, Ituri. The Group contacted MNM to confirm the onward trajectory of the gold, but was unable to obtain comment. The Group is aware of at least two other similar cases in Ituri in 2019 and continues to investigate.

Affaire n° 3: Une troisième affaire a permis au Groupe de documenter comment le 17 juin 2019 un élément des FARDC, assurant la sécurité hors budget d'une compagnie minière d'or non enregistrée dans la province de l'Ituri, est tombé dans une embuscade tendue par d'autres éléments FARDC lors d'une tentative de braquage d'un peu plus 6,5 kg (6,53916 g) d'or. L'or, qui était sous la forme de lingots, provenait de la mine non-validée Adisoma en Irumu, en Ituri, pour une destination inconnue et était transporté dans un véhicule conduit par un représentant de la compagnie Xin Ding Yuan, qui appartient à des investisseurs chinois. Le représentant de Xin Ding Yuan et l'élément FARDC assurant la sécurité hors budget ont, tous les deux, été tués dans l'embuscade, selon les procès-verbaux officiels consultés par le Groupe. Les enquêtes des autorités militaires et provinciales, consultées par le Groupe, montrent que le braquage a été organisé par l'Honorable Didier Boyoko Kabange, un politicien provincial, qui a depuis été démis de ses fonctions. Le Groupe a essayé de contacter Honorable Kabange, qui a été condamné à une amende de 20 000 dollars américains et des travaux forcés à vie et qui a fait appel, mais n'y est pas parvenu avant la publication du rapport. L'or saisi a été évalué à 235 911,60 dollars américains et a été vendu à Muungano na Maendeleo (MNM), un comptoir d'or enregistré et basé à Bunia, en Ituri. Le groupe a contacté MNM afin de s'enquérir de ce qu'il était advenu de l'or, mais n'a pas été en mesure d'obtenir le moindre commentaire. Le Groupe a connaissance d'au moins deux autres affaires similaires en Ituri en 2019 et continue d'enquêter.



**Case Study #4:** The prosecution of a fourth case involving Colonel Innocent Kabundi of 32nd military region, head of sector operations, Bunia, is ongoing. Military justice informed the Group that the Colonel, who is charged with involvement in illegal gold trafficking, is suspended from duty.

- (b) Keep a record of all types of plant, machinery and equipment, raw materials and goods manufactured in the factory and keep that record at all times available for examination by the proper officer.
- (c) Provide all necessary, labour and materials for the storing, examining, packing, marking, coopering, weighing and taking stock of the goods in the factory whenever the proper officer so requires.

Section 164 (2) All manufactured goods shall be duly exported or entered for home consumption within such time and subject to such conditions as the Commissioner may impose.

**Section 166 (1)** The Commissioner may, subject to such conditions as he may impose and on payment of duties due, permit goods manufactured in a bonded factory, including waste from the manufacturing process, to be entered for home consumption.

**Section 166 (2)** The value for the purpose of determining the duty on the goods removed from a bonded factory shall be determined in accordance with section 122.

Section 166 (3) A licensee who, without the permission of the Commissioner, disposes of, or allows to be disposed of, raw materials or manufactured goods from a bonded factory, within the Partner States, whether on payment or not, or any person who acquires, keeps, conceals or has in his or her possession such raw materials or manufactured goods from a bonded factory, commits an offence and shall be liable on conviction to a fine of five thousand dollars or fifty percent of the ex-factory value of the raw materials or manufactured goods, whichever is the higher, or to imprisonment for a term not exceeding three years or both; and the goods in respect of which the offence has been committed shall be liable to forfeiture.

## Section 171 further states;

**'inward processing'** means the customs procedure under which certain goods can be brought in a Partner State conditionally exempted from duty on the basis that such goods are intended for manufacturing, processing or repair and subsequent exportation.

**Section 172 (1)** The Commissioner shall, subject to such conditions as the Commissioner may prescribe, allow the following goods to be entered for inward processing in a Partner State in one or more processing operations

- (a) Goods imported directly from a foreign country
- (b) Goods transferred from another Partner State

Section 172 (2) Goods entered under subsection (1) shall be exempt from duty.

Section 172 (3) The right to import goods for inward processing shall not be limited to the owner of the imported goods but shall extend to a contract in which a foreign consignor remains the owner of the goods and the importer only processes the goods under contract.

Further reference is made to the **East African Community Customs**Management Act Regulations under Part XIII Manufacturing Under Bond
(MUB) as well as those under Part XVI Inward and Outward Processing.

In order to streamline the sector and achieve the country's objective of value addition through processing as well as mitigate the rampant fraud in the sector and line with the above provisions, you SHALL be required to fulfil the conditions listed below before you are allowed to continue operating an MUB facility and exporting gold out of the country:

 Any licensed gold refinery or precious metal processing company which wishes to export shall produce gold bars that conform to the international specifications as follows:

# (a) Weight and fineness of the bar:

- For 1 Kilogram of tradable gold bar of international standards minimum of 995 purity and /or minimum of 999.9 purity per thousand parts of gold.
- For a small tradable gold bar an exact weight of 1.00g, 2.5g, 5.00g, 10.00g, 20.00g, 50.00g, 100.00g, 10 tola with a weight of 11.6638 grams minimum 999.0 purity and /or higher purity of 999.9 per thousand parts of fine gold.

# (b) Appearance:

- The surfaces of the bar shall be smooth, free of any irregularities such as layering, surface cavities, bubbles, spots, blowholes or shrinkage.

## (c) Marks:

- The bars should bear the following marks, which shall be clearly legible
  - i) Serial Numbers
  - ii) Hallmark/brand stamp of the refiner
  - iii) Fineness (to four significant figures)
  - iv) Weight (expressed in grams, kilograms or troy ounces)
- The bars must reflect the year of manufacture, or if not, the year must be stated on the accompanying certificate of the manufacturer.
- (d) All shapes and sizes of the fine kilobars may have minor variations but the following measurements should be considered as the benchmarks:
  - Maximum Length: 119 mm
  - Maximum Width: 55 mm
  - Maximum Thickness: 9 mm

- 2. All licensed refineries are required to provide to Customs an XRF Machine, an accurate weighing scale and size measuring instrument.
- 3. All gold exports shall be verified, weighed and tested by Customs at the Airport using the equipment provided in 2 above. For any consignment to be allowed, it must pass all the tests using the provided equipment by all the refineries.
- 4. Since all mineral dealers are regulated by the Ministry of Energy and Minerals Development, the licensed refineries must only accept gold from licensed dealers or licensed producers for locally produced gold.
- 5. All refineries must put in place Environmental friendly and sustainable Management practices to manage waste disposal and obtain clearance of the same from National Environmental Management Authority before application for Manufacture Under Bond (MUB).
- 6. All refineries must establish standards and practices to protect human resources against any dangerous exposure arising from the refining processes. A confirmation on the same from Ministry of Gender and Labour development must be submitted before application of MUB.
- 7. Any company which is under international sanctions or whose directors are under international sanctions SHALL not be licensed to operate a refinery and export of gold. For this matter, all companies must submit to the Commissioner the Ultimate Beneficiary Owners and shareholders of the legal entity to avoid sanctioned persons getting involved in the business to safe guard Uganda against listing in the United Nations reports.
- 8. No refinery is allowed to source gold for inward processing from jurisdictions or authorities under international sanctions.
- 9. All refineries MUST fully comply with the applicable domestic tax laws and submit a tax compliance certificate before application for MUB.
- 10. All refineries must comply with the Import and Export procedures as per the EACCMA.
- 11. In order for the Country to further enhance the value chain in the sector, all refineries are required to submit to the Commissioner their roadmap / plan for future value addition i.e. in producing products out of Gold bars by 31st December 2019.
- 12. Any company whose directors directly or indirectly get involved in smuggling or abetting smuggling of Gold, Money laundering and or violating the provisions for licensing SHALL have their license AUTOMATICALLY REVOKED and directors prosecuted under the Customs Laws.

All the companies are requested to revert back to the undersigned **within 5 days** from the date of this notice indicating their full compliance with the above requirements as a condition for further facilitation by Customs.

By copy of this letter, the Manager Entebbe Customs is instructed to STRICTLY enforce compliance with these requirements with immediate effect.

# 1. INTRODUCTION

- 1.1 The 19th Meeting of the ICGLR Regional Committee against the Illegal Exploitation on Natural Resources was held from 1st to 4th October 2019 in Ngozi, Republic of Burundi. The meeting was marked by the official launch of the ICGLR Certificate in the Republic of Burundi. The meeting was officially opened by His Excellency Dr Joseph Butore, the Second Vice-President of the Republic of Burundi.
- 1.2 The objective of the 19<sup>th</sup> Meeting of the ICGLR Regional Committee was threefold: Official launch of the ICGLR Certificate in the Republic of Burundi, Review of the Status of Implementation of the Roadmap for the 6 Tools of RINR and Consideration of the revised Manual of the Regional Certification Mechanism.
- 1.3 The following Member States attended the meeting: Republic of Burundi, Central African Republic, Republic of Congo, Democratic Republic of Congo, Republic of Kenya, Republic of South Sudan, Republic of Zambia, United Republic of Tanzania and Republic of Uganda. The Chairperson of the ICGLR Regional Audit Committee also attended the meeting.
- 1.4 Besides, ICGLR partners in implementation of the RINR, namely GIZ, BGR and IMPACT attended the meeting as observers. It was also attended by the Director General of AMGC and officials of the Ministry of Minerals of the United Republic of Tanzania and those of the Ministry of Mines of the DRC from South Kivu Province.

# 2. OPENING SESSION

2.1 The meeting was officially opened by H.E. Dr Joseph Butore, Vice-President of the Republic of Burundi. The Opening Session was also

addressed by H.E. Hon. Côme MANIRAKIZA, Minister of Hydraulics, Energy and Mines in the Republic of Burundi, Ambassador Ambeyi Ligabo, Representative of the ICGLR Executive Secretary, Mr Albert NDUWIMANA, Governor of Ngozi Province, Mrs Annick MAKOLET, Vice-President of the ICGLR Regional Committee, and Mrs. Madame Julie Héliane Danielle SERVICE on the behalf of H. E Minister of Geology and Mines in the Republic of Congo and Chair of Ministers in charge of Mines in ICGLR of Member State.

- 2.2 In his opening statement, the Guest of Honour, His Excellency Dr Joseph BUTORE, Vice-President of the Republic of Burundi, first conveyed to the audience the greetings from His Excellency Pierre NKURUNZINZA, President of the Republic of Burundi.
- 2.3 He placed particular emphasis on the Protocol on the Fight against Illegal Exploitation of Natural Resources and the objectives assigned to it and recommended that Member States should take ownership of the Protocol. He further called for full cooperation between Member States in the implementation of strategies to combat the illegal exploitation of natural resources and smuggling of minerals, through sharing of information and experiences between more and less advanced countries. He finally stated that mineral resources should further unite Member States of the ICGLR, strengthen them and not divide them.
- 2.4 In his remarks, His Excellency Minister of Hydraulics, Energy and Mines of the Republic of Burundi, Honourable Côme MANIRAKIZA, welcomed, with pleasure, the various ICGLR delegations at Ruhuka Hotel, in BUYE of which he praised the natural landscape. He framed the event within the ICGLR Protocol on the Fight against the Illegal Exploitation of Natural Resources before dressing a list of key achievements of the Republic of

Burundi after the signing of the Lusaka Declaration at the Special Summit of ICGLR Heads of State and Government against the Illegal Exploitation of Natural Resources, held on 15 December, 2010. Lastly, he acknowledged the support of the Conference Secretariat and technical and financial partners, particularly in strengthening the capacities of the management and staff of the Burundi Mining Authority.

- 2.5 Ambassador Ambeyi LIGABO, Representative of the ICGLR Executive Secretary, expressed his profound gratitude and thanked His Excellency the Second Vice-President of the Republic of Burundi for having honoured, with his presence, the opening ceremonies of the 19th Meeting of the ICGLR Regional Committee on Natural Resources and the Official Launch of the ICGLR Certificate in Burundi. He reiterated the desire of the ICGLR to see the effective implementation of the Regional Certification Mechanism in all Member States in the aim of cutting the link between the exploitation of the natural resources and the financing of conflicts perpetrated by negative forces, and thus contributing to peace, security, stability and sustainable development of our States.
  - 2.6In his welcome note, the Governor of Ngozi Province, Mr. Albert NDUWIMANA, thanked the ICGLR Secretariat and the Regional Committee for choosing Ngozi Province as the venue of the 19<sup>th</sup> meeting of the Regional Committee against the Illegal Exploitation of Natural Resources. He then wished all the participants a nice stay while stating that the whole province is calm and peaceful.
  - 2.7The Vice-Chairperson of the ICGLR Regional Committee, Mrs Annick MAKOLET, thanked the Republic of Burundi through His Excellency the Second Vice-President of the Republic for the warm welcome extended to the various delegations. The same thanks were addressed to the Executive Secretary of the ICGLR for the



adequate logistical and financial arrangements for the success of the work. The Vice-Chairperson reminded the delegations of the ICGLR Member States about the urgent need highlighted by urgency highlighted by the 7th Summit of ICGLR Heads of State and Government and the 5th meeting of Ministers in charge of Mines, both held in Brazzaville in October 2017 and December 2018, respectively, for the implementation of the Self-Financing Mechanism of the Regional Initiative on the Fight Against the Illegal Exploitation of Natural Resources.

2.8 The representative of His Excellency Pierre OBA, Minister of Geology and Mines of the Republic of Congo and Chair of ICGLR Ministers in charge of Mines, Mrs. Julie Héliane Danielle SERVICE, in the statement by the Minister and Chair, congratulated the Government of Burundi for its determination in issuing the ICGLR Certificate. She stated that her Government is working tirelessly to implement the 6 tools of the ICGLR Regional Initiative on the Fight against the Illegal Exploitation of Natural Resources. She concluded her speech by encouraging all Member States to implement the ICGLR Regional Certification Mechanism, as it is said that, "Our hard work depends on our people's lives".

# 3. OFFICIAL LAUNCH OF THE ICGLR CERTIFICATE IN BURUNDI

3.1.On Tuesday, October 1st, 2019, under the High Patronage of HE Dr. Joseph BUTORE, Second Vice President of the Republic of Burundi, Burundi officially launched its ICGLR Certificate for the export of 3T minerals. The Ministers in charge of Mines of the Member States, in this case the United Republic of Tanzania, the Democratic Republic of Congo and the Republic of Congo were respectively represented by the Permanent Secretary of the Ministry of Mineral Resources of the United Republic of Tanzania, the Secretary General for Mines of the

Democratic Republic of Congo and Member of the ICGLR Regional Committee for the Republic of Congo. The Republic of Kenya and the Republic of Rwanda were represented by their respective Embassies accredited to Burundi. Embassies and Diplomatic Missions accredited to Burundi as well as International Organisations partnering with ICGLR and Burundi also took part in the ceremonies.

3.2. The Specimens of the ICGLR Certificate were issued to 3 Mineral Export Companies of the 3Ts in Burundi who had undergone ICGLR Third party Audit, namely, Burundi Mineral Export (BME), Société d'Exploitation et de Commercialisation des Minerais au Burundi (SECOMIB) et Raw Mineral Resources (RMR). The delegations of all 12 ICGLR Member States received specimens for use as reference document whenever required to do so.

#### 4. ADOPTION OF THE AGENDA

After presentation of the draft agenda by the Vice-Chair of the Regional Committee, the Committee reviewed and adopted it as follows:

- Review of the Status of Implementation of Roadmaps for the 6 tools by Member States and at regional level.
- Review of the revised Manual of the Regional Certification Manual.
- Revision of the Committee's Rules of Procedure.
- Election of the Bureau members of the Regional Committee.

#### 4. RECOMMENDATIONS

The Committee deliberated on all the items of the agenda and formulated the following recommendations:

- 1. The Regional Certification Mechanism Manual is approved.
- 2. The Regional Certification Mechanism Manual shall be evaluated every two (2) years.

- 3. In case of an audit request by a Red Status exporter, the Audit Committee shall proceed with the request in a timely manner;
- 4. The ICGLR Secretariat shall send a letter to the Ministers in charge of Mines on the need for the RINR Self-Financing Mechanism to be implemented;
- 5. A period of six (6) months from November 2019 should be granted to each Member State to pay its annual contributions, which, in case of failing, a penalty system will be applied to it.
- 6. The Regional Committee took note of the proposed USAID- PACT Project on Mine Site Inspections and Validation in DRC and expressed strong reservation because of the potential conflicts of interest since PACT is also involved in Mineral traceability alongside other traceability service providers in the Great Lakes Region.
- 7. Member States should support and facilitate logistical arrangements for the development of a ICGLR promotional video for the RINR.
- 8. The Revised Rules of Procedure of the Regional Committee have been adopted; they will be transmitted to Ministers in charge of Mines for onward transmission to an Approval Authority before it is implemented, namely the ICGLR Regional Inter-Ministerial Committee at its next meeting.
- 9. Member States are encouraged to nominate two members of the Regional Committee each, a principal and an alternate, preferably one man and one woman, from officials in the Ministry in charge of Mines, while indicating the principal.

- 10. The Bureau of the RINR Regional Committee will be established on a rotational basis following the alphabetical order of Member States for a period of two years, non-renewable beginning from the next meeting; in case of unavailability of the concerned Member State, the following Member State on the alphabetical list will take the post.
- 11.An Interim Bureau was constituted until the next meeting and the approval of the Rules of Procedures. It is composed as follows:
  - Chairperson: Mrs Annick MAKOLET, Central African Republic;
  - Vice- Chairperson: Mr William ALIGA, Republic of South Sudan;
  - Rapporteur: Mr Assa MWAKILEMBE, United Republic of Tanzania.
- 12. The Regional Committee expressed deep concern on the refusal of GIZ to facilitate the delegates of Burundi and DRC in participation in ICGLR Regional Committee Meetings. Therefore, the Committee recommends the ICGLR Secretariat to engage with GIZ and find a sustainable solution.
- 13. Date and Venue of the Next Meeting: The Twentieth Meeting of the Regional Committee on Natural Resources will be held in the Central African Republic or the United Republic of Tanzania or the Democratic Republic of Congo (consecutively with the Regional Forum on Gold) in March 2020.





Ils sont là, ohh, **OPJ Mouvement** (*Commentaire*: Officier de Police judiciaire du mouvement (NDC-R)), ohh **ParSec du Cabinet** (*Commentaire*: Secrétaire Particulier du Cabinet)), ohh, le **chef T1** (*Commentaire*: Le Tl

désigne l'officier en charge de la gestion du personnel), le voici, il est là, il est décidé, il part à Rutshuru pour mettre fin aux histoires de kidnapping, aux histoires des convois.

Avec une grande équipe, là.

C'est (incompréhensible) les mouvements décidé là-bas, voilà toute l'équipe.

Ils sont là, ils sont là... très décidé.

#### English translation by the Group

There are a lot of them.

There they are (we see a long file of people advancing and carrying varying weaponry).

#### There are a lot of munitions as well.

See, you see these are the "revolutionaries".

The NDC-Rénové, they're fighting the FDLR at the moment, in Rutushuru territory, at Bwito.

(Commentary: it was the CNRD and not the FDLR who were at Bwito the date that this video was taken).

Even the mamas have decided to bring this thing to an end.

#### See, look at the mamas who are carrying munitions.

They're commanders too.

Ha, there you are.. they are there..

There we have it, a big commander that you see before us here.

#### He is called MATUNGULU, he's one of the big commanders.

They're there.

See, the whole population has decided to stop this.

They're fighting against the FDLR in the whole territory of Rutshuru, at Bwito area.

They're there today, right now.

#### There will be at least five operations.

Look at them, they're all NDC-R fighters.

The others, they're patriots, very "revolutionaries".

Well, there they are, passing by.

That's the leader, the man who just passed.

They are carrying heavy weapons.

Mi AA, anti-Aircraft machine gun (Commentary: heavy machine gun, 12.7x108mm calibre weapon).

Look at those kids, fighting day and night with their (incomprehensible), the PKMs (*Commentary: light machine gun*, 7.62x54Rmm calibre weapon).

There they are, and all combatants.

So you see there are lots of arms, tripods. (*Commentary:* a fighter carrying a 82mm mortar bipod comes into view). I don't know what else.

#### Oh an 82mm mortar

Look, look, an 80 mortar (Commentary: a second tube of an 82mm mortar passes in front of the camera).

They've come with a lot.

Look, look (incomprehensible) the warrant officer, he's a big fighter, he's there, he's called **Eric KITWANA**. There's a PKM behind him (**Commentary:** a fighter carrying a PKM machine gun).

#### Behind KIBARIGA

A big man, it's the deputy T3 (Commentary: the T3 designates the officer in charge of operations), a senior NDC-R fighter, he's called Alpha RADJABU ALFANI.

With the whole team behind him.

He's a big man, he's a big fighter.

They've passed by, and him as well.

The others are.. Bureau 4! (Commentary: the "fourth office" designates the service or officer in charge of logistics/supplies).

There he is, the sector head **Raga HAKIZIMWAMI**, with all the team. There's the deputy sector head. They're all there, they've decided to bring an end to the FDLR at Bwito.

Even the mamas are very angry about it.

See, see how the mamas bang on their chests.

They're all there, ooh **OPJ Mouvement** (Commentary: the senior judicial police officer of the NDC-R movement) ooh **ParSec du Cabinet** (Commentary: the particular secretary of the Cabinet of the NDC-R) ooh the **chef T1.** (Commentary: the T1 designates the officer in charge of management of personnel). Him, he's there, it's decided, he will leave Rutshuru to end the kidnapping, this thing with the convoys.

With a big team, that we see.

It's (incomprehensible) the movements decided there, and here we see all the team. They're there, they're there, they're there, most decidedly.



### Short background and history of the Hema-Lendu conflict

#### Bref historique et contexte du conflit Hema-Lendu

After the 1999-2003 conflict during which the Hema and Lendu communities in Ituri opposed one another, a first wave of violence erupted in Djugu territory, Ituri, between December 2017 and March 2018 (see S/2018/531, paras. 158-164). After a relative lull, smaller-scale attacks on FARDC positions and civilians started from September 2018, in particular on the shores of Lake Albert. According to several sources, including MONUSCO, from 23 to 25 May 2019, multiple attacks targeted the Alur population of Mahagi territory, north of Djugu territory, Ituri. On 10 June 2019, unidentified individuals killed four Lendu men in Zibiti, Djugu territory, including the president of the Fédération des entreprises du Congo (FEC) in Kobu. Simultaneous mass attacks on Hema localities started immediately afterwards on the same day.

Testimonies varied as to whether the four Lendu men were killed by Lendu individuals because of the alleged opposition of the FEC president to Lendu militias, or whether they were killed by Hema individuals.

Most of the sources interviewed by the Group referred to conflicts related to land and administrative limits between both communities as well as to the unresolved aftermaths of the 1999-2003 conflict. In this respect, a leader of an Hema IDPs camp told the Group that cohabitation between both communities could not exist anymore after this second wave of attacks and that anyone speaking about reconciliation was an enemy of the Hema community.

Après une relative accalmie, des attaques à plus petite échelle ont été perpétrées contre des positions des FARDC et des civils à partir de septembre 2018, en particulier sur les côtes du Lac Albert. D'après plusieurs sources, dont la MONUSCO, du 23 au 25 mai 2019 des attaques multiples ont visées la population Alur dans le territoire de Mahagi, au nord du territoire de Djugu, dans l'Ituri. Le 10 juin 2019, des individus non identifiés ont tué, à Zibiti, dans le territoire de Djugu, quatre hommes de la communauté Lendu, y compris le président de la Fédération des entreprises du Congo (FEC) de Kobu. Des attaques massives et simultanées contre les localités Hema ont débuté immédiatement après le même jour.

Les témoignages diffèrent sur la question de si les quatre hommes ont été tués par des individus appartenant à la communauté Lendu en raison de l'opposition alléguée du président de la FEC aux milices Lendu, ou par des individus appartenant à la communauté Hema.

La plupart des sources interrogées par le Groupe ont fait référence aux conflits fonciers et liés aux limites administratives entre les deux communautés ainsi qu'aux séquelles non résolues du conflit de 1999-2003. À cet égard, un leader d'un camp de déplacés Hema a dit au Groupe que la cohabitation entre les deux communautés était maintenant impossible après cette seconde vague d'attaques et que ceux qui parlaient de réconciliation étaient les ennemis de la communauté Hema.





#### Taxation of the Lendu population by Lendu militias

#### Taxation de la population Lendu par les milices Lendu

Based on eight independent sources, the Group found that the Lendu militias forced the Lendu population to financially contribute to the war effort in several areas. One Lendu source told the Group that on 15 September 2019 armed men, who introduced themselves as "Chief Ngudjolo" representatives and who explained that their stated goal was to expel the FARDC from Lendu's land, forced him to pay a 1,000 Congolese Francs tax. Every family in Ndr'li and Andri, close to Linga, had to pay that tax (see also annex 28 above).

According to another Lendu source, Ngudjolo movement taxed the population, controlled the markets around Lake Albert, Njalo and Jiba and took percentages on goods. The movement forced each village in the area to pay 35,000 Congolese Francs monthly, issuing receipts to the village chiefs (see receipt below). The movement also erected a barrier at Njalo requesting between 200 and 500 Congolese Francs per person. Two Lendu sources also told the Group that the militias looted the Lendu population.

Chaque famille de Ndr'li et Andri, près de Linga, a dû s'acquitter de cette taxe (voir aussi ci-dessus annexe 28).

D'après une autre source Lendu, le mouvement de Ngudjolo a taxé la population, contrôlé les marchés autour du Lac Albert, Njalo et Jiba et a pris des pourcentages sur les biens. Le mouvement a forcé chaque village de cette zone à s'acquitter de 35 000 Francs congolais par mois et a délivré un reçu aux chefs de villages (voir reçu cidessous). Le mouvement a aussi érigé des barrières à Njalo et y a demandé entre 200 et 500 Francs congolais par personne. Deux sources Lendu ont aussi dit au Groupe que les milices pillaient la population Lendu.
