# The Daily report of victims of human rights violations in Syria 21-5-2019

*SDF militia killed a child while dispersing a demonstration*

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Tuesday 21<sup>st</sup> May 2019 reached 4 people of whom two children.

In the province of Idlib, two people were killed, one of them due to the shelling of the town of Ma'rat Hurma and the other from his wounds due to the shelling of the city of Ma'arat al-Nu'man few days before.

In the province of al-Hasakeh, a girl died of her wounds due to shooting of SDF Kurdish militia in Khashman neighbourhood of Al-Hasakeh city.

In the province of Deir ez-Zor, a child was shot dead by SDF Kurdish militia while people were trying to resolve a dispute between two families in the town of Sudan Aljazeera.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Mohammed Khaled Omar / Idlib / due to the bombing of the regime forces Ma'arat Hurma.

2 – Abdel Hamid Al-Mahloul / Idlib / from wounds sustained a few days before due to the shelling of the city of Ma'arat al-Nu'man.

3- The child Helen Mahmoud Al-Sulabi / Al-Hasakeh – Khashman neighbourhood / from her wounds as being shot by SDF militia in the neighbourhood.

4- The child Ibn Omar al-Habash / Deir ez-Zor / due to being shot by SDF militia in the town of Sudan Aljazeera

# Daily report of victims of human rights violations in Syria 22-5-2019

*9 people were killed due to shelling of Ma'arat al-Nu'man*

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Wednesday, 22nd May 2019 reached 24 people of whom 5 children and 1 killed under torture.

In the province of Idlib, 20 people were killed due to the bombing of the cities and towns of the province. The victims were distributed as follows: 9 people in the town of Ma'arat al-Nu'man, 5 in the city of Sarqeb, and 2 in each of Ma'arat Hurma and Jesr al-Shughur and 1 each of the towns of Svohen and Mahambel.

In the province of al-Raqqa, two people were slaughtered by knives by unidentified assailants during grazing sheep in the town of Hamrat, which is under the control of SDF.

A person was killed due to a landmine explosion in al-Ummal district of Deir ez-Zor.

A person was also killed in the province of Aleppo under torture in the prisons of the LDPD militia a week after his arrest in the city of Manbej.

*Four people were killed due to bomb explosion in their house in Deir ez-Zor province*

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Thursday, 23rd May 2019 reached 14 people of whom 6 children, 2 women and 1 killed under torture.

In the province of Idlib, 9 people were killed, 8 of whom were killed by the shelling of the city of Kafranbel, the towns of Haysh, Kafroweid and Kafrsijneh, and 1 was killed under torture in a prison in the regime.

In the province of Deir ez-Zor, 5 people were killed, of whom 4 killed by a bomb explosion in a house in the desert town of Khasham, and one was killed in a landmine explosion in the town of al-Kashmeh.

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Friday, 24th May 2019 reached 9 people, including 4 children

In the province of Idlib 6 people were killed due to the Russian and Syrian regime bombardment of the city of Kafranbel and the towns of Hass and Mseibin.

In the province of Aleppo, two people were killed, one by a gang that kidnapped him and demanded a ransom and then tortured and killed him and the other from his wounds due to artillery shelling on the city of Hreitan.

In the province of Deir ez.Zor, one person was killed in a landmine explosion in Al-Ummal district of Deir ez.Zor city.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Rachid Hamid Khalil / Aleppo countryside – Afrin / killed by unknown persons and his body was found on the road leading to the village of Qustal Jendu.

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Saturday 25<sup>th</sup> May 2019 reached 7 people of whom a child and a woman.

In the province of Idlib, 3 persons were killed due to the shelling of Khan Shykhun, Kafranbel and al-Fatira.

One person was killed in the province of Hama due to the shelling of agricultural land in the vicinity of the city of Latamna.

One person was also killed in Daraa province by unknown assailants in Daraa al-Balad.

One person was also killed in the province of Aleppo due to the artillery shelling on the village of Birna.

And a person died in the province of Deir ez-Zor due to the collapse of a wall because of the strong winds in the city of al-Mayadeen.

The Syrian Human Rights Committee documented the names of the following victims:

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Sunday, 26<sup>th</sup> May 2019, reached 20 people of whom a child, a woman and a person killed under torture.

In the province of Idlib, 15 people were killed, of whom 14 due to the shelling of the following: 6 people in the town of Ma'rat al-Nu'man, 2 each in the towns of Sfuhen and Haysh, and 1 each in the villages of Sheikh Mustafa and Umm Zaytouna. One person was also killed by a roadside bomb in his car in the town of Ma'rat Misrin.

In the province of Hama, two people were killed due to the shelling of the town of Kafr Zita and the agricultural land surrounding Morek. One person was also killed in the town of Deir ez-Zor by unknown assailants in the town of Boqrus.

A person in Daraa province was shot dead by the regime's military security in Da'al city. A person from Latakia was also killed under torture in a regime prison.

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Monday 27<sup>th</sup> May 2019 reached 20 people of whom 9 children and 6 women.

In the province of Idlib, 19 people were killed in the bombing of the cities and towns of the province by the Russian and Syrian regime warplanes. The victims are distributed as follows: (11) people in the city of Ariha, 6 people in the town of Hazarin, and (1) in each of Ma'arat Hurma and Karsa'a.

In the province of Aleppo, a person was killed by a bomb whose source is unidentified in a house in the village of al-Dana, east of the city of Bab.

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Tuesday 28<sup>th</sup> May 2019 reached 32 people of whom 10 children, 9 women and 1 killed under torture.

In the province of Idlib, 16 people were killed, of whom 15 due to the bombing of the province's towns and villages by the regime forces. The victims were distributed as follows: 5 people in the town of Khan al-Saubul, 3 each in the towns of Sfohen and lhsem, and 2 each in the towns of Arafat and the city of Ariha. One person was also killed under torture in a prison for regime forces.

In the province of Aleppo, 14 people were killed, 13 of whom by the bombing of the province's towns and villages by the regime forces: 10 people were killed in the town of Kfer Halab and 1 each in the villages of al-Bawabiya and al-Barqoom. One person was also killed in the clashes between armed factions in Gindiris area in Afrin countryside.

In the province of Deir ez-Zor, 2 people were killed, one in a mine explosion in the town of Al-Bagoz and the other was killed by unknown gunmen in the town of Takihi.

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Wednesday, 29<sup>th</sup> May 2019 reached 21 people of whom 6 children and 7 women.

In the province of Idlib, 20 people were killed, of whom 19 in the bombing of the cities and towns of the province. The victims were distributed as follows: 7 in the town of Sarja and 3 each in the towns of Ihsem, Al Barra and Habeet, 2 in the town of Musibin and 1 in the town of Hazarin. A woman was also found dead and severely burnt on the road between the towns of Harim and Qalb-Luza.

In the province of Daraa, a person was killed by unidentified persons in the city of Tafas in the province southern countryside.
