Daily Report on the victims of human rights violations in Syria, 7/10/2019

The Syrian Human Rights Committee has documented a total of one people killed in Syria on Monday 7/10/2019.

One person from the province of Homs was killed under torture in Sednaya Military prison , after he was detained for a period of a year and a half, despite the victim having undertaken the necessary procedures to clear his name with the regime.

The Syrian Human Rights Committee documented the following name:

Hasan Muath Bakkour / Homs – Al-Houla / Died under torture in Sednaya Military Prison

The Syrian Human Rights Committee has documented a total of nine people killed in Syria on Wednesday 9/10/2019, amongst them two women and one person killed under torture.

In Aleppo province, two people were killed. One was killed due to a landmine explosion on the road leading to Jarez, and another was killed due to artillery shelling by the SDF Kurdish militia targeting a displaced camp close to Jarabulus.

In Idlib province, two people were killed due to rocket shelling on a farm in Al-Barnas in the countryside of Jisr al-Shughur city.

In Al-Raqqah province two people were killed due to shelling by Turkish air forces on the Al-Mutakalittah village, in the countryside of Tal al-Abyad town.

One person was killed in Al-Hasakeh province, due to artillery shelling by both the Turkish armed forces and the Syrian National Army on al-Qamishli city.

One person was also killed in the province of Deir ez-Zor by unknown forces in Al-Kubar town.

One person was also documented to have been killed under torture in Rif Dimashq province in a regime prison after almost a year of his detention.

The Syrian Human Rights Committee managed to document the following names:

1. Mohamed Haj Qader Abu Souzdar / Al-Raqqah – Al-Mutakalittah village / Killed due to Turkish air forces shelling the area

6. Akram Yousef Ali / Al-Hasakeh – Al-Qamishli / Killed due to artillery shelling by Turkish armed forces and the Syrian National Army on the city

The Syrian Human Rights Committee has documented a total of six people killed in Syria on Thursday 10/10/2019, amongst them one child.

In Al-Hasakeh province, three people were killed; two of whom were killed during a fire exchange between SDF militias and the Turkish Army in the cities of Qamishli and Ras Al-'Ain. In addition to one person being killed by an SDF sniper when as he attempted to flee his city of Ras Al-'Ain.

In Deir El-Zour province, two people were killed by unknown sides after being subjected to intense torture in the town of Al-Shuhayl.

In Daraa province, one person was killed from the town of Ibta, after he was kidnapped for several days and it is likely he was field executed by regime forces despite taking the procedures necessary to resolve his security situation.

The Syrian Human Rights Committee managed to document the following names:

1. Khateeb Soufi Hammi / Al-Hasakeh – Al-Qamishli / Killed due to an exchange of fires between SDF Kurdish militias and the Turkish Army.
2. Child – Mohammed Yousef Hussein / Al-Hasakeh – Al-Qamishli / Killed due to an exchange of fires between SDF Kurdish militias and the Turkish Army.
3. Khalaf Abd Al-Habloushi / Al-Hasakeh – Ras Al-'Ain / Killed by an SDF sniper.
4. Ahmed Mohammed Al-Kareen / Deir El-Zour – Al-Hara Village / Killed by unknown forces, his corpse was found in the central park of Al-Shuhayl town.
5. Kassar Faisal Obaid Al-Raja / Deir El-Zour – Al-Hara Village / Killed by unknown forces, his corpse was found in the central park of Al-Shuhayl town.
6. Ali Mohammed Aqailah Al-Nusayrat / Daraa – Ibta / Killed by bullet and his body was found inside a school.

The Syrian Human Rights Committee has documented a total of eight people killed in Syria on Friday 11/10/2019, amongst them one child.

In Al-Hasakeh province, six people were killed amongst them three who were executed by SDF militias after they refused to fight in their ranks, and three others were killed due to a loaded-car explosion in Al-Qamishli.

In the province of Idlib, one person was killed due to an unknown explosion in the city of Salqeen. One baby from the province of Homs was also killed by a mortar shell which targeted the city of Nusaybeen on the Turkish border, by SDF militias.

The Syrian Human Rights Committee managed to document the following names:

The Syrian Human Rights Committee has documented a total of seven people killed in Syria on Saturday 12/10/2019, amongst them one child and two women.

Four people were killed in Al-Hasakeh province, three of whom were field executed by Ahrar Al-Sharqiya rebel group, amongst them one woman. Another woman was killed by a Turkish Army sniper.

In the province of Deir El-Zour, one person was killed due to a landmine explosion in Abu Hamam town, and another was killed by an unknown bullet in Sweidan Al-Jazira town.

In Idlib province, one child was killed due to artillery bombardment by the Syrian regime on Kafr Roma village.

The Syrian Human Rights Committee managed to document the following names:

The Syrian Human Rights Committee has documented a total of 13 people killed in Syria on Sunday 13/10/2019, amongst them one woman and one person killed under torture.

In Al-Raqqah province, six people were killed amongst them three people killed by the YPG in Abu Karaya village due to their refusal in handing their car to the militia. Three others were killed due to a tow missile targeting their car by SDF militias, in Al-Ghazali village.

In Aleppo province, four people were killed due to a rocket targeting their car by SDF militias between Al-Mahsanli village and Arab Hasan.

In Al-Hasakeh province two people were killed due to shelling from the YPG targeting Al-Duwairah village in Ras Al-'Ain. In addition to one person being killed under torture in a regime prison, in Daraa province.

The Syrian Human Rights Committee managed to document the following names:

1. Aziz Hasan Al-Hamady / Al-Raqqah / Killed by a YPG bullet
2. Mahmoud Hasan Al-Hamady / Al-Raqqah / Killed by a YPG bullet

The Syrian Human Rights Committee has documented a total of seven people killed in Syria on Monday 14/10/2019, amongst them three children and two women.

In Idlib province three people were killed, amongst them a child and mother due to rocket shelling by the Syrian regime, targeting Al-Baarah village. Another woman was killed by Turkish border police (Jandarma) when she attempted to cross the border into Turkey.

In Deir El-Zour province two people were killed, one of which was killed by unknown forces in Al-Shuhayl city, the other was field executed in Al-Jarthy town by YPG militias.

One child was killed in Al-Raqqah province due to shelling by the Syrian regime which targeted Ain Issa camp. Another child was killed in Al-Hasakeh province by unknown forces, and was found with a bullet to the head in a farm near Al-Mushayrifah neighbourhood.

The Syrian Human Rights Committee managed to document the following names:

1. Safaa Tareef Abu Bakr / Idlib – Ram Hamdan village / Killed by a Turkish Jandarma bullet when attempting to cross the border
2. Child, Aamaal Mohamed Ali Al-Dibs, 10 years old / Deir Al-Zour – Alboukamal / Killed due to shelling by the regime on 'Ain Issa camp
3. Child, Omar Mohamed Bakkara, 14 years old / Al-Hasakeh – Al-'Amiriyeh village / Found with a bullet to his head in Al-Hasakeh province
4. Child, Mohamed Mousa Al-Skaf / Idlib – Al-Baarah / Killed due to shelling on the town
5. Intisar Al-Raheem / Idlib – Al-Baarah / Killed due to shelling on the town

The Syrian Human Rights Committee has documented a total of four people killed in Syria on Sunday 27/10/2019, amongst them two children.

In the province of Idlib two people were killed, one of which was a child who was killed by artillery shelling on the town of al-Janoudiyah, the other died due to wounds caused by a previous shelling on the same town in Jisr al-Shughour.

One person was executed in the province of al-Raqqa in an attack on SDF militias on the village of Kafeefa. One child was killed in the province of al-Hasakeh due to a mine explosion left by Kurdish militias in Al-Shirkah village, south of Ras Al-'Ain city.

The Syrian Human Rights Committee managed to document the following names:

1. Ammar 'Aleyko / Idlib / died due to wounds caused by a previous shelling on al-Janoudiyah
2. Child, Bashar Sh'aar / Idlib / killed by artillery shelling on the town of al-Janoudiyah
3. Mustafa Al-Hussein / al-Raqqa – Kour Hasan village / killed in an attack on SDF militias on the village of Kafeefa

After Russian warplanes strike

The total number of victims documented by the Syrian Human Rights Committee on Tuesday 5-11-2019 reached 7 people of whom 3 children and 2 person killed under torture

In Idlib province, 3 children were killed due to the Russian shelling that targeted Al-Kabira town in the southern countryside.

In Rif Dimashq, 2 people died under torture. One was arrested from a shelter in Misraba town and the other was killed in Sednaya Military Prison and he was arrested despite settling his security situation with the regime authorities.

One person was killed in al-Hasakeh province by a landmine explosion in the town of Markada and one person in Deir ez-Zor province by unidentified persons in Thiban town.

SHRC has documented the names of the following victims:

1 – Ibrahim Mohammed Mahjoub / al-Hasakeh / by a landmine explosion in the town of Markada.

- 2 – Ali al-Lahham / Rif Dimashq – Misraba / killed under torture in one of the regime's prisons
- 3- Rateb Al-Mubakher / Rif Dimashq – Irbeen / He was killed under torture in Sednaya Military Prison despite settling his security situation with the regime.
4. 'Abdul' Awad al-Majid / Deir ez-Zor, killed by unknown assailants in the market of Theban town.

The total number of victims documented by the Syrian Human Rights Committee on Wednesday 6-11-2019 reached 11 people of whom 2 children and 1 woman.

In Aleppo province, 8 people, including 2 children and a woman, were killed in a Russian warplanes strikes that targeted the town of al-Sahara in the western countryside

In Idlib province, 3 people were killed, 2 due to shelling on Jisr al-Shughur city, and one person was killed in a bomb explosion left in the city of Ma'arat Al-Nu'man.

The total number of victims documented by the Syrian Human Rights Committee) on Thursday, 7-11-2019 reached 11 people including 3 children and 1 woman.

In Idlib province, 10 people were killed, of whom 4 killed by HTS when they stormed Kafr Takharim city, 3 people were killed due to Russian shelling on Rami village and Kfr Roma, 2 people were killed due to regime forces shelling in Meshmishan village, and 1 person was killed by a landmine explosion at Umm Jalal Village.

One person was also killed in Hama province due to shelling by regime forces that targeted al-Hawash village in the province western countryside.

SHRC has documented the names of the following victims:

Russian shelling on al-Dar al-Kabira

The total number of victims documented by the Syrian Human Rights Committee in Syria on Friday, 8/11/2019 reached 8 people, including: 4 children and 1 woman.

In Idlib province, 5 people were killed, four of them by the Russian shelling on al-Dar al-Kabira town, al-Rami village and traveling Bedouin camp near al-Nairab town.

In Aleppo province, 4 people were killed, three of them by a car bomb in Al-Ra'i town, and one person was shot dead by SDF militia in al-Jaryat village.

In al-Hasakah, two people died, one due to a landmine explosion in al-'Arishah town, and the other due to lack of health and medical care in al-Houl camp, which is under the control of the SDF militia.

One person died in Deir ez-Zor province when a bomb exploded in Hawi al-Baghrouz town.

In Idlib province, 3 people, including 2 children, were killed by previous shelling on Mardikh village.

In Deir ez-Zor province a woman was killed by indiscriminate gunfire in Shuhail.

A child was also killed in Daraa province due to an explosion of a landmine left by regime forces on Ibta'a town.

SHRC has documented the following victims:

Car bomb explosion in al-Raqqa

The total number of victims documented by the Syrian Human Rights in Syria on Sunday 10-11-2019, reached 19 people including 3 children and 1 person killed under torture.

In Idlib province, 8 people were killed, 7 by Russian bombardment of Kfr Roma town, and 1 by Russian bombardment of Sheikh Mustafa village.

In al-Raqqa province, 8 people were killed when a car bomb exploded near al-Jabri Bakery in Sluk town.

Two persons were killed by unknown persons, one in Abu Hardoob town in Deir Ez-Zorr province, and the other was found near Qaita junction in Daraa province.

One person from Quneitra province was killed under torture in Sednaya prison, despite his security situation being settled with the regime authorities.

SHRC has documented the following victims:

The total number of victims documented by the Syrian Human Rights Committee in Syria reached (15) persons on Monday 11/11/2019, including (4) children and (3) women.

In al-Hasakeh province, 7 people were killed, including 6 who were killed in a double bombing in al-Qamishli, and 1 person was killed by a landmine in Ras al-Ain.

In Deir ez-Zor province, 5 people were killed, including 2 by ISIS operatives in al-Zir village, 1 was also killed by ISIS in Theban town on charges of belonging to the SDF, a child was killed under torture by electricity by a neighbour, and a person was killed by unknown people in the village of Daranj, which is controlled by the SDF militia.

In Idlib province, 2 persons were killed as a result of shelling on the towns of Kfroma and Bisqla.

A child was also killed in Aleppo province when a rocket hit their house in Saif Al-Dawla neighbourhood in Aleppo city.

SHRC has documented the following victims:

The total number of victims documented by the Syrian Human Rights Committee (SHRC) in Syria on Tuesday 12-11-2019 reached 15 people, including 2 children and 2 women.

In Idlib province, 11 people were killed, 8 of them by Russian bombardment of Kafranbel city and Shanan town, and 3 by artillery shelling in Ma'aret Hurma town.

In al-Raqqa province, 3 people were killed, 2 of them by landmines in Ai'wa and Jern al-Maez villages in Tal Abyad countryside.

In al-Hasakeh, one person was killed by a landmine in Umm al-Khair village.

SHRC has documented the following victims:
