COI QUERY RESPONSE - BANGLADESH - INFORMATION ON OPPRESSION AND/OR THEFT OF GOODS AND ASSETS OF BNP POLITICAL PARTY SUPPORTERS BY AWAMI POLITICAL PARTY MEMBERS.

The Office of the United Nations High Commissioner for Human Rights (OHCHR) in March 2024 points out that: "On 25 May 2023, when the Awami League attacked a BNP procession in South Keraniganj, Dhaka, at least 50 leaders and activists, including BNP's central leader Nipun Roy Chowdhury, were injured in the clash. However, the police filed a report against more than 500 members of BNP. The police fired rubber bullets and tear gas shells at the main opposition BNP supporters on 29 July 2023, leaving dozens of its supporters injured during anti-government protests. The violence broke out as the opposition party organised sit-in protests at all the entry points to Dhaka. The police and ruling Awami League members attacked road marches organised by BNP in different districts on 20 August 2023, resulting in more than 100 injured people while pressing their demand for party chief Khaleda Zia's release from her house arrest and for her to be taken abroad for treatment."

A report issued by *Human Rights Watch* in January 2024 states that: "The Awami League-led government of Prime Minister Sheikh Hasina arrested over 8,000 leaders and supporters of the opposition Bangladesh Nationalist Party (BNP) ahead of the elections, in an overt attempt to incapacitate the competition and disqualify opposition leaders from participating. Many were allegedly "disappeared" when police arrested and kept them in unlawful detention for days or weeks before eventually producing them in court."²

International Federation for Human Rights (FIDH) in January 2024 mentioned that: "In the lead-up to the election, the authorities arrested thousands of BNP members and supporters and filed politically-motivated cases against them. From 1 August to 31 December 2023, at least 1,724 opposition leaders and activists, mostly from the BNP, were detained and sentenced to jail terms by courts in Dhaka. According to opposition figures, between 28 October and late December 2023, 23,460 opposition leaders, members, and supporters had been arrested, and 684 cases had been

filed against them. There have also been reports of detained opposition activities being tortured and subjected to inhuman and degrading treatments while in prison. At least nine opposition activists have died in prisons while in arbitrary detention since 25 November 2023."³

The document further points out that: "BNP leaders, members, and supporters have continued to face a crackdown even after the party's decision to boycott the upcoming polls." ⁴

Odhikar (Bangladesh) in January 2024 reported that: "Awami League members have been involved in attacking BNP leaders and activists, as well as vandalizing their residences. Additionally, there have been reports of ruling party members vandalizing and setting fire to BNP's party offices and business establishments owned by BNP supporters"⁵

A report issued by *Human Rights Watch* in November 2023 states that: "Bangladesh authorities are targeting opposition leaders and supporters ahead of the general elections slated for January 7, 2024."⁶

The same report mentioned that: "Senior government leaders, including Prime Minister Sheikh Hasina, have fueled ongoing violence through public statements encouraging attacks on opposition protesters. On November 3, she told her Awami League party supporters that if they catch anyone committing arson to "throw [them] into the same fire. The hand that sets fire to anything will have to be burnt ... tit for tat. If so, they would learn lessons." Videos and witness reports show disturbing evidence of coordination between the police and the Awami League supporters in threatening and targeting opposition party activists. "People are scared to come out of their homes because the police and Awami League activists are in the street," said a BNP supporter." ⁷

The Coalition for Human Rights and Democracy in Bangladesh (CHRD Bangladesh) in November 2023 reported that: "The Coalition for Human Rights & Democracy in Bangladesh (CHRD Bangladesh) condemns once again the continued brutal treatment of the political opposition, particularly the Bangladesh Nationalist Party (BNP) and the Jamaat-e-Islam (JeI), by the autocratic regime of Prime Minister Sheikh Hasina, illegally in power since 2009 by repeated election fraud and by keeping the opposition out of the polling booths."

The same document points out that: "The current phase of political oppression started on October 28, 2023 when BNP's pre-announced rally, attended by about one million supporters in Dhaka was ruthlessly crushed." [...] 9

In October 2023 *Odhikar* (Bangladesh) reported that: "On 28 July 2023, thousands of the main opposition Bangladesh Nationalist Party (BNP) supporters joined sit-in programmes at the entry points of Dhaka demanding the resignation of the government and for a neutral caretaker administration to oversee the upcoming parliamentary elections. The following day, police cleared thousands of protesters and fired rubber bullets and teargas to disperse the crowds blockading the main roads in Dhaka. There were allegations of police and ruling party supporters, who were carrying sticks and rods in the presence of police, attacking protesters. According to the BNP, 600

supporters were injured by police rubber bullets and attacks by the ruling party supporters. Police filed at least 13 cases against 628 named BNP leaders and activists and many unnamed persons, following attacks and clashes between BNP supporters and law enforcers, who teamed up with ruling party activists. However, Awami League supporters, who were seen attacking opposition members with sticks, rods and hammers, were neither arrested nor charged."¹⁰

In September 2023 *Voice of America News* states that: "Hundreds of thousands of leaders, activists and supporters of the Bangladesh Nationalist Party (BNP), the country's largest opposition party, have faced "fictitious" charges of violence, party leaders allege."¹¹

The document further mentioned that: "BNP leaders allege their political rallies are being attacked by the police and armed Awami League activists, and that their leaders and supporters are being set up on spurious charges of violence and sabotage." ¹²
