

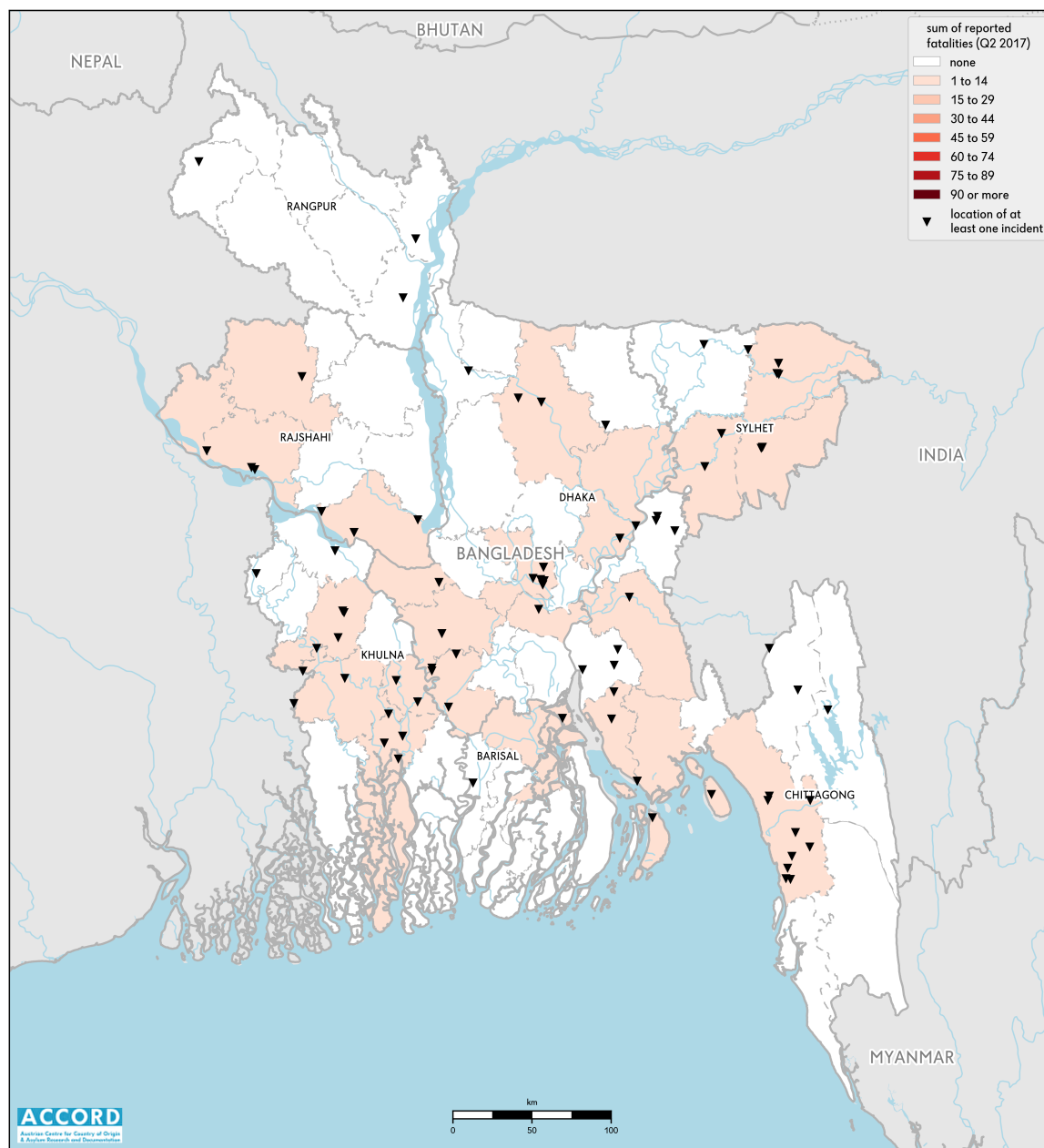

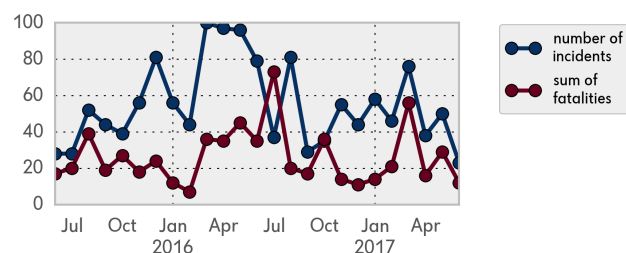

LOCALIZATION OF CONFLICT INCIDENTS

Note: The following list is an overview of the incident data included in the ACLED dataset. More details are available in the actual dataset (date, location data, event type, involved actors, information sources, etc.). In the following list, the names of event locations are taken from ACLED, while the administrative region names are taken from GADM data which serves as the basis for the map above.

Administrative divisions (based on GADM data) are reflected as of before the creation of Mymensingh division.

In **Barisal**, 2 incidents killing 1 person were reported. The following locations were affected: **Bausia, Pirojpur**.

In **Chittagong**, 31 incidents killing 6 people were reported. The following locations were affected: **Banshkhali, Baraitali, Bijoy Nagar, Chandanaish, Chandpur, Chittagong, Hathazari, Haziganj, Jobra, Kachua, Kalipur, Khagrachari, Lakshmipur, Langadu, Patiya, Rahimpur, Ramganj, Ramgati, Rangunia, Sandwip, Sarail, Sukh Char**.

In **Dhaka**, 36 incidents killing 18 people were reported. The following locations were affected: **Bhairab Bazar, Boshila, Dhaka, Goalandaghat, Gopalganj, Jamalpur, Kashiani, Kasiani, Motijheel, Muksudpur, Muktagacha, Mymensingh, Raipura, Rajnagar, Ramna, Saltha, Shahbagh, Sirajdikhan, Tongi**.

In **Khulna**, 19 incidents killing 13 people were reported. The following locations were affected: **Benapole, Daulatpur, Dumuria, Jessore, Jhenaidah, Kalia, Kaliganj, Khulna, Kushtia, Meherpur, Modonpur, Narail, Phultala, Satkhira**.

In **Rajshahi**, 9 incidents killing 12 people were reported. The following locations were affected: **Bera, Godagari, Ishwardi, Pabna, Rajshahi, Sherpur, Shibganj**.

In **Rangpur**, 3 incidents killing 0 people were reported. The following locations were affected: **Baliadangi, Gaibandha, Ulipur**.

In **Sylhet**, 11 incidents killing 7 people were reported. The following locations were affected: **Chhatak, Habiganj, Moulvibazar, Nabiganj, Osmani Nagar, Sunamganj, Sylhet**.

METHODOLOGY

The data used in this report was collected by the Armed Conflict Location & Event Data Project (ACLED). ACLED collects data on reported conflict events in selected African and Asian countries, Bangladesh being among them. ACLED researchers collect event data from a variety of sources and code them by date, location, agent, and event type. Based on these data, the Austrian Centre for Country of Origin & Asylum Research and Documentation (ACCORD) compiles updates on conflict incidents. Geographic map data is primarily based on GADM, complemented with other sources if necessary. ACLED's location data is then used to locate incidents in these maps. Incidents that could not be located are ignored. The numbers included in this overview might therefore differ from the original ACLED data.

Incidents comprise the following categories: battle, headquarters or base established, non-violent strategic activities, riots/protests, violence against civilians, non-violent transfer of territory, remote violence. For details on these categories, please see
