Daily report of victims of human rights violations in Syria 15-10-2018

Sham Liberation Org. dashed into Ain Laruz

The total number of victims SHRC was able to document in Syria on Monday 15/10/2018, reached 6 persons including one who died under torture.

In the province of Raqqqa, 4 people were killed in the explosion of their car while they were driving near Bi'r Al-Hashim in the northern countryside.

In the province of Idlib a “person” was killed in the town of Ain Laruz due to the heavy fire by the Sham Liberation Organization, which broke into the town.

A person from Hama province was also tortured to death in the regime prisons after seven years in prison.

The Syrian Human Rights Committee documented the names of the following victims:

1- Mustafa Fares Qantar 70 years / Idlib-Ain Laroz / by the Sham liberation Organisation when they stormed the town.

2 – Tariq Mahmoud al-Othman / Hama – Murek / under torture in the regime prisons after 7 year detention.

The total number of victims SHRC was able to document in Syria on Tuesday 16/10/2018, reached two persons, one of them a woman.

In the province of Homs, a woman was killed in al-Rukban camp on the Syrian-Jordanian border after suffering from severe malnutrition and low health care in the camp.

in the province of Raqqqa, a person was killed in the explosion of a landmine left by ISIS before withdrawing from the city of Raqqqa.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Basma Ahmed Zaarour / Homs -Miheen / due to lack of health care in the camp Rukban

2 – Mohammed al-Ali / Raqqqa / in the explosion of a landmine left by ISIS before leaving the city.

The total number of victims SHRC was able to document in Syria on Thursday, 18-10-2018 reached 9 persons.

In the province of Deir ez-Zor (5) people were shot dead by ISIS in the town of Shoufah on charges of dealing with the Kurdish militia of SDF.

In the province of Hama, bodies of 4 people were found at the outskirts of Kafr Zita in a state of disintegration indicating their death more than a year ago. The cause of their death has not been specified.

The US led International Coalition against ISIS wages air strikes against civilian targets

The total number of victims SHRC was able to document in Syria on Friday 19/10/2018, reached 7 people including a child and a woman.

In Idlib province, 3 persons were killed, including two persons whose bodies were found in the town of Ma'rat Misrin north of Idlib and a woman who was shot by unidentified persons in the city of Sarmin.

In the province of Aleppo, two persons, including a child, were killed as a result of clashes that took place between armed men in Shamarakh camp north of Aleppo and another one was shot by unidentified gunmen in the city of Darat Azzah.

In the province of Deir ez-Zor, two persons were killed, one of them by the bombing of international coalition aircraft on the town of Sousseh and the other was found dead and handcuffed in the desert between Granige and al-Kashkia.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Atta Ahmed Flees / Aleppo countryside – Darta Azzah / after being shot by unknown persons in the city.

2 – Mohammed Zia Abdul Latif Al-Dibs / Deir ez-Zor / Following raids by the international coalition aircraft on the town of Sousse countryside, the city of Al-Bokmal.

The total number of victims SHRC was able to document in Syria on Saturday 20-10-2018 reached 2 persons.

In the province of Idlib, a displaced person was kidnapped in the evening in front of his house in Sarmin. His dead body was found the next morning.

A “person” in the province of Raqqa also shot dead by the Kurdish militia of SDF at one of its checkpoints, where they shot him and did not help him until he died.

The Syrian Human Rights Committee documented the names of the following victims:

The total number of victims SHRC was able to document in Syria on Sunday, 21-10-2018, reached 46 people including 12 children, 4 women and 1 under torture.

In the province of Deir ez-Zor, 41 people died after two air strikes of the international coalition aircraft targeted the town of al-Suseh in the countryside of Albokmal on Thursday, 18-10-2018 and Friday, 19-10-2018, and the information was not available until late because of the region under ISIS control and it was difficult to reach the accurate number of victims.

In the province of Idlib, 5 people were killed, 3 of them in a car bomb explosion in al-Qusour neighbourhood in Idlib city, 1 in a bomb explosion in the city of Jisr al-Ashughur, and 1 under torture in the prisons of the regime forces.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Ahmed Abdel Rahman Omar / Idlib / by a car bomb in al-Qusour neighbourhood in the city of Idlib

2 – Yamen Shabib / Idlib / by a car bomb explosion in al-Qusour neighbourhood of palaces in the city of Idlib

The total number of victims SHRC was able to document in Syria on Wednesday, 10-24-2018, reached 5 persons including one child.

In the province of Idlib, two people died in clashes between Sham Liberation on the one hand and the National Liberation Front on the other side in the town of Jarjnaz in the eastern countryside.

In the province of Daraa, two people died following the explosion of a landmine left by the regime forces in the town of al-Teeha in the northern countryside.

In the province of Aleppo, a girl was killed by heavy rocket fire by the regime forces targeting the town of Kafr Hamra before midnight.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Jana Khaled Teet , girl of 6 years / Aleppo province / as a result of the rocket fire on the town of Kafr Hamra.

2 – Alaa' Khaled Al-Halheel / Daraa – al-Teeha / in the explosion of a landmine left by the regime forces

3. Khalid Mohammed Al-Halheel / Daraa – al-Teeha / in the explosion of a landmine left by the regime forces.

In the province of Rif Dimashq, 2 brothers were tortured to death in the regime prisons.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Fayyad Fatteh / Rif Dimashq – Daraya / under torture in the regime prisons.

2 – Hussein Fatteh / Rif Dimashq – Daraya / under torture in the regime prisons.

In the province of Deir Ezzor (6) people were killed , including (5) in the bombing air strikes of the international coalition which targeted the area of Bobdran in the town of Sousseh, and (1) died by unknown gunmen are likely to be ISIS in the town of Jorzi.

In the province of Homs, a one-year-old boy died in Al-Rukban camp on the Syrian-Jordanian border because of his suffering from diarrhea for over a week and the lack of medical care in the besieged camp.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Rajab al-Hasan / Die Ezzor / due to the bombing of the international coalition aircraft on the town of Sousse

In the province of Aleppo, a woman was killed by shrapnel from an explosive bullet hit her in the heart during a clash between two popular committees as she passed through al-Furqan neighbourhood.

A person was also killed in Deir Ezzor province due to the bombing of the international coalition's air force on al-Shu'fah town.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Fathiya Ghiyath Barakat / Aleppo – Al-Furqan district / with shrapnel of explosive bullets in the neighbourhood of unknown source.

The total number of victims SHRC was able to document in Syria on Monday, 29 October 2018 reached 11 people, including a child and a man died under torture.

In the province of Aleppo (5) persons died, including three in the explosion of an explosive device on Al Azraq Road at the outskirts of Al Bab city, another one in a landmine explosion left by the Kurdish militias in the countryside of Afrin and one by artillery shelling on the town of Hayyan.

In the province of Deir Ezzor, 4 people were killed, three of them shot by the regime forces in Al Joura neighbourhood, and one was executed by unknown persons and his body was found at Hawija Alkashkia.

In the province of Raqqa, a girl died due to lack of medical care in Ein Issa camp, which is overseen by the Kurdish SDF militia.

A person from Hama province was also tortured to death in the regime prisons.

The Syrian Human Rights Committee documented the names of the following victims:

1- The daughter of Sabri al-Hajj Ajil al-Dbs from the town of Al-Bokmal died due to the lack of medical care in Ein Issa camp

2 – Qutaiba Mohammed Hakoush from Khirbet al-Naqus village in Sahl Al Ghab died under torture in Assad's prisons after three years of detention..

3 – Ibrahim al-Alo 22 years / Aleppo province / in a bomb explosion on the outskirts of Al Bab city.

4 – Walid Hawash / Aleppo province / because of artillery shelling on the town of Hayyan

In the province of Raqqa, one person was shot dead by the militia of SDF on Al Qitar Road north of Raqqa.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Najm al-Jasham / Raqqa / by the militia of SDF north of Raqqa city

2. Khalif al-Huwaiti, 34 old, from Deir Ezzor. His body was found in a water tank where he was killed a month and a half in the town of Al-Bagouz while he was trying to pull one of the bodies

In the province of Idlib (9) people were killed, including (8) in the city of Jarjanaz following a bombardment by the regime forces, and (1) shot by Turkish border guards while trying to infiltrate into Turkey.

In the province of Hama, a person was tortured to death in a regime prison after nearly six years of detention.

In the province of Raqqqa, a person shot by ISIS in Annour Street.

A person in the province of Daraa also died due to a mine explosion left by the regime forces in the vicinity of Dael.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Hasan al-Akhras / Idlib- Jarjanaz / because of the artillery shelling on the town by the regime forces

2) Mustafa Rzouq Al-Khattoun / Hama suburb – Soran / as a result of artillery shelling on the town of Jarjanaz

In the province of Homs, two people died in Al-Rukban camp, one of them a newborn child due to the lack of health care in the camp on the Syrian-Jordanian border.

In the province of Raqqah, a person was killed in a car bomb explosion on Al Nour Street.
