Article 135 - If someone drinks liquor several times and punishment is enforced on him after each drinking, he will be killed the third time.

Article 136 - If the one condemned to Had [whipping] becomes lunatic or apostate, his punishment will not be quashed.

CONDITIONS FOR THE QUASH OF PUNISHMENT OF ITS PARDON

Article 137 - If the liquor-drinker repents before the giving of testimony, his punishment will be quashed. However, if he repents after the giving of testimony, his punishment will not be quashed.

Article 138 - If someone repents after making confession to having taken liquors, the judge may either pardon him or enforce punishment on him.

CHAPTER THREE PUNISHMENT FOR SODOMY

Article 139 - Sodomy is sexual intercourse with a male.

Article 140 - In case of sodomy both the active and the passive persons will be condemned to its punishment.

Article 141 - Punishment for sodomy is killing; the Sharia judge decides on how to carry out the killing.

Article 142 - Sodomy involves killing if both the active and

passive persons are mature, of sound mind and have free will.

Article 143 - If a mature man of sound mind commits sexual intercourse with an immature person, the doer will be killed and the passive one will be subject to Ta'azir [lesser punishment] if not under duress.

Article 144 - If an immature person commits sexual intercourse with another immature person, both of them will be subject to Ta'azir [lesser punishments] unless one of them was under duress.

WAYS OF PROVING SODOMY IN COURT

Article 145 - By confessing four times to having committed sodomy, punishment is established against the one making the confession.

Article 146 - A confession is valid only if the confessor is mature, of sound mind, has free will and intention.

Article 147 - A confession made less than four times [to having committed sodomy] does not involve punishment of Had but the confessor will be subject to Ta'azir [lesser punishments].

Article 148 - Sodomy is proved by the testimony of four righteous men who must have observed it.

Article 149 - If less than four righteous men testify, sodomy is not proved and the witnesses shall be condemned to punishment for Qazf [malicious accusation].

Article 150 - Testimony of women alone or together with a man does not prove sodomy.

Article 151 - The Sharia judge may act according to his own knowledge which is derived through customary methods.

Article 152 - Punishment for Tafhiz (17) [the rubbing of the thighs or buttocks] and the like committed by two men without entry, shall be hundred lashes for each of them.

Note: If the doer is a non-Muslim and the subject is a Muslim, the doer will be condemned to death.

Article 153 - If Tafhiz and the like are repeated three times, without entry and punishment is enforced after each time, the punishment for the fourth time would be death.

Article 154 - If two men not related by blood stand naked under one cover without any necessity, both of them will be subject to Ta'azir [lesser punishments].

Article 155 - If someone kisses another without lust, he will be subject to Ta'azir.

Article 156 - If the one committing Tafhiz and the like or a homosexual man, with or without intercourse, repents before the giving of testimony by the witnesses, his punishment will be quashed; if he repents after the giving of testimony, the punishment will not be quashed. If it is proved by confession and thereafter he repents the Sharia judge may pardon him.

LESBIANISM

Article 157 - Mosaheqeh [lesbianism] is the homosexuality of women by genitals.

Article 158 - The ways of proving lesbianism in court are the same by which the homosexuality [of men] is proved.

Article 159 - Punishment for lesbianism is hundred (100) lashes for each party.

Article 160 - Punishment for lesbianism will be established vis-a-vis someone who is mature, of sound mind, has free will and intention.

Note: In the punishment for lesbianism there will be no distinction between the doer and the subject as well as a Muslim or non-Muslim.

Article 161 - If the act of lesbianism is repeated three times and punishment is enforced each time, death sentence will be issued the fourth time.

Article 162 - If a lesbian repents before the giving of testimony by the witnesses, the punishment will be quashed; if she does so after the giving of testimony, the punishment will not be quashed.

Article 163 - If the act of lesbianism is proved by the confession of the doer and she repents accordingly, the Sharia judge may pardon her.

Article 164 - If two women not related by consanguinity stand naked under one cover without necessity, they will be punished to less than hundred (100) lashes [Ta'azir]. In case of its repetition as well as the repetition of punishment, hundred (100) lashes will be hit the third time.

PUNISHMENT FOR PIMPING

Article 165 - Pimping means that someone brings two individuals together or puts them in contact with each other for fornication or homosexuality.

Article 166 - Pimping is proved by two confessions if the confessor is mature, of sound mind, has free will and intention.

Article 167 - Pimping is proved by the testimony of two righteous men.

Article 168 - Punishment for pimping is seventy (70) lashes and exile from the place of [his] domicile the period of which is determined by the judge.

Note: Punishment of pimping by a woman is seventy five (75) tashes only.

PUNISHMENT FOR QAZF

Article 169 - Qazf [malicious accusation] means that someone associates fornication or sodomy to a certain person.

Article 170 - Punishment for Qazf [malicious accusation] is
