The Daily report of victims of human rights violations in Syria 16-8-2019

17-AUGUST-2019 BY SHRC_ADMIN



The total number of victims documented by the Syrian Human Rights Committee in Syria (20) on Friday 16th August 2019 reached 20 people including 8 children, unborn baby, and 4 women.

In Idlib province, 20 people were killed, 16 of them by Russian air strikes targeting a camp for displaced people in Hama countryside near the town of Hass, and three people due to shelling in Ariha city, Hayesh village and al-Ghudfa town, and one person was killed by unknown persons. His body was found on the road between Al-Rami and Kafr Haya

The Syrian Human Rights committee has documented the following victims:

The total number of victims documented by the Syrian Human Rights Committee in Syria on Tuesday 20th August 2019 reached 10 people including three children.

In Idlib province, (7) people were killed due to the Russian-Syrian regime shelling on the cities of Ariha, Ma'rat Al-Nu'man, Ma'rshmarin, Al-Tah, Al-Ghudfa and Benin villages.

Two people died in Hama province, one of them by stray bullets in the city of Hama and the other affected by his wounds in al-Ghab Plain.

In Aleppo, one person was killed by artillery shelling on Kafr Hamra town.

The Syrian Human Rights Committee has documented the following victims:

The total number of victims documented by the Syrian Human Rights Committee in Syria on Wednesday 21st August 2019 reached 12 people, including 4 children, 2 women and 1 killed under torture.

In Idlib province, 10 people were killed, 7 of whom by shelling on the towns of Ma'arshamarin, Telmens and Deir Al-Gharbi and Al-Bashiriya villages.

In Deir Ez-Zor, 2 people were killed, one by shrapnel from a shell fired by a SDF checkpoint near Bir al-Sayyad, and the other under torture in a regime prison.

The Syrian Human Rights Committee has documented the following victims:

In Idlib province, 5 people were killed, three of them were killed by the Russian shelling on the village of Deir al-Gharbi.

In Deir ez-Zor province, one person was shot dead by unknown gunmen in Abu Hamam town in the province eastern countryside

In Aleppo, one person was killed by artillery shelling in the village of Al-Bawabiya.

In Daraa province, one person died under torture in a regime prison after a year of detention.

The total number of victims documented by the Syrian Human Rights Committee in Syria on Sunday 25th August 2019 reached 12 people including 3 children and 2 women.

In Idlib province, 9 people were killed due to the shelling on the towns of Talmens, Ma'rshourin, and the villages of Fagee 'and Al-Halba.

In Deir ez-Zor province, two people died in ISIS prisons where they were executed.

In Aleppo, one person was shot dead after being kidnapped from the province countryside.

Ma'arat al-Nu'man under the Russian and Syrian regime air strikes

The total number of victims documented by the Syrian Human Rights Committee in Syria on Monday 26th August 2019 reached 21 people including 3 children and 3 women.

In Idlib province, 19 people were killed due to the shelling on the cities and towns of the province. The victims were distributed as the following: 6 people in Kafranbel city, 4 people in Basiqla town, 3 persons each in Kafr Owaied and Abdeita, 2 persons in Kafr Sijna town and 1 person in Ma'art Horma town.

In Deir ez-Zor province, one person was killed by unidentified gunmen in Hawaij village.

In Al-Raqqqa, one person died in a car bomb explosion in Al-Tabqa.

The Syrian Human Rights Committee has documented the following victims:

The total number of victims documented by the Syrian Human Rights Committee in Syria on Tuesday 27th August 2019 reached 11 people, including 2 children and 2 women.

In Idlib province, 7 people were killed due to the shelling on Kafranbel city and the towns of Ma'arshmarin, Ma'arshamsha and Telmens.

In Aleppo province, 3 people were killed, two of them by an explosive device in a bus on the Azaz-Kfarkalbeen road, and one person was killed by an armed robbery who broke into his house in Afrin city.

In Deir ez-Zor province, one person was shot dead by unknown assailants in the town of Baghouz in Albukamal countryside.

The Syrian Human Rights Committee has documented the following victims:

Score of children were massacred by the Russian and regime warplanes in Ma'arat al-Numan

The total number of victims documented by the Syrian Human Rights Committee in Syria on Wednesday 28th August 2019 reached 20 people, including 10 children and 2 women.

In Idlib province, 19 people were killed due to the shelling on the cities and towns of the province, where the shelling was distributed as follows: (14) people in Ma'rat al-Nu'man city, (2) in Ma'asran town, and (1) in each of Al-Taman'a, Jarjanaz and Ma'arshamsha towns.

In al-Hasakeh province, one person died in a car bomb explosion in the centre of the city of Shadadi.

In Idlib province, 7 people were killed, 4 due to the shelling on Ma'arshamsha town, and 3 by the Russian shelling on al-Tah town.

In Deir ez-Zor province, one person died due to clashes between the people of Qusayba and Matab al-Burashid because of a dispute over the border between the two villages.

In Idlib province, 5 people were killed, 4 of them due to the shelling on Kafranbel city and Jabala town, and a person was killed by a cluster bomb left over from the shelling of the village of Tal Touqan.

Soran city – Hama province

The total number of victims documented by the Syrian Human Rights Committee in Syria on Saturday 31st August 2019 reached 10 people including a child, a woman and a person who was killed under torture..

In Hama province, 3 persons were killed due to a landmine explosion in Tal Bazam village / Soran city.

In al-Raqqah province, 2 people were killed, one on the hands of SDF Kurdish militia, when they raided his house in al-Dir'iya neighbourhood in al-Raqqah city, and the other died due to his wounds from previous explosion of a car bomb in al-Tabqa city.

In Aleppo province, 2 persons were killed, one due to the shelling on the town of Zarba, and the other by the SDF Kurdish militia in the village of Bukhar for refusing compulsory conscription into the ranks of SDF.

One person was killed in Idlib province due to the shelling on Kafranbel city.

One person was also killed in Deir ez-Zor province by unknown assailants. His body was found in the industrial zone in Albukbamal three days after his disappearance.

One person from Homs province was also killed under torture in a regime prison after nearly a year of detention.

The Syrian Human Rights Committee has documented the following victims:

1- Fadi Juma Alslou / al-Raqqah – Diriyah neighbourhood / shot by the SDF Kurdish militia.

2- Child Nasrallah Mahmoud Al-Hadi / Aleppo countryside – Tal Alloush / due to the shelling on the town of Zorba

Massive destruction at Al-Tah town after being targeted by Syrian and Russian missiles

The total number of victims documented by the Syrian Human Rights Committee in Syria on Sunday 1st September 2019 reached 8 people including 2 women and 1 person killed under torture.

In Idlib province, 4 people were killed, 2 of them due to the shelling on Al-Tah town, and died of their wounds due to previous shelling on Al-Tah town and Ma'aret Al-Nu'man city.

In Aleppo province, 3 people were killed: a man and his pregnant wife shot dead while asleep by unknown assailants who broke into their house in Jarabulus city. And a man killed due to a landmine explosion near Azaz city.

In Daraa province a man was killed under torture in a regime prison a year after his arrest.

The Syrian Human Rights Committee has documented the following victims:

- 1- Ahmad Khaled Al-Mohammad / Aleppo countryside, shot by unknown persons in Jarabulus city
- 2- The wife of Ahmad Khaled Al-Mohammad / Aleppo countryside, shot by unknown persons in Jarabulus city

In al-Hasakeh province a man was also shot by unknown gunmen in the village of al-Gharb.

The total number of victims documented by the Syrian Human Rights Committee in Syria on Wednesday 4th September 2019 reached 4 persons including a child.

In Deir ez-Zor province, 2 people, including a child, were killed by a SDF militia during a raid between the towns of Mu'ayzila and the village of Marat, and the other was killed by unknown gunmen near Al-Shuhail town.

A young man was killed in Idlib province by a landmine explosion in Sarmin town.
