1. Will a mother (not holding Lebanese citizenship) of a minor child with Lebanese citizenship be granted a residence permit or citizenship in Lebanon upon application for family reunification/citizenship? If so, please outline stipulations concerning the mother and her relationship to the child along with the application procedures and other relevant requirements.

According to the information received from the GDGS and as a general rule, a mother (not holding Lebanese citizenship) of a minor child with Lebanese citizenship will be granted a residence permit in Lebanon under two conditions:

- 1- The applicant has to reside with the minor child in Lebanon,*
- 2- The applicant has to apply in person.*

It is to be noted that two remarks have been in this regard raised by the GDGS:

- 1- The institution of family reunification is not applicable in Lebanon,*
- 2- The decision on whether or not a residence permit is granted to any foreigner is a decision to be taken by the Director General of the GDGS on a case to case basis.*

A mother (not holding Lebanese citizenship) of a minor child with Lebanese citizenship will not be granted the Lebanese citizenship. The Lebanese citizenship is transmitted by the Lebanese husband and not by the child.

2. Follow up question to NOTAT: LIBANON. Opholdstilladelse i Libanon. Svar på supplerende spørgsmål til svar indeholdt i UM's NOTAT af 27.5.2015 Ref. US mail af 15.8.2015, J.nr. 2015-12080:

-In case a Syrian applicant has lost his/her national passport and isn't able to reacquire the passport or acquire a new one, could an applicant applying **for the first time** for a "residence permit of three years (renewable) granted as a rule to the son/daughter of a Lebanese mother" present **a Syrian identity card** instead of 'A passport valid for at least three years'?

According to the information received from the GDGS, a Syrian applicant, who lost his/her national passport and isn't able to reacquire the passport or acquire a new one, will be able to apply for a residence permit in Lebanon by presenting a Syrian identity card instead of a passport when aged 15 years or more. When aged less than 15 years old, a certificate of civil status must be presented. The applicant should however be able to document the loss of his passport by providing the GDGS with a formal police report.

In case a Syrian spouse of a child of a Lebanese mother applying for a residence permit or renewal of such who has lost his/her national passport and isn't able to reacquire the residence permit or acquire a new one, could the spouse in question present **a Syrian identity card** instead of 'a passport'?
