Situation of single Muslim women, particularly Yoruba, without family or support network in Lagos, including availability of support services and ability to access housing and employment

1. Background

Information on single Muslim women, particularly Yoruba, without family or support network in Lagos, could not be found among the sources consulted by EUAA within the time constraints of this query. However, the following information on single women in Nigeria may be relevant.

Sources cited in the 2023 General Country of Origin Information Report on Nigeria by the Ministry of Foreign Affairs of the Netherlands stated that ‘the situation for single women was difficult throughout Nigeria, although this varied greatly according to region and ethnic group.’¹ In December 2023, a counsellor interviewed by the News Agency of Nigeria (NAN) highlighted that societal stigma, economic challenges, and emotional struggles significantly impacted the mental health of single mothers in Nigeria.²

The United States Department of State (USDOS) Annual report on human rights in 2022 indicated that unmarried women in Nigeria ‘endured many forms of discrimination.’³ Similarly, the Ministry of Foreign Affairs of the Netherlands reported that women experienced ‘significant discrimination’ in different fields, including in ‘education, employment and inheritance’, as well as gender-based violence’ (GBV).⁴

2. Availability of support services

Information on support services for single Muslim women, particularly Yoruba, without family or support network in Lagos could not be found among the sources consulted by EUAA within the time constraints of this query. However, the following information on single women in Nigeria may be relevant.

The Lagos State Ministry of Women Affairs and Poverty Alleviation (WAPA) comprises various units dedicated to the empowerment of women and the reduction of poverty through skill

acquisition programmes and targeted support initiatives.⁵ For instance, a Facebook post by the government of Lagos state shared that WAPA launched on 1 July 2022 a free short-term skills acquisition program for female members of different Islamic organizations, ‘including Muslim Students Society of Nigeria (MSSN), Al Mu’izz, Nasrul-lahi-li Fathi Society of Nigeria (NASFAT) and the Federation of Muslim Women Association of Nigeria (FOMWAN)’.⁶

In 2024, media sources reported on a project launched by the Oladele Fajemirokun Foundation⁷ in the Ibeju-Lekki area of Lagos State, which provided vocational skills to over 1 000 young mothers, including ‘single mothers without male support in their households’.⁸

Sources provided lists of local organisations based in Lagos and in Nigeria offering support services to women.⁹ Among these is the Jireh Doo Foundation (JDF), a women-led organization that provides resources and assistance to underserved individuals across Nigeria, including single mothers.¹⁰

3. Access to housing and employment

Information on access to housing for Muslim women, particularly Yoruba, without family or support network in Lagos, could not be found among the sources consulted by EUAA within the time constraints of this query. However, the following information on single women in Lagos may be relevant.

According to a study published in September 2023 in the Journal of Housing and the Built Environment,¹¹ survey data indicated presence discrimination in the Lagos rental market and the ‘majority of the victims were female headed households’.¹² Media also reported on cases when landlords and estate agents in Lagos refused to rent to single women.¹³ Several single women interviewed by media sources were asked ‘embarrassing and humiliating’ questions while looking for an apartment,¹⁴ and were discriminated based on their marital status¹⁵, fear of perceived misconduct or inconsistencies in bill payments.¹⁶ A single mother interviewed by another local newspaper stated that an estate agent suggested her perceived ‘waywardness’

was the reason she was a single mother and tried to convince her former landlord not to rent to her.¹⁷ While the source did not specify the exact location, it discussed the broader challenges faced by single mothers in Nigeria.¹⁸

Information on access to employment for Muslim women, particularly Yoruba, without family or support network in Lagos, could not be found among the sources consulted by EUAA within the time constraints of this query. However, the following information on single women in Nigeria may be relevant.

A study on 'Gender-Disaggregated Data Analysis of the Nigerian Lending Market' published in 2022 found that 98 % of Nigerian women were excluded from formal credit markets.¹⁹ Furthermore, according to the National Women's Economic Empowerment (WEE) Policy and Action Plan, married women and women in the youngest and oldest age groups are more likely to have access to bank accounts and financial services compared to single women.²⁰
