1. Introduction

This is the 27th monthly report on violence and other forms of human rights violations on the basis of sexual orientation and gender identity/expression since the Anti-Homosexuality Act (AHA) came into force on 30th May 2023. The report discusses cases in which known or suspected LGBTIQ persons were targeted for violence and violations purely on the basis of their SOGIE as reported in the month of August 2025, drawing a comparison with the month of July 2025. This report builds on the reports produced earlier for every month since the AHA came into force and therefore seeks to build on the data available about the enforcement of the AHA 2023 from 30th May 2023 to date.

2. Methodology

This report provides an overview of cases of violence and human rights violations on the basis of SOGIE that were reported to the HRAPF legal aid network in August 2025. Quantitative data for this report was obtained from a review of case files for data on the number of cases handled and the number of cases in which acts of violence or other human rights violations were identified. The data was then subjected to a qualitative analysis to ascertain the circumstances under which the incidents occurred, in order to ensure that only cases in which such acts were perpetrated purely or primarily on the basis of real or presumed SOGIE are included in the report. All data reported has been independently verified to ensure its accuracy.

The data presented in this report covers only cases reported through the HRAPF legal aid network. The report presents a fair picture of the situation for LGBTIQ persons across the country as reported to HRAPF's countrywide network of community paralegals, regional legal aid centres, specialised community legal aid desks and the main legal aid clinic, but it may not be representative of all LGBTIQ persons' lived realities during the month, as not all cases that occurred in August 2025 were reported to HRAPF's network.

3. Nature and number of cases reported

HRAPF handled a total of 66 cases in the month of August 2025, an increase from the 41 cases handled in the month of July 2025. Out of the 66 cases handled, 18 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 27.3% of all the cases handled during the month. This represents an increase from July 2025, where 12 cases were registered where people were targeted for negative treatment on the basis of their SOGIE. The number of victims almost doubled – from 14 people in July 2025 to 26 people in August 2025. A total of 26 persons were affected by the violations in August 2025 as compared to 14 people in July 2025 – an increase in the number of victims. Out of the 18 cases in which LGBTIQ people were specifically targeted for violent or otherwise detrimental treatment during the month of August 2025, 8 cases involved violence and threats of violence against victims due to their actual or presumed SOGIE, 6 cases involved arrests for sexuality related reasons, 3 were eviction cases and 1 was a case of discrimination on the basis of sexuality.

This section of the report provides detailed data on these cases.

3.1. Cases involving actual violence and threats of violence

A total of 8 cases involving violence and threats of violence were registered in August 2025, affecting 11 individuals. 6 of the cases involved actual violence towards the victims due to their SOGIE while 2 cases involved threats of violence.

(i) Cases involving actual violence

There were 6 reported cases of actual violence in August 2025, affecting 9 individuals, and they all involved physical assaults and actual injuries to the victims. Two cases were reported from Kampala while one case was reported from each of the districts of Iganga, Gulu, Mbarara and Mbale. 3 of these incidents were perpetrated by unknown persons while 1 was perpetrated by an individual from the local community, one by local leaders and one by a family member.

(ii) Threats of violence

There were 2 reported incidents of threats of violence in the month of August 2025, affecting 2 people. The cases were reported in Gulu and Lira districts, and involved threats of physical harm.

3.2. Arrests

There were 5 cases where 9 persons were arrested purely on the basis of their presumed SOGIE in August 2025. This was a significant increase from July where only one case affecting one person was recorded, indicating that arrests continue to be carried out.

3.3. Evictions

There were 3 cases of evictions on the basis of sexuality in August 2025, affecting 4 persons. Two of the cases were reported from Kampala while one case was reported from Ntungamo district. The evictions were executed by the client's landlord in one case and the clients' landlords and local leaders in two of the cases.

3.4. Other forms of discrimination

During the month of August, one case of discrimination in healthcare was recorded from Kabarole district, affecting 1 person and perpetrated by a health worker.

4. Comparison with July 2025

There was an increase in the overall number of cases reported in August 2025, from 41 cases in July 2025 to 66 cases,

and the number of cases in which individuals were targeted for violence and other violations on the basis of their SOGIE also increased significantly from 12 cases in July to 18 cases in August 2025, affecting 26 persons (up from 14 people affected in July). Cases involving threats and actual violence were the highest number of cases in July, and this trend held steady in August, where 8 incidents of violence and threats of violence were reported. Notably, cases of arbitrary arrests for sexuality-related reasons increased significantly from 1 case affecting 1 person in July to 6 cases affecting 10 individuals in August 2025. It appears therefore that dramatic reduction in the number of cases of targeted violence against individuals on the basis of their real or presumed SOGIE recorded in July was not in fact an indicator of a consistent improvement in the human rights situation or the lived realities of LGBTIQ persons in Uganda.

5. Comparison with August 2024

HRAPF handled a total of 56 cases in the month of August 2024, out of which 20 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 35.7% of all the cases handled during the month of August 2024. Out of the 20 cases in which LGBTIQ people were specifically targeted for detrimental treatment during the month of August 2024, 10 cases involved violence and threats of violence against persons on the basis of their SOGIE, 9 were cases of eviction from rented properties while 1 case was an arrest for sexuality related reasons. The total number of cases reported in August 2025 increased to 66 cases, although cases involving acts of homophobia/ transphobia reduced a little from 20 cases in August 2024 to 18 in August 2025. The number of victims in these cases however increased slightly from 24 persons in August 2024 to 26 persons in August 2025.

In terms of the specific nature of cases reported, there was a small reduction in the number of cases involving violence and threats of violence from 10 cases affecting 12 people in August 2024 to 8 cases affecting 11 people in August 2025, and the number of eviction cases reduced significantly from 9 cases affecting 10 persons in August 2024 to 3 cases affecting 4 people in August 2025. However, cases of arbitrary arrests on the basis of sexuality jumped dramatically from 1 case affecting 2 individuals in August 2024 to 6 cases affecting 10 people in August 2025. Also noteworthy is the fact that, for the first time, a case of direct discrimination on the basis of sexuality in a healthcare setting and a total denial of services was registered in August 2025. These changes indicate that the general public's treatment of LGBTIQ persons seems to be continuously improving, yet the treatment of LGBTQ persons in state institutions is not following this trend at all (and in fact seems to be regressing). The denial of PEP services might suggest a shift towards scarcity of essential HIV/ AIDS prevention services and technologies that is attributable both to homophobia and to the reduced resources for such services following the cessation of funding support for such services from the US government in January 2025.

6. Comparison with the pre-AHA period - August 2022

In August 2022, about 6 months before the Anti-Homosexuality Bill 2023 was tabled and about 10 months before the law was enacted, a total of 45 cases were handled involving LGBTIQ persons. Of these, 13 cases involved actions that directly targeted persons on the basis of their real or presumed SOGIE. The actions in these 13 cases affected a total of 13 people, and included 9 cases of real or threatened violence, 3 evictions and 1 arrest. It is important to note that, while the AHA was not yet in force at this time, there was still heightened public outcry against homosexuality and increased media attention towards the LGBTQ community following allegations of 'recruitment' of people into homosexuality,¹ which would eventually culminate into the tabling of the AHB 2023 in February 2023.

Nevertheless, these numbers are still lower than the number of cases reported in August 2025, during which 66 cases were handled, of which 18 involved acts of targeted homophobia. Cases of actual or threatened violence actually reduced slightly from 9 cases in August 2022 to 8 in August 2025, while evictions have remained the same. It is noteworthy that the number of incidents of violence on the basis of sexuality jumped significantly from 9 in August 2022 to 19 in August 2023 before reducing again to 8 in August 2025, and cases of eviction also increased dramatically from 3 cases in August 2022 to 22 cases in August 2023 before reducing again to 3 cases in August 2025 as shown in the figure below. The factors that majorly influenced these two trend lines are clear: the enactment of the AHA 2023 on 30th May 2023, and the judgment of the Constitutional Court in April 2024 decriminalising letting of premises to LGBTIQ persons in section 9 of the AHA and nullifying section 14 of the AHA 2023, which imposed an obligation on all individuals to report suspected homosexuals. These two sections of the law had led to an increase in public profiling of suspected queer persons, as well as impunity in violence and violations against LGBTIQ persons.

Trends in cases of SOGIE-based violence and violations (Aug '22, Aug '23, Aug '24 and Aug '25)



On the other hand, cases of arbitrary arrests for sexuality-related reasons, starting at 1 in August 2022, increased to 6 in August 2023 (a clear reaction to the expanded criminalization in the AHA 2023), reduced to 1 in August 2024, but then rose again to 6 in August 2025, suggesting that the enforcement of the AHA has not in fact been affected by the April 2024 decision, and that the right to liberty for LGBTIQ persons continues to be adversely affected by the overbroad terms in which many of the provisions of the AHA 2023 are couched.

7. The implementation of the AHA 2023 from 30th May 2023 to 31st August 2025

As the implementation of the AHA marks two years and three months, a total of 1,907 cases involving LGBTIQ persons have been handled across the HRAPF legal aid network, of which 893 cases (46.8%) involved actions that specifically targeted LGBTIQ people because of their sexuality, affecting a total of 1,175 persons.

The breakdown of all the cases involving SOGIE- motivated violence and violations so far is as follows:

8. Conclusion

Over the last 27 months, HRAPF and other NGOs working in the field of legal aid service provision and social protection for LGBTIQ persons have carefully monitored the human rights situation for LGBTQ persons in the wake of the enactment of the AHA 2023, tracking the impact of the law on access to justice, SRHR, protection from violence and

other aspects of the day to day experiences of LGBTIQ persons. It remains abundantly clear that, despite a notable reduction in the number of cases of violence and violations perpetrated primarily by non-state actors, the situation still remains dire for LGBTIQ persons, and the state institutions in the criminal justice sector continue to enforce the AHA 2023 in a way that prejudices the right to liberty for LGBTIQ persons across the country, despite slight improvements in the legal environment in April 2024. The only apparent solution to this impasse remains a complete overhaul of the legal framework to provide for specific protection from violence and human rights violations on the basis of real or presumed SOGIE, as required by African Commission Resolution 275.

APPENDIX: Cases of arrests still pending before police stations and courts across the country at the end of July 2025

Currently, HRAPF is providing legal representation to a total of 21 individuals in 14 cases that are still pending actively either at police stations or before various courts across the country. In 5 cases, 9 individuals are still reporting on police bond and answering charges of homosexuality. In 9 cases, 12 individuals are answering various charges, including homosexuality, promotion of homosexuality, aggravated homosexuality, indecent practices and having carnal knowledge against the order of nature/ indecent practices in various courts of law. Of the 12 persons whose cases are pending before the courts, 3 are still on remand in the various prisons around the country while 5 were released on bail.
