1. Introduction

The month of September 2023 marks the fourth full month of the enforcement of the AHA 2023, and this report considers cases of violence and violations against persons on the basis of their real or presumed sexual orientation that have occurred during this period. The report considers only cases received by HRAPF's legal aid network in September 2023. This report builds on previous reports in this series, which have documented violence and violations of the rights of LGBTQ persons during the run up to the passing of the AHA, the first 21 days of implementation of the AHA, and the first, second and third months of the law being in force. The report also documents the total number of cases since the AHA came into force, and makes comparisons between September 2023 and September 2022 as well as between the period June – September 2023 and June – September 2022 with a view to establishing the change in trends that the AHA and its enforcement has caused for LGBTIQ persons in Uganda.

2. Methodology

The report contains only those cases that have been reported to the HRAPF legal aid clinic in the month of September 2023. The cases have been reported across the entire legal aid network, from the central legal aid clinic at the HRAPF secretariat, the regional legal aid centres, the specialised legal aid desks as well as the network of community paralegals spread across the country.

In compiling the data for this report, the team reviewed all the physical files for all the cases reported in the month of September 2023, focusing on establishing the number of cases in which there was evidence of violence or other violations against persons on the basis of their real or presumed SOGIE. The figures were compiled in order to establish the number and nature of cases included in this report, and these cases were classified into three categories, as has been the case with the previous reports: cases of violence, evictions, and arrests on sexuality based charges. The files were then subjected to further review to establish the nature of each violation/case of violence and to establish, more importantly, the reason for the violation. Care is taken to include only those cases where the actions that affected the rights and lives of LGBTIQ persons were based purely or primarily on their presumed sexuality.

This report contains only those cases that have been reported to HRAPF's legal aid network. While HRAPF has a wide network of community paralegals and regional legal aid centres, this network by no means covers the entire country, and there are thus areas where LGBTIQ persons may not be reached by HRAPF legal aid services. This would therefore mean that this report is limited in so far as it does not consider cases involving persons in those areas that may have gone unreported or reported to other legal aid service providers or private practitioners. However, the report does capture cases reported from across the country through HRAPF's vast network, and therefore presents a fairly representative picture of SOGIE-based violence in light of the enforcement of the AHA 2023.

3. Nature and number of cases reported

In the month of September 2023, HRAPF handled a total of 68 cases involving LGBTIQ persons across its legal aid network, a slight reduction from 71 in August 2023. Out of the 68 cases handled, 49 involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 72.1% of all the cases handled during the month, a slight increase from the 47 (66.2%) in August 2023. Out of these 24 were cases of violence and threats of violence, 22 were cases of eviction from homes and rented properties, and 3 were arrests based on sexuality. These violations affected a total of 73 individuals up from 59 individuals in August 2023 – a 23% increment. This section of the report provides detailed data on these cases.

3.1. Cases of violence

In September 2023, HRAPF recorded a total of 24 cases of violence and threats of violence against individuals on the basis of their real or presumed sexual orientation and gender identity, an increase from 17 cases handled in August. Out of the 24 cases reported, 18 involved acts of physical violence while 6 were threats of violence. In August, there were 12 cases of actual violence and 5 threats of violence.

The actions in these cases affected a total of 37 individuals up from 20 persons in August – a remarkable increase.

i) Cases of actual violence on the basis of sexual orientation/gender identity

There were 18 cases of actual violence against persons on the basis of their real or presumed SOGIE in September 2023, affecting 20 persons. The majority of these cases were cases of physical violence (11), followed by verbal abuse (3), and extortion (2). There was also one case each of rape and confiscation of property.

The cases of violence were perpetrated by unknown persons in 9 cases, and 1 each by boda boda riders, intimate partners, neighbours and a manager at work. The cases were reported from Kampala (7), Wakiso (4), Gulu (2) and 1 each from Mbale, Oyam, Kitgum, Mukono and Nwoya.

ii) Cases involving threats of violence based on sexual orientation and/or gender identity

HRAPF received and handled a total of 6 cases involving threats of violence against LGBTIQ persons in September 2023, the same number of cases received in August. These affected a total of 17 persons up from 8 in August. Of these, 5 were threats of physical harm while 1 was a threat of arrest.

The cases were registered from Kampala (2), Wakiso (2), Gulu (1), Mbale (1) and Mukono (1). The threats were perpetrated by unknown individuals (4 cases), friends of the victim (1), the police and LC authorities (1) and the father of an intimate partner in 1 case.

3.2. Evictions from rented property

In September 2023, HRAPF handled a total of 22 cases involving evictions of persons from rented premises on the basis of their SOGIE. This was the same number of cases handled in August. The evictions were carried out by family members in 9 cases, landlords/ property owners in 7 cases, the local council leadership in 4 cases and neighbours in 1 case. The majority of these cases occurred within the Kampala Metropolitan Area (7 in Kampala district and 7 in Wakiso district), followed by 2 cases in Tororo district while one case was recorded from Budaka, Busembatia, Gulu, Kibuku, Mbale, and Mukono each. These cases affected a total of 31 individuals up from 26 in August.

3.3. Cases of arrest

There were 3 cases of arrests of individuals on the basis of their real or presumed sexual orientation or gender identity. One of the arrests was on the charge of homosexuality under section 2 of the AHA while the other was on the charge of promotion of homosexuality under section 11 of the AHA. All the cases were in Kampala, and they involved 5 persons. In August 2023, there were 6 such cases affecting 11 individuals.

4. Comparison with August 2023

While there has been a slight reduction in the total number of cases recorded over the past two months, the number of cases specifically targeting people on basis of their SOGIE increased slightly from 47 in August to 49 in September, and the proportion of the total number of cases handled which involve violence and violations against persons on grounds of SOGIE also increased from 66.2% in August to 72.1% in September. This increase is a sustained trend from July, in which 63.1% of all cases handled involved actions deliberately targeting individuals on the basis of their SOGIE.

The number of individual victims affected greatly increased in September with cases affecting 73 persons compared to 59 in August, a 23.7% increase.

Cases of violence overtook those of evictions from rented property/ housing as the highest with 24 in September compared to 22 in August. Those of evictions remained constant at 22 while arrests reduced from 6 to 2.

5. Comparison with the period from 1st September 2022 to 30th September 2022

In September 2022, a total of 31 cases were handled involving LGBTQ persons, of which 9 cases involved actions that directly targeted persons on the basis of their real or presumed SOGIE (29%). The actions in these 9 cases affected a total of 11 people, and included 5 cases of real or threatened violence, 2 evictions and 2 arrests. There has been a clear increase in the number of cases being handled between the two time periods, with the general number of cases increasing dramatically from 31 in September 2022 to 68 in September 2023, an increase of 37 cases (119.4%). The cases in which LGBTQ people have been specifically targeted also increased dramatically from 9 in September 2022 to 49 in September 2023 (444.4%), a clear indication of the contribution that the homophobia surrounding the enactment and enforcement of the AHA 2023 to the upsurge in violence and violations based on real or presumed sexual orientation or gender identity.

6. An overview of trends in the first four months of the AHA 2023 in Uganda

In the first three months of the AHA 2023, a total of 288 cases involving LGBTIQ persons were handled across the legal aid network, of which 195 (67.7%) targeted LGBTIQ people on the basis of their sexuality, affecting a total of 249 persons. The breakdown of cases so far is as follows:

In comparison with the same three-month period in 2022, a total of 138 LGBTIQ cases were handled in that period, of which 43 cases (31.2%) contained actions that deliberately targeted LGBTIQ persons for detrimental treatment. This translates to an increase of 150 in the overall total number of cases handled, and an increase of 152 in the number of cases involving actions targeting LGBTQ persons specifically – a clear indication that nearly all the new cases creating the current surge are directly as a result of attacks against LGBTQ persons in the context of the enforcement of the AHA.

7. Conclusion

The four months since the AHA came into force have continued to be particularly difficult for LGBTQ persons in Uganda, contrasting sharply with the same exact period from a year ago. While there have been claims from various state agencies within the Justice Law and Order Sector that the law is not being enforced, it is necessary to note that the law is quite clearly being formally enforced by the state. It is even more important to note that the AHA 2023 is in many ways self-enforcing, with non-state actors modifying their behavior in accordance to what they believe the law requires of them, including evicting suspected LGBTIQ tenants, reporting suspected LGBTQ persons to the police and even attacking LGBTQ persons verbally and physically, many of which actions go unaddressed in part because the victims are usually too afraid of further victimization to report these acts.
