The daily report of the victims of human rights violations in Syria 11-6-2019

Massacre of Kafr-Ein

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Monday, 11th June 2019 reached 16 people, including two children and four women.

In the province of Idlib, 12 people were killed, of whom 11 due to the shelling of the villages of Kafr-Ein, Tabeesh, the town of Hass and the city of Ma'arat al-Nu'man. A person was also killed in Kefr Lousin camp on the Syrian-Turkish border due to a random shooting by the Turkish border guards.

Two people were killed in Deir ez-Zor province, one by the Kurdish SDF militia in the village of Abu al-Naitel and the other by the regime forces in Ayyash village.

Two people were also killed in Aleppo province, one of them by the regime forces artillery fire on the town of al-Zerba and the other by unidentified gunmen in the city of Afrin.

Another person was also killed in the province of Deir ez-Zor by a landmine explosion in Mozan, Albukmal countryside.

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on 13th June 2019 reaches 14 people of whom 3 children, a woman and a person killed under torture.

In the province of Idlib, 8 people were killed, seven of them in the shelling of the towns of Ma'arata, Khan al-Subol, Josef and Mukka village, and one died of his wounds after being shot by the Turkish border guards in the Kafr-Lusin border camp.

In the province of Deir ez-Zor, 3 people were killed, of whom 2 due to a landmine explosion while planting near al-Omer oil field, and a person with special needs was shot dead by the regime forces at a checkpoint near the town of Ayyash.

One person was killed in the province of Hama due to the shelling of farmland around Murek.

One person was also killed in the province of al-Raqqa due to the explosion of an explosive device near the Al-Rasheed Park in the city centre.

A person in the province of Daraa, was tortured, in the regime prisons after five years of detention.

In the province of Aleppo, two persons died, one of them from a bomb attack on a gathering of displaced persons in the town of Telhadaya and the other died of burns he had sustained while trying to extinguish the fire in his home in Ain al-Arab.

In the province of Idlib, 3 persons were killed due to the regime bombing of the town of Hass.

four persons from the province of Homs were also killed under torture in the prisons of the regime.

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Saturday 15th June 2019 reached 20 people, of whom 4 children and 4 women.

In the province of Idlib, 13 people were killed due to the bombing of cities and towns in the province. The victims were distributed as follows: 5 people in al-Barra, 3 in Ma'arat al-Nu'man and 2 in al-Fatira and one in each of Hass, Kafr-Mous and Deir Sunbol.

In al-Hasakah province, 6 people were killed while trying to extinguish the fires that destroyed their farmland.

In the province of al-Sweida one person was killed by unidentified gunmen near the al-Kahraba neighbourhood in al-Sweida.

Syrian regime burns crops and agricultural lands

The total number of victims confirmed by the Syrian Human Rights Committee in Syria on Sunday 16th June 2019 reached 9 people of whom a child and a woman.

In the province of Aleppo, 2 people died, one due to the shelling of the town of Al-Bawabiya, and the other due to an explosive device explosion in the village of Kafr-Naseh.

In the province of Idlib, 2 people died, one due to the bombing of Karsa'a village and the other died due to the collapse of his house, which was damaged by the shelling.

In the province of Hama, 2 persons were killed: one due to the shelling on al-Zakat village, and the other due to a bomb explosion in al-Salamiya which is under the regime control.

Three people were also killed in the province of al-Raqqa by a landmine explosion in an agricultural land.

In the province of Idlib, 2 people died, one of them a girl died affected by her wounds from a previous bombing targeted the town of al-Barra and the other was killed under torture in the air intelligence branch in Damascus.



A person from the province of Deir ez-Zor was killed under torture in the regime's forces prisons.




