The Daily Report of Victims of Human Rights Violations in Syria 20-2-2019

The total number of victims documented by the Syrian Human Rights Committee on Wednesday, 20-2-2019, reached two persons, one of them a woman.

In the province of Daraa, a person was killed in a cluster bomb explosion left by the regime forces in the city of Sheikh Maskin.

In the province of Hama, a woman was killed by rocket fire by the regime forces targeting the Zakat village in the northern countryside.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Sarah Hassan Bakour Yassin / Hama – Zakat villages / by the rocket fire on the village

2 – Rafa Mohammed Ibrahim al-Khasawneh / Daraa – Sheikh Maskin / by a cluster bomb remnants of the regime forces.

The total number of victims documented by the Syrian Human Rights Committee on Thursday, 21-2-2019, reached (22) people of whom (3) children and (1) died under torture.

In the province of Deir ez-Zor, 12 people were killed, 10 of whom in a car bomb explosion targeting a bus carrying staff of al-Omar oil field in the city of Al-Shuhail, and 2 people whose bodies were found, one in Al Shanan desert and the other in the village of at-Tiana.

In the province of Aleppo, 4 people were killed, a man and a girl of whom, by a car bomb in the city of Afrin, a child was killed in an unknown explosion inside a military headquarters near the city of Ein al-Arab, and a man died under torture in a detention centre belonging to the Kurdish SDF militia.

In the province of Idlib, 3 people were killed, one of whom died of his wounds from a previous bombing of Khan Shykhun, a child was killed by a cluster bomb from the previous bombing of al-Rinba village, and one killed due to the rocket fire on Saraqeb town.

In the province of Hama (2) persons were killed by the shelling of the town of Sharia.

In al-Hasakah province a person was tortured and killed by unknown killers.

The total number of victims documented by the Syrian Human Rights Committee on Friday, 22-2-2019 reached 10 people: of whom 7 children, a woman and 1 died under torture.

In the province of Idlib, six people of whom five children and a woman, were killed by the bombing of Ma'arat al-Nu'man.

In the province of Latakia, two children were killed by a bomb explosion in a park overlooking the northern Cornich of the city of Jablah.

In the province of Hama, a person was killed by the shelling on the village of Zizoun by the regime forces stationed at Joreen Camp.

A person from Homs province also died under torture in a prison of the regime's forces.

The Syrian Human Rights Committee documented the names of the following victims:

In the province of Idlib (7) people, of whom two women, a child and a fetus was killed in his mother's womb due to the bombing of the regime forces that targeted the city of Khan Shykhun.

In the province of Hama, two people were killed by the bombing of the regime forces that targeted the agricultural land of the city of Latamna.

In the province of Deir ez-Zor, one person died under torture in the regime's prisons.

The total number of victims documented by the Syrian Human Rights Committee (SHRC) on Sunday, 24-2-2019, reached 21 people, of whom 1 child and 15 women.

In the province of Hama, 20 people, of whom 15 women and a child, were killed by a landmine explosion in al-Mushairifa area near Wadi al-Atheeb in the eastern province's countryside while collecting the roots of the Kam'a.

In the province of Idlib, one person was killed by rocket fire launched by the regime forces on the town of Khan Shykhun.

The Syrian Human Rights Committee documented the names of the following victims:

Shelling of Kafr Zita, Hama countryside

The total number of victims documented by the Syrian Human Rights Committee on Monday, 25-2-2019, reached 14 people of whom 7 children and 2 women.

In the province of Hama, 5 people were killed, 4 of whom by the shelling of the town of Kafr Zita, the village of Jabal Sulaiman and the towns of Zizafoon and Kafr Naboda.

In the province of Idlib, 5 people were killed due to the shelling on Khan Shykhun, al-Habeet and Khan al-Sobul.

In the province of Deir ez-Zor, 4 people were killed: one by unknown persons on the Syrian-Lebanese borders, another by a landmine explosion in the Shula area, and a third one was found dead and severely tortured in Abu Hamam desert. A woman died while giving birth due to lack of health care and not being helped to the hospital in the temporary Sour camp that was set up by the SDF militia for displaced people from the town of al-Bagoz.

Shelling the city of Khan Shykhun

The total number of victims documented by the Syrian Human Rights Committee on Tuesday 26-2-2019 reached (8) people, of whom (5) children, (2) women and (1) died under torture.

In the province of Idlib, 5 people, including three children and two women, were killed in the shelling of Khan Shykhun by the Syrian regime.

In the province of Aleppo, two people were killed: one of them by unknown persons, and his body was found in the village of Tal Shaeer, in the district of Jarablus, and the other died under torture in a prison of the regime forces.

In the province of Deir ez-Zor, a person was shot dead by the Turkish border guards while trying to cross into the Turkish territory.

The Syrian Human Rights Committee documented the names of the following victims:

Turkish Borders Guards in operation

The total number of victims documented by the Syrian Human Rights Committee on Wednesday, 27-2-2019 reached (9) people of whom (3) women and (2) were killed under torture.

In Deir ez-Zor province, 4 persons were killed: one was executed by ISIS in the town of al-Bagoz, another killed by a landmine explosion in at-Taym field, a third was killed by unknown persons in the town of Abu Hardub, The last died under torture in the regime prisons after 6 months of arrest.

In al-Hasakeh province, 4 people, of whom three women, were shot by the Turkish borders guards while trying to cross the border from ad-Derbasiyah area.

In ar-Raqqa province, a person died under torture in the prisons of the regime forces after nearly three and a half years in detention.

The Syrian Human Rights Committee documented the following victims:

1 – Ali Hamid Al-Mayouf/ Deir ez-Zor -Graniye / was executed by ISIS.

Solitary cells where political prisoners are tortured to death

The total number of victims documented by the Syrian Human Rights Committee on Thursday 28-2-2019 reached 16 people of whom 5 women and 9 people who were tortured to death in the regime prisons.

In Homs province, 8 people were died under torture in the prisons of the regime forces after nearly eight years of detention. Their relatives were informed of their deaths through death certificates which were handed over by the regime forces.

In Aleppo province, 5 women were killed in the village of al-Buweider due to a landmine explosion while working in the agricultural land.

A person was killed in Idlib province due to the shelling of Khan Shykhun.

Another person was also killed in Deir ez-Zor province due to a landmine left by ISIS in Hajin town.

A man from Rif Dimashq province died under torture in the regime's prisons after five months of detention.

The Syrian Human Rights Committee documented the names of the following victims:

In ar-Raqqa province, 4 people were killed by ISIS while collecting the plant of truffles in al-Badia as-Shamiya.

In Deir ez-Zor, one person died affected by his wounds from a landmine explosion in the Shula area a few days ago.

The Syrian Human Rights Committee documented the names of the following victims:

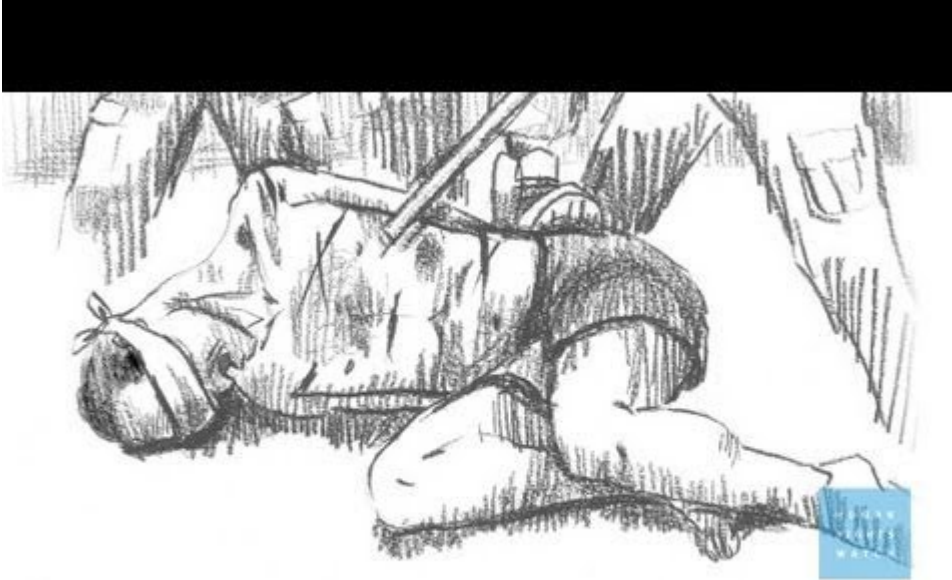

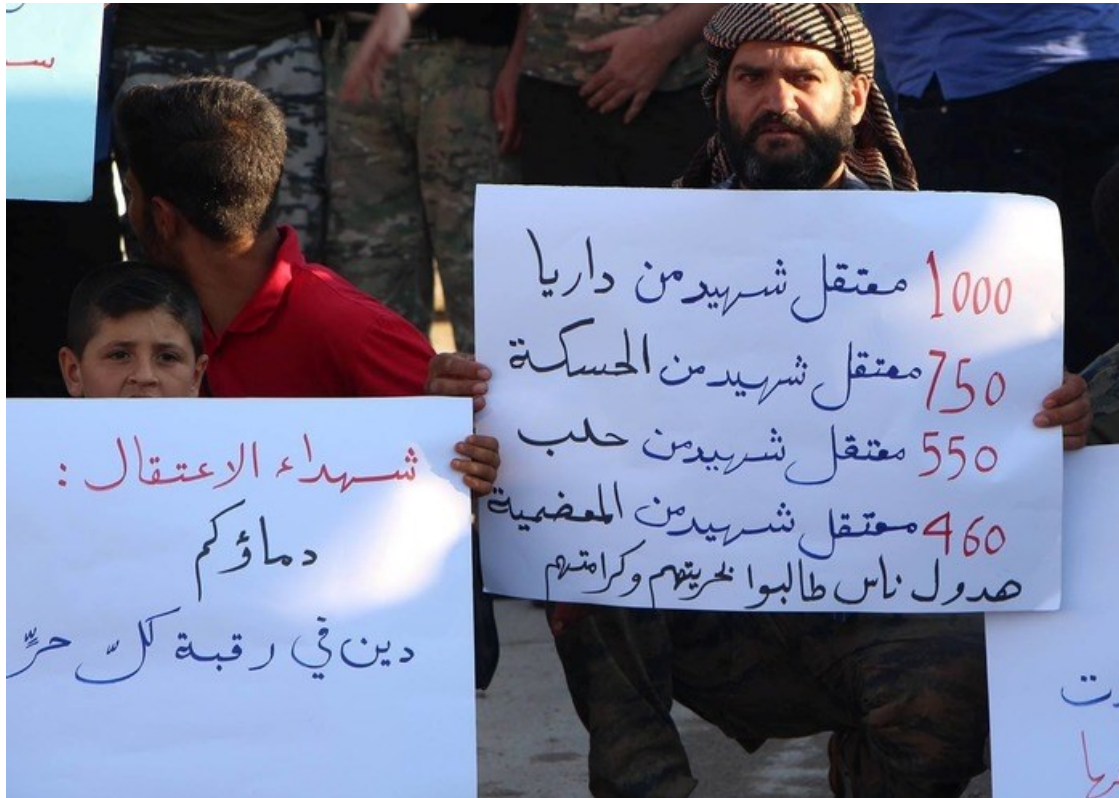

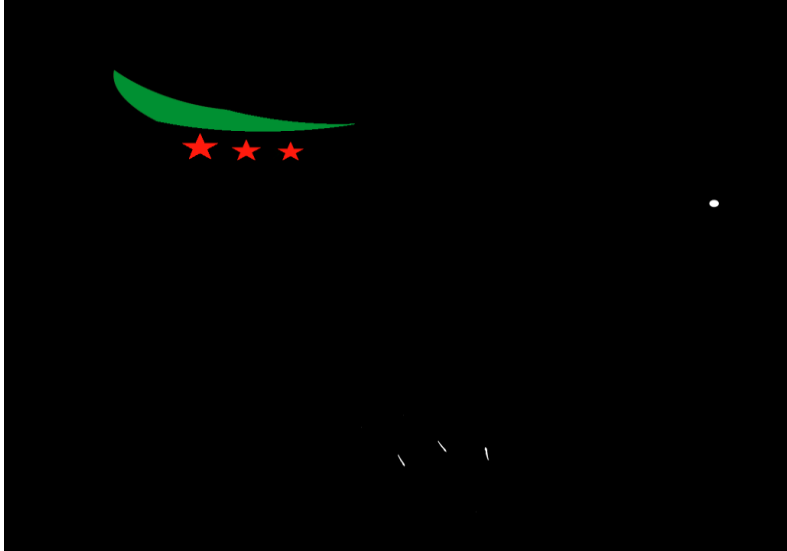

The total number of victims documented by the Syrian Human Rights Committee on Sunday, 31-3-2019, reached 9 persons, of whom 2 children.

In the province of al-Raqqa 7 people were killed, 4 of whom were kidnapped while working in the collection of truffles in al-Badia al-Shamia and then executed by ISIS, two children were killed by a landmine explosion left behind by ISIS in the Independence Park in al-Raqqa city, and a person was killed by the Kurdish PYD while attempting to infiltrate the city of Tal Abyadh to Turkish territory.

In Deir ez-Zor, 2 people were killed: one by the regime's forces despite the settlement of his status, and the other in a bomb explosion in the city of al-Basirah.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Ra'ed Latouf Salom Mjjal / Deir ez-Zor –al-Mayadin / was executed by the regime forces

2- Daham al-Darwish, 19 years / al-Raqqa, was shot dead by the Kurdish militia during his attempt to infiltrate Tal Abyadh to the Turkish territory.
