Dear Jakob Dam Glynstrup,

We hereby send you our reply to your question on our policy regarding transfers to Hungary in accordance with Regulation (EC) no 604/2013.

At the Directorate of Immigration (UDI) we do request Hungary and we also make decisions on transferring asylum seekers to Hungary in accordance with Regulation (EC) no 604/2013. Whether Hungary has accepted by default or not is not relevant since we don't ask Hungary for any specific assurances or guarantees. The Immigration Appeals Board (UNE) has given suspensive effect. Though they are looking into each case individually, we have noticed that since September all cases have been given suspensive effect. There are no final decisions as of yet.
