I. Follow up to the previous review

- 1. During its Third Universal Periodic Review (UPR) in 2019, Iran received 329 recommendations, of which it supported 143. The country did not support 123 recommendations and only partially supported 45. Merely a week following its review on 8 November, Iran witnessed a large-scale and lethal crackdown by State security forces on the nationwide protests that had engulfed it. State authorities and security forces committed crimes under international law and gross violations of human rights, many of which were subject to UPR recommendations a week earlier. They included those pertaining to the right to life, freedom from torture and ill-treatment, the rights to liberty, freedom of expression, association and peaceful assembly and fair trial rights.
- 2. Access Now and ARTICLE 19 welcome the opportunity to contribute to Iran's Fourth Universal Periodic Review. The organisations highlight that the majority of the recommendations supported by Iran in its third cycle were general in language and that the country did not accept concrete recommendations which, if implemented, would have allowed for tangible human rights improvements. These included recommendations to ratify key UN human rights conventions;² abolish the death penalty for persons under the age of 18;³ establish a moratorium with a view to abolish the death penalty;⁴ criminalise gender-based domestic violence and marital rape;⁵ repeal laws imposing mandatory *hijab* on women and girls;⁶ and release all persons detained in connection

with the exercise of their human rights.⁷

- 3. The organisations further highlight that Iran has failed to implement many of the recommendations it accepted, including those on ensuring freedom from torture while in detention;⁸ the right of detainees to adequate medical care;⁹ and the right of access to a lawyer of one's choosing.¹⁰ This has been despite the country's repeated statements when rejecting Special Procedures country mandates that it supports the UPR as a "non-selective and balanced mechanism".¹¹ The authorities failed to reform laws and institutions that enable human rights violations and impunity. Neither the Constitution nor other domestic laws were reformed for conformity with international law. Instead, regressive legislation was introduced and/or adopted further allowing for human rights violation. The organisations remain deeply alarmed by the ongoing gross violations of human rights and commission of crimes under international law, in particular in the context "Woman, Life, Freedom" and other protests that have engulfed the country since 2017, and the systemic and systematic impunity with which violations continue to be committed.
- 4. This submission addresses the following themes:
 - O Cooperation with international human rights mechanisms;
 - O Accountability for human rights violations and crimes under international law; ;
 - O Freedom of expression, association and assembly;

- O Gross violations of human rights and crimes under international law in the context of protests;
- O Digital Surveillance and Harassment;
- O Access to the internet;
- O Freedom of religion and belief; and
- O Discrimination and violence against women.

II. Cooperation with international human rights mechanisms

- 4. Iran failed to cooperate with international human rights mechanisms. The country supported only three recommendations concerning cooperation with the United Nations High Commissioner for Human Rights and the mandate holders of the Human Rights Council (UNHRC).¹² It did not accept 12 recommendations that called for cooperation with the Special Rapporteur (SR) on Iran through accepting his requests to visit the country and visits by other Special Procedures.¹³ In June 2023, the UN High Commissioner for Human Rights highlighted a "very limited" ... "substantive implementation of the State's obligations under international human rights law" stating that "Iran does not cooperate with the Special Procedures country mandate, and has received only one Special Procedures mandate holder in the past 17 years."¹⁴
- 5. Immediately after theestablishment of the Independent Fact Finding Mission on Iran (FFMI) by the UNHRC in November 2022, Iran's authorities publicly rejected its mandate and announced that they would not cooperate with the Mission.¹⁵ The authorities left unanswered repeated requests by the FFMI to visit the country and did not provide any

- response to over 20 information request letters sent by the FFMI.¹⁶ Similarly, Iran did not respond to 17 of the 56 communications by UN Special Procedures between 17 February 2020 and 24 April 2024.¹⁷
- 6. Moreover, Iran merely noted all recommendations related to the ratification of international human rights treaties. The country neither ratified the Convention Against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment and its Optional Protocol, ¹⁸ the Convention on the Elimination of All Forms of Discrimination against Women and its Optional Protocol, the Convention for the Protection of All Persons from Enforced Disappearance (ICPPED) and the first ¹⁹ and the second Optional Protocols ²⁰ to the International Covenant on Civil and Political Rights (ICCPR), ²¹ nor took any steps towards their ratification during this review cycle. ²²

Recommendations

- Immediately and fully cooperate with the Independent International Fact Finding Mission on the Islamic Republic of Iran including by allowing the Mission unhindered access to the country;
- Accept all outstanding visit requests of special procedures, including in particular the UN
 Special Rapporteur on the situation of human rights in the Islamic Republic of Iran

without any hindrance or restrictions on duration or scope and ensure they are allowed to meet victims and human rights defenders without any risk of reprisal;

- Respond in a timely and meaningful manner to the Special Procedures' communications;
- Ratify the first and second Optional Protocols to the ICCPR, the Convention Against
 Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment and its
 Optional Protocol, the Convention on the Elimination of All Forms of Discrimination
 against Women and its Optional Protocol, and the Convention for the Protection of All
 Persons from Enforced Disappearance.

III. Accountability for human rights violations and crimes under international law

7. Iran did not accept recommendations to investigate human rights violations and crimes under international law including those committed in the context of protests.²³ Similarly, recommendations to ratify the Rome Statute of the International Criminal Court were rejected.²⁴

Refusal to investigate

8. The authorities have systematically refused to carry out investigations into human rights violations and crimes, including those committed in the context of protests in 2017/18, 2019, 2021, and 2022 such as extra-judical killings, torture and ill-treatment and enforced disappearances. In 2022, the Special Rapporteur on Iran reflected on "the structural impediments for accountability" and the "lack of any progress or political will to conduct investigations, let alone ensure accountability." He stressed that within Iran's current

"system of governance, it is clear that obtaining accountability for human rights violations becomes arbitrary at best and impossible at worst". In its report, the FFMI "found no evidence of effective domestic remedies for victims of human rights violations" stating that "the authorities had failed to investigate allegations of human rights violations, or to prosecute or punish those responsible, and had deliberately and systematically obstructed any efforts by the victims and their families to obtain redress and establish the truth." ²⁶

Persecution of those seeking truth, justice and accountability

- 9. Authorities systematically concealed the truth about violations and subjected those seeking accountability to sustained harassment, including through arrests, detentions, torture and ill-treatment, judicial prosecutions, heavy punishments, and dismissal from work.²⁷ They denied families of victims killed during the 2019 and 2022 protests the right to give their loved ones a dignified burial, hold funerals and mourn their loss and threatened them with secret burials, harming or killing their surviving relatives, and arrest, if they continued to speak up.²⁸ Numerous family members of victims were arrested and prosecuted during this cycle.²⁹
- 10. In December 2023, Mahsa Yazdani, the mother of Mohammad Javad Zahedi, a 16-year-old child killed in September 2022 during the protests in Sari, Mazandaran, was summoned to serve a 13-year prison sentence for "insulting sanctities", "inciting people to disrupt public order", "insulting the Supreme Leader" and "propaganda against the system". She was convicted in connection with her activism seeking truth and justice for

- 11. Iran accepted to ensure that lawyers are not subject to intimidation and arbitrary arrest³¹ but did not support recommendations calling for an end to their harassment and the release of those detained.³² Persecution of lawyers continued and they faced heightened risk of severe reprisals in connection with their professional work. Authorities summoned, arrested, detained, tortured, convicted, sentenced, and disbarred lawyers in connection with their work representing victims of human rights violations, including protesters and families of those killed during protests.³³
- 12. At least 159 lawyers were subjected to various forms of harassment, including summons, and criminal investigations following the protests that started in September 2022. At least, 57 of them were arrested and detained.³⁴ Authorities conducted mass summoning of lawyers in relation to their professional work and/or expressions of solidarity with victims of human rights violations.³⁵
- 13. On 2 October 2023, Khosrow Ali-Kordi, the lawyer of the family of Abolfazl Adinehzadeh, a 16-year-old child who was killed by security forces during protests in October 2022 in Mashhad, Khorasan Razavi province,³⁶ was arrested, charged and convicted of "propaganda against the system". In November 2023, he was sentenced to one year in prison, two years in internal exile, a two-year prohibition on leaving the country, two

years of prohibition from online activities, and two years of disqualifications from practicing. His conviction solely arose from his work representing families of victims and media interviews he had given in this relation.³⁷

Recommendations

- Ratify the Rome Statute of the International Criminal Court;
- Ensure that prompt, independent, transparent, impartial and thorough investigations are
 conducted into human rights violations and crimes under international law, including
 those committed in the context of protests in 2017- 2018, 2019, 2021, and 2022 and
 where sufficient admissible evidence of crimes exists, prosecute those suspected of
 criminal responsibility before civilian courts in proceedings that conform to international
 fair trial standards without recourse to the death penalty;
- Make public all available information and records regarding the number of those killed during the protests in 2017-18, 2019, 2021, and 2022; their identities; the location, and the cause and circumstances of their deaths;
- Immediately cease the harassment of those seeking truth, justice and reparation including families of victims, lawyers, and human rights defenders and unconditionally release all persons detained in connection with their activism.

IV. Freedom of expression, association and assembly

14. During the last UPR, Iran received 20 recommendations concerning freedom of expression, ³⁸ only three of which were accepted. ³⁹ Only two recommendations to guarantee freedom of association, and one to ensure the right to assembly were accepted. ⁴⁰ Iran did not accept recommendations to repeal provisions of the Islamic Penal Code (IPC) that unduly restrict the right to freedom of association and peaceful assembly or to release all persons detained for exercising this right. ⁴¹ Constitutional provisions which subject the rights to freedom of expression, ⁴² association ⁴³ and assembly ⁴⁴ to vague and broad qualifications, namely respect for the fundamentals of Islam, remained unamended. Similarly, numerous vaguely worded and broadly defined provisions of the 2013 Islamic Penal Code (IPC), which allow for criminalisation of protected speech and the exercise of human rights, ⁴⁵ in some cases making them

punishable by death, 46 remained in force.

- 15. In January 2021, a supplementary provision, Article 499 *bis*,⁴⁷ was added to the IPC. It imposes heavy punishments on anyone who 'insults' legally recognised religions, Islamic branches, and Iranian ethnicities with the intention to cause 'violence or tension' in society or with the knowledge that their conduct will result in 'violence or tension'. The provision is vague, fails to define key concepts, restricts protected speech in breach of international law, and is likely to be used against already persecuted ethnic and religious minorities.⁴⁸
- 16. A draft Bill on Discretionary Punishments, which, if enacted, will replace the existing Book Five of the IPC, was introduced. It includes a wide range of provisions which would further erode human rights. Some provisions continue to criminalise conduct that is currently criminalised under the existing IPC including "insulting" the authorities and "spreading propaganda". However, in some cases, the bill has expanded the scope of criminalised conduct or has proposed heavier punishments. The draft bill has further introduced "offences", such as "insulting the flag and the national anthem", which are not currently stipulated under the existing IPC. Alarmingly, it contains provisions that further open the hands of State authorities to crackdown on peaceful protests. Most notably, under Article 60 of the bill, participation in and leading demonstrations, strikes and other similar acts of protests may result in the harsh punishment of up to 15 years in prison if the authorities deem that such protests to have been "armed" or "contravened the principles of Islam." 49
- 17. Iran received several recommendations concerning the safety of journalists, protesters, human rights defenders (HRDs), political dissidents and others, calling on Iran to create a

safe and enabling environment for civil society and HRDs, especially women HRDs.⁵⁰ Since the review, the authorities have continued to systematically repress any expression of dissent, both online and offline, arbitrarily arresting and detaining thousands of people for exercising their human rights. Among them are peaceful protesters, journalists and media workers, bloggers, artists, writers and HRDs including trade unionists, minority rights activists lawyers, women's rights defenders and student activists.⁵¹ In doing so, they have resorted to the country's legislative arsenal, including the IPC and have instrumentalized the Judiciary, which lacks independence and acts as the State's arms for repression.

- 18. Iran was one of the biggest jailers of journalists during the review period.⁵² According to the Committee to Protect Journalists, by September 2023, roughly 100 journalists had been arrested for covering the "Woman, Life, Freedom" protests.⁵³ Among them were Elaheh Mohammadi, Niloufar Hamedi, and Nazila Maroufian, women journalists who were arrested and convicted in connection with reporting on the death in custody of Jina Mahsa Amini, a young Kurdish-Iranian woman arrested by the so called "morality police" in September 2022 for not adhering to degrading mandatory *hijab* laws.⁵⁴
- 19. Repression of journalists and media workers was not confined to Iran's borders. Authorities increasingly engaged in transnational repression of dissent. Journalists based abroad received serious threats, including to their lives and personal safety, leading to

police involvement in some countries.⁵⁵ Authorities harassed family members of journalists working with media outlets such as BBC Persian, IranWire, and Voice of America, including by summoning, arresting, and detaining them.⁵⁶ On 12 December 2020, authorities executed dissident journalist, Rouhollah Zam, on the charge of "spreading corruption on earth" (*efsad fel arz*) after he was abducted by Iran's Revolutionary Guards during a visit to Iraq in October 2019 and was forcibly returned to Iran.⁵⁷

- 20. Human rights defenders were similarly targeted for systematic state repression. Authorities arrested, detained, tortured and sentenced to harsh punishments hundreds of HRDs.⁵⁸ Narges Mohammadi, the 2023 Nobel Peace Prize laureate, remained imprisoned. Authorities have repeatedly charged and sentenced her with new charges in connection with her ongoing human rights work. In May 2024, she reported that authorities have brought new charges against her after she spoke up about sexual violence against women prisoners by state officials in prison.⁵⁹ Authorities also subjected family members of HRDs outside Iran to harassment, including through arrests and criminal prosecutions.⁶⁰
- 21. Iran maintained laws that imposed the death penalty for acts falling under protected human rights, and sentenced to death and/or executed individuals in connection with their exercise of the rights to freedom of expression, association and assembly including protesters, artists and activists.

- 22. In May 2023, authorities executed two men, Yousef Mehrdad and Sadrollah Fazeli Zare on the charges of "insulting the Prophet of Islam", "burning the Quran and insulting Islamic sanctities" in connection with their expression on Telegram channels. The charges stemmed solely from the exercise of their protected rights.⁶¹
- 23. In July 2024, a Revolutionary Court convicted Sharifeh Mohammadi, a labour rights activist and HRD, on the charge of "baghi" (armed rebellion) and sentenced her to death. The conviction was on the basis of her alleged membership in the Labor Unions Assistance Coordination Committee (LUACC), a legal association in Iran, and her alleged membership in the banned Komala Party of Iranian Kurdistan.⁶²
- 24. In April 2024, a Revolutionary Court sentenced Toomaj Salehi, a rapper, to death after convicting him of "corruption on earth" The charges stemmed from his participation in the "Woman, Life, Freedom" protests and his critical social media posts condemning oppression and executions and calling for human rights and freedom.⁶³ His death sentence was overturned in June 2024 and a retrial was ordered.⁶⁴

Recommendations

 Reform domestic legislation, including the Islamic Penal Code and the Press Law to bring them in compliance with international human rights law including by repealing all provisions that unduly restrict the rights to freedom of expression, association and assembly and criminalise protected rights;

- Immediately and unconditionally release all persons detained for having exercised their constitutionally-protected rights to freedom of expression, assembly, and association;
- Immediately cease the transnational harassment of journalists, human rights defenders and dissidents based outside of the country

V. Gross violations of human rights and crimes under international law in the context of protests

25. Iran's authorities violently suppressed protesters who took to the streets against political repression, corruption, high inflation, and worsening environmental situation and demanded structural change, freedom, justice, accountability and equality. Violent state crackdowns were carried out against a backdrop of internet shutdowns and disruptions that blocked millions of people from being able to communicate with the outside world and aided the authorities to cover up the scale and nature of the violations. In March 2024, the FFMI found that the authorities had committed gross violations of human rights and the crimes against humanity of murder, torture, enforced disappearance, rape and sexual violence, imprisonment, persecution on the grounds of gender, intersecting with religion and ethnicity, and other inhumane acts in the context of "Woman, Life, Freedom" protests.⁶⁵

Unlawful use of force against protesters

26. Since the last review in November 2019, Iran's authorities and security forces have killed and severely injured thousands of women, men and children by unlawfully resorting to force, including lethal force, in the context of protests. This included the nationwide protests in November 2019;⁶⁶ protests in Khuzestan⁶⁷ and Esfahan⁶⁸ respectively in July and November 2021; protests in several provinces in May 2022⁶⁹ and the protests that

- engulfed the country from 16 September 2022, following the death in custody of Jina/Mahsa Amini at the hands of the morality police.⁷⁰
- 27. Various branches of security forces, including police (FARAJA) and its special forces, the Revolutionary Guards, and Basij systematically deployed firearms, including military grade assault rifles such as AK-47, to crush the protests, shooting at protesters and bystanders who did not pose an imminent threat of death or serious injury. They further fired inherently indiscriminate ammunition such as birdshot or other metal pellets (and other ammunition containing multiple projectiles) the use of which violates the absolute prohibition of torture and other ill-treatment causing severe, irreversible and painful injuries including blinding and deaths.⁷¹

Arbitrary arrest and detentions

28. Tens of thousands of men, women and children were arrested in the course of state crackdown on protests. Security forces conducted mass arrests of protesters and bystanders at protest sites and targeted arrests of activists, journalists, lawyers, and others.⁷²

The use of the death penalty

- 29. Iran did not accept any recommendations to abolish the death penalty;⁷³ establish a moratorium;⁷⁴ reduce the scope of offences punishable by death;⁷⁵ or even abolish its use against children.⁷⁶ Instead, the authorities have increasingly resorted to the death penalty as a tool of political repression and to instil fear in the population, in particular in the context of protests.⁷⁷
- 30. On 12 September 2020, authorities arbitrarily executed Navid Afkari, a wrestling champion, following a grossly unfair trial. He was subjected to enforced disappearance, torture and other ill-treatment, and was forced to make "confessions" prior to his execution.⁷⁸ Another protester, Abbas Deris, remains on death row and is at grave risk of execution in connection with the November 2019 protests. He has been convicted of the charge of "enmity against God" following a grossly unfair trial.⁷⁹
- 31. Between December 2022 and January 2024, the authorities arbitrarily executed nine young men, Mohsen Shekari, Majirdreza Rahnavard, Mohammad Mehdi Karami, Seyyed Mohammad Hosseini, Majid Kazemi, Saeed Yaghoubi, Saleh Mirhashemi, Milad Zohrevand and Mohammad Ghobadlou, in connection with the "Woman, Life, Freedom"

protests following grossly unfair trials that did not constitute meaningful judicial proceedings.⁸⁰ Over 100 persons, including women and children, were charged with offences carrying the death penalty in connection with the protests⁸¹ and, as of July 2024, several men, including from ethnic minorities, remained at risk of execution.⁸²

Impact on minorities

- 32. Ethnic minorities have been disproportionately impacted by the state's violent crackdown on protests. In November 2019, Khuzestan province, home to Ahwazi Arabs, witnessed a particularly lethal response by state security forces.⁸³ The Special Rapporteur on Iran highlighted reports showing that some of the provinces with a majority population of ethnic minorities had the highest numbers of deaths during the 2019 protests.⁸⁴
- 33. Similarly, during the protests that started in September 2022, security forces killed and injured a disproportionately high number of protesters and bystanders in minority-populated provinces in particular, Sistan and Baluchestan, Kurdistan, Kermanshah and Western Azerbaijan. Almost half of the recorded killings took place in minority-populated provinces while the largest number of killings in one day was in Zahedan,

Sistan and Baluchestan on 30 September 2022 in what is known as "the Bloody Friday".⁸⁵ The FFMI "assessed the existence of distinctly egregious conduct"⁸⁶ by security forces in these regions and found "that security forces displayed a particularly militarized response to protests that took place in minority regions, as compared to the means and methods used by security forces to repress the protests elsewhere."⁸⁷

Recommendations

- Immediately cease the use of lethal force during protests when there exists no imminent threat of death or serious injury to security forces or others;
- Reform 1995 Law on the Use of Firearms by Armed Forces in Necessary Incidents, in compliance with international law and standards on the use of force and firearms to ensure that it incorporates the principles of legality, necessity, precaution, proportionality, non-discrimination and accountability and that any use of lethal force is strictly limited to circumstances where there is an imminent threat of death or serious injury to security forces or others;
- Identify and repeal or reform all legislation that imposes undue restrictions on the right to peaceful assembly;

• Immediately cease the unlawful use of birdshot and other metal pellets which should not be used in any policing situations and violates the absolute prohibition on torture and other ill-treatment.

VI. Digital Surveillance and Harassment

- 34. Iran's National Information Network (NIN) continued throughout this period, with proposals such as the User Surveillance Bill. In addition to exacerbating internet censorship, these efforts have intensified surveillance and monitoring.⁸⁸ Policies aimed at increasing reliance on national internet infrastructure, its platforms and services would result in handing over more data to the state.
- 35. In March 2020, it became evident that unofficial Telegram apps Hotgram and Telegram Talei, associated with the Iranian government and intelligence services⁸⁹had stored the data of 42 million Telegram users, which were subsequently leaked online.⁹⁰ Privacy and data protection remain unprotected under Iranian laws.⁹¹
- 36. During the 2022-2023 protests, at least two cases were recorded in which protesters were geolocated through their use of national applications such as Snapp! Foods.⁹²
- 37. The Iranian state's cyberwarfare tactics are well known, but their use has been especially worrisome against minorities, dissidents, and those active in the diaspora. State efforts to hack into the mobile phones of Iranians using malware have been documented to have targeted individuals in Sistan and Baluchistan, members of NGO, HRANA, and diaspora activists.⁹³
- 38. Leaks from Internet Service Providers (ISPs) in Iran have revealed SIAM (a web program for remotely manipulating cellular connections made available to the Iranian

- Communications Regulatory Authority) system's role in targeting throttling of user access to the internet, and surveillance mechanisms of users through SIM cards.⁹⁴
- 39. This reporting period also saw the deployment of various technologies of surveillance to police mandatory *hijab* throughout Iran, enforcing the "Chastity and Hijab Bill" online. Officials have announced the use of facial recognition cameras⁹⁵ and open source reporting of women's infractions through a public application known as the "Nazer app"⁹⁶, and a wider system known as the "Cyberspace Monitoring System" to report content that promotes or depicts infraction of the mandatory *hijab*.⁹⁷

Recommendations

- Draft privacy and data protection laws in line with international human rights standards, and repeal provisions of the Computer Crimes Law that undermine encryption, privacy and people' rights against surveillance;
- Cease all forms of unlawful surveillance and digital attacks against individuals exercising their right to freedom of expression, assembly and association;
- Ensure ISPs in Iran are divested of all forms of cooperation with systems of state surveillance and censorship that goes beyond international human rights standards on access to the internet.

VII. Access to internet

Platform blocking

- 40. In2019, Iran rejected all recommendations on free expression and access to the internet.⁹⁸ Concerns that ARTICLE19 and Access Now raised for the intensification of NIN in 2019⁹⁹ have persisted and evolved into far reaching policies and actions during this period.
- 41. Authorities quietly implemented the User Protection Bill¹⁰⁰ which has devastating impacts on surveillance, control of internet infrastructure, internet disruptions and censorship.
- 42. The messaging app Signal was blocked in January 2021.¹⁰¹ In April 2021, the audio discussion app Clubhouse was blocked by ISPs without explanation .¹⁰² Instagram and WhatsApp, the only international platforms that remained accessible in Iran prior to September 2022, were blocked at the start of protests. According to official announcement this was said to be temporary,¹⁰³ but in December 2022, Meta was reportedly given a 10-day deadline to establish an office in Iran and cooperate with censorship and data sharing regulations in exchange for unblocking as per the User Protection Bill. Meta did not comply with the order and the platforms remain censored.¹⁰⁴
- 43. The start of the "Woman, Life, Freedom" protests also saw Google Play store and Apple's app store filtered. The Apple app store was unblocked in October 2022 alongside Skype

and Linkedin which were also temporarily blocked.¹⁰⁵ As of July 2024, the Google Play store still remains blocked. Over 90 percent of mobile phone users in Iran use phones powered by Google's Android operating system.¹⁰⁶ This is a particularly difficult hurdle for accessing the internet as lack of access to the Google Play store means accessing safe, secure and effective Virtual Private Networks (VPNs) become more difficult (especially in the face of constant censorship of VPNs outlined below).

Internet Shutdowns and Disruptions

- 44. In November 2019, a near total internet shutdown was implemented for around seven days, following nationwide protests sparked by the sudden announcement of fuel price increases. This blackout in communications facilitated the brutal killing with impunity of protesters by Iran's security forces.¹⁰⁷
- 45. Investigations have highlighted how internet shutdowns facilitate the commission of gross violations of human rights and crimes under international law such as unlawful use of force against protesters, extrajudicial killings and enforced disappearances.¹⁰⁸
- 46. The 2022-2023 nationwide protests did not see shutdowns on the scale of 2019, however new tactics to disrupt internet access during protests were used. This included far reaching VPN censorship. While this tactic preceded these protests and was already documented to be part of the new policies of the User Protection Bill, ¹⁰⁹ it intensified during this period as documented by OONI and having repercussions that led to disruptions and slow bandwidth on the wider internet. ¹¹⁰

- 47. The second tactic was the use of mobile curfews. This was the shutdowns or severe disruptions to mobile internet connections. Mobile internet data is the main source of internet connection for the majority of Iranians, especially in provinces such as Sistan and Baluchistan and Kurdistan. Mobile internet connections have become disabled in a number of locations on most days since the protests began curfews that have meant mobile internet providers have been unusable, if not completely throttled, from 4pm to 1am.¹¹¹ Data has shown these outages on various days on the major mobile carriers such as Irancell, Rightel and Hamrah Aval (MCI) across the country.
- 48. Based on the #KeepltOn campaign's reports,¹¹² Iran shut down internet during the period under review **57 times** divided as follows: **34** times in 2023¹¹³, **18** times in 2022¹¹⁴, **1** time in 2021,¹¹⁵ **1** time in 2020,¹¹⁶ and **3** times in 2019.¹¹⁷
- 49. During the "Woman, Life, Freedom" protests in 2022, the Iranian authorities imposed **15** internet shutdowns across the country. **Eight** of them impacted ethnic minorities such as Kurds, Baluch and Ahwazi Arabs in Kurdistan, Sistan and Baluchestan and Khuzestan. In many instances, the cities where internet shutdowns were most extreme were also been subjected to the most extreme forms of brutality by the authorities, including in Zahedan, Sanandaj and Saqqez, all populated by Iran's persecuted Kurdish and Baluch ethnic minorities, which account for almost half of the protester fatalities. This alarming trend supports the organisations' long-held position that internet shutdowns facilitate the commission of human rights violations and crimes under international law and further enable impunity.

- Refrain from shutting or disruption internet and telecommunications services, particularly during protests or in times of mass unrest;
- Divest ISPs from the control of state orders of internet shutdowns, surveillance and censorship;
- Immediately restore full access to the internet and all communication services, including blocked social media and messaging applications;
- Allow ISPs to operate freely by providing open, reliable, and secure access to the internet and digital communications platforms;
- Prosecute those suspected of criminal responsibility for crimes under international law, including crimes against humanity, facilitated by internet shutdowns in 2022 and 2019.

VIII. Freedom of religion and belief

51. Iran supported one recommendation to protect the rights of Christians and other minorities. 120 It did not accept several recommendations to amend legislation to ensure the right to freedom of religion and belief; freedom from discrimination on the grounds

of religion and belief,¹²¹ and to end the persecution of religious minorities.¹²² No steps were taken to amend laws that impose restrictions on the right to freedom of religion and belief and discriminate against religious minorities. Instead, in January 2021, authorities added Article 500 *bis* to the IPC, further criminalising conduct falling under the right to freedom of religion and belief. This includes "deviant educational or proselytising activity that contradicts or interferes with the sacred religion of Islam in ways such as making false claims or lying in religious and Islamic spheres such as claiming divinity, prophecy...". The provision effectively criminalises adherence to, practising, and promotion of religions and belief systems that fall outside the legally recognised religions under the Constitution, and dissenting opinions within the legally recognised religions.¹²³

52. Iran's religious minorities including Baha'is, Yaresan, Christians, Gonabadi Dervishes, Sunnins, Zaroastrians and Jews continued to face discrimination. Various minorities, in particular Bahai's, Yaresan, converts to Christianity and Gonabadi Dervishes were particularly targeted for arrest, detention and criminal prosecutions. Authorities continued to persecute Bahai's, including by demolishing their homes and cemeteries, confiscating their properties and closing their businesses, and denying them the right to education and employment.¹²⁴ Individuals converting from Islam or professing atheism remained at serious risk of arbitrary detention, torture and the death penalty.

Recommendations

- Identify and reform all laws that restrict the right to freedom of religion and belief and discriminate or have a discriminatory impact on persons belonging to religious minorities;
- End all forms of discrimination and persecution on the basis of persons' religion or belief.

IX. Discrimination and violence against women

- 53. Iran did not support recommendations to repeal discriminatory laws against women and girls 125 including laws imposing compulsory *hijab* (veiling) on them. 126 Women and girls continued to be subjected to extreme forms of discrimination and violence. 127 Iran's laws maintained provisions relegating women to second-class citizens and sanctioning violence and discrimination against them. They included laws sanctioning marital rape and those imposing compulsory *hijab* (veiling) in violation of the rights to equality and non-discrimination, freedom of belief and religion, freedom of expression and the absolute prohibition of torture and other ill-treatment.
- 54. On 16 September 2022, 22-year old Kurdish-Iranian woman, Jina Mahsa Amini, died in the custody of the "morality police" after she was arrested for "improper" *hijab*. The FFMI established the "existence of evidence of trauma to Ms. Amini's body, inflicted while in the custody of the morality police" and found that she "was subjected to physical violence that led to her death." Authorities denied responsibility for her death, violently repressed protesters, and doubled down on their crackdown on women and girls who, in defiance of these degrading and discriminatory laws, increasingly appeared in public unveiled. Since then, countless women have been arrested, denied basic services and rights such as access to banking and education, received SMS messages

warning that their vehicles would be confiscated or have had their vehicles compounded, prosecuted and sentenced. Courts have further subjected women to punishments violating the absolute prohibition of torture and other cruel, inhuman or degrading treatment or punishment including attending counselling sessions for "anti-social behaviour", cleaning governmental buildings, and washing corpses.¹²⁹

- 55. A draft bill on "Chastity and Hijab", which seeks to further cement violence and discrimination against women and imposes severe punishments on those who defy mandatory *hijab* remains under consideration while many of its provisions are already being implemented. Another draconian bill, the draft Bill on Discretionary Punishments, also contains provisions which expand the scope of offences and penalties for women not adhering to compulsory *hijab* and advocating for the right to choose one's dress.¹³⁰
- 56. In its report, the FFMI concluded that the authorities committed the crime against humanity, inter alia, of persecution on the grounds of gender.¹³¹

Recommendations

- Identify and reform all laws and rescind all draft legislation that discriminate against or have a discriminatory impact on women and girls;
- Adopt legislation to criminalise rape and sexual and gender-based violence, including domestic violence and marital rape, in line with international law and standards and ensure accountability for violence against women including when committed by state agents;
- Repeal all laws that impose compulsory hijab (veiling) on women and girls, in violation of their rights to equality and non-discrimination, freedom of belief and religion, freedom of expression and the absolute prohibition on torture and other ill-treatment.
