#### 1. Introduction

This is the 23<sup>rd</sup> monthly report on violence and other forms of human rights violations on the basis of sexual orientation and gender identity/expression since the Anti-Homosexuality Act (AHA) came into force on 30<sup>th</sup> May 2023. The report discusses cases in which known or suspected LGBTIQ persons were targeted for violence and violations purely on the basis of their SOGIE as reported in the month of April 2025.

#### 2. Methodology

This report provides an overview of cases of violence and human rights violations on the basis of SOGIE that were reported to the HRAPF legal aid clinic during the month of April 2025. Quantitative data for this report was obtained from a review of case files for data on the number of cases handled and the number of cases in which acts of violence or other human rights violations were identified. The data was then subjected to a qualitative analysis to ascertain the circumstances under which the incidents occurred, in order to ensure that only cases in which such acts were perpetrated purely or primarily on the basis of real or presumed SOGIE are included in the report. All data reported has been independently verified to ensure its accuracy.

The data presented in this report is limited by the fact that it covers only cases reported through the HRAPF legal aid network. The report presents a fair picture of the situation for LGBTIQ persons across the country as reported to HRAPF's countrywide network of community paralegals, regional legal aid centres, specialized legal aid desks and the main legal aid clinic, but it may not be representative of all LGBTIQ persons' lived realities during the month, as we acknowledge the possibility that not all cases that occurred in April 2025 were reported to HRAPF's network.

# 3. Nature and number of cases reported

HRAPF handled a total of 56 cases in the month of April 2025, an increase from the 49 cases handled in March 2025. Out of the 56 cases handled, 17 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 30.6% of all the cases handled during the month of April 2025 and 22 persons were affected by the violations.

Out of the 17 cases in which LGBTIQ people were specifically targeted for violent treatment during the month of April 2025, 8 were eviction cases, 6 cases involved actual physical violence and threats of violence being committed against the victims, 3 cases involved arrests for sexuality related reasons.

This section of the report provides detailed data on these cases.

#### 3.1. Evictions

The cases of evictions increased from 5 cases affecting 5 individuals in March 2025 to 8 cases affecting 9 individuals in April 2025. 2 of the eviction cases were reported in Mbale and 1 case each in the districts of Bushenyi, , Kapchorwa, , Kasese, Kampala, Mukono and Sironko. The evictions were orchestrated by the clients' landlords in 4 cases, family members in 3 cases and the landlord working with the local area leadership in 1 case. This is the first time since the Constitutional Court nullified provisions criminalising landlords renting out properties to 'homosexuals' in April 2024 that evictions have overtaken cases of violence as the highest number of violations in a month.

# 3.2. Cases involving actual violence and threats of violence

A total of 6 cases involving violence and threats of violence were registered in April 2025, affecting 8 individuals. Of these, 3 cases involved actual violence while 3 cases involved threats of violence. There has been a slight increase in cases of violence in April 2025, compared to the month of March in which 5 cases affecting 6 individuals were registered.

# Cases of actual violence

There were 3 incidents of actual violence against persons on the basis of their presumed SOGIE, affecting 4 individuals. All these incidents were perpetrated by unknown persons, and they all involved physical violence as a result of which the victims sustained injuries. 2 cases were registered in Kampala district while 1 was registered in Mbarara. This was a reduction from the 5 incidents of actual violence against persons on the basis of their presumed SOGIE, affecting 6 individuals recorded in March 2025.

Threats of violence

There were 3 incidents involving threats of violence being directed against the victims due to their SOGIE/presumed SOGIE which were registered during the month of April 2025. All the incidents involved verbal threats and 4 persons were affected. All these incidents were registered in Wakiso district. 2 of the incidents were perpetrated by the victim's neighbours and in 1 case by the client's close family members. This was an increase from the one case recorded in March 2025.

#### 3.3. Arrests

Arrests for sexuality-related reasons reduced from 3 cases affecting 3 persons in March 2025 to 2 cases affecting 4 persons in April 2025. There was also 1 case where the client was only summoned at police to answer allegations of homosexuality which had been raised by the general community against him. In one case, the client was charged with homosexuality under the Anti-Homosexuality Act, while in the other case the clients were first charged with homosexuality but upon their release, the officers indicated a charge of possession of narcotics on their bond forms. All the victims were released on police bond but their cases are still under investigation. 2 of the cases were registered in Wakiso and 1 case in Mukono district.

#### 4. Comparison with March 2025

There was a slight increase in the overall number of cases reported in April 2025 from 49 cases in March 2025 to 56 cases in April 2025. The number of cases involving actions that deliberately targeted persons for negative treatment on the basis of their real or presumed SOGIE also increased from 16 cases in March 2025 to 17 cases in April 2025, while the number of victims increased from 19 in March 2025, to 22 in April 2025. Eviction cases were the highest number of cases registered in April 2025, at 8 cases affecting 9 individuals while in March, 5 eviction cases were registered affecting 5 individuals. The cases of violence and threats of violence increased from 5 cases affecting 6 individuals in March 2025, to 6 cases affecting 8 individuals in April 2025. Arrests on sexuality related charges slightly reduced from 3 cases affecting 3 individuals in March 2025, to 2 cases affecting 5 individuals in April 2025.

#### 5. Comparison with April 2024

A total of 99 cases involving LGBTI persons were handled the month of April 2024, out of which 44 cases involved actions that directly targeted people for negative treatment on the basis of their real or presumed SOGIE and 61 persons were affected. Out of the 44 cases in which LGBTIQ people were specifically targeted for detrimental treatment during the month of April 2024, 19 were cases of evictions from rented properties, 17 were cases of violence and threats of violence while 8 were arrests for sexuality-related reasons.

In contrast, 56 cases were handled in April 2025, of which 17 cases involved acts of deliberate homophobia. Evictions from rented properties were the highest number of cases registered at 8 cases affecting 9 individuals, followed by cases of violence and threats of violence at 6 cases affecting 8 persons and arrests related to sexuality charges were the lowest at 2 cases affecting 5 individuals.

# 6. The first 23 months of the AHA 2023 in Uganda

In the 23<sup>rd</sup> month of the implementation of the AHA 2023, a total of 1,692 cases involving LGBTIQ persons have been handled across the HRAPF legal aid network, of which 828 (48.9%) targeted LGBTIQ people on the basis of their sexuality, affecting a total of 1,055 persons.

#### 7. Conclusion

The implementation of the Anti-Homosexuality Act 2023 continues to have a negative impact on the rights of LGBTQ persons, specifically in relation to protection from violence, protection of the right to liberty and access to housing, the three aspects that this series of reports majorly tracks. The data indicates that violence and other human rights violations continue to be high, almost two years since the AHA 2023 was enacted, thus highlighting the necessity for a swift review of this law. The rise in the number of cases of evictions is worrying, but we hope this is a temporary trend.

## APPENDIX: Update on Cases of arrest still pending before police stations and courts across the country

Currently, HRAPF is providing legal representation/following up to a total of 23 individuals in 14 cases that are still pending actively either at various police stations or before various courts across the country. In 6 cases, 12 individuals are still reporting on police bond and answering various charges related to their sexuality, both under the Penal Code Act and the Anti-Homosexuality Act, specifically homosexuality, attempted homosexuality and having carnal knowledge against the order of nature. In 8 cases, 12 individuals are answering various charges, including homosexuality, promotion of homosexuality, aggravated homosexuality, indecent practices and having carnal knowledge against the order of nature/ indecent practices. Of the 12 persons whose cases are pending before the courts, 5 remain on remand in various prisons across the country. It is thus quite clear that the Uganda Police

Force and the Office of the Director of Public Prosecutions are actively enforcing the Anti-Homosexuality Act, alongside the various provisions criminalizing same sex sexual behaviour in the Penal Code Act.

It is important to note that none of those who were reporting on police bond last month have had charges withdrawn, and instead two more have been added. For those in prison, none has been released on bail or conclusion of their cases. The most recent changes are shown in the table below:
