COI QUERY RESPONSE

DRC – SECURITY SITUATION IN GOMA

A report issued in October 2024 by the *Conversation* points out that "The violence wrought by the Rwandan-backed rebel group M23 Movement is often narrowly framed as intended to control eastern Democratic Republic of Congo's resource-rich mining sites. The rebel group launched its most recent offensive in 2021 and currently controls vast territories in the south-east of North Kivu province, surrounding and cutting off the main city of Goma."

In November 2024 *United Nations News* states that: "Between June and October, aid partners documented more than 100 attacks against people in displacement sites in Goma, Nyiragongo and Masisi. At least 18 people were killed."²

In November 2024 *Agence France Presse* states that: "Security forces in the DRC have since 2021 been battling the M23, a largely Tutsi militia that has seized large swathes of territory in the country's east. Goma, the provincial capital of North Kivu, is virtually surrounded by the armed rebellion."³

The *International Committee of the Red Cross* in November 2024 states that: "Despite the relative calm on the outskirts of Goma, fighting continues among various armed groups in several of North Kivu's territories."

A report issued in November 2024 by the *United Nations Security Council* states that: "In Goma, North Kivu, the presence of armed groups, widespread availability of weapons, and overcrowded sites for internally displaced persons contributed to heightened insecurity, criminal activity, civilian casualties..."⁵

The *International Organization for Migration* in December 2024 comments on: "...the expansion of the M23 group's zone of influence and the activity of other armed groups in and around the city of Goma (capital of North Kivu province) have increased both security and humanitarian challenges."

Agence France Presse in December 2024 states that: "The capital of DRC's North Kivu province Goma, home to about one million people and another million displaced by war, is now nearly surrounded by M23 rebels and the Rwandan army."⁷

Deutsche Welle in December 2024 points out that: "The capital of DRC's North Kivu province Goma is now nearly surrounded by M23 rebels and the Rwandan army."⁸
