1. Introduction

This is the 14th monthly report on violence and other human rights violations on the basis of sexual orientation and gender identity/ expression since the Anti-Homosexuality Act (AHA) came into force on 30th May 2023. The report discusses cases in which known or suspected LGBTIQ persons were targeted for violence and violations purely on the basis of their SOGIE as reported in the month of July 2024. This report builds on the reports produced earlier in this series and therefore seeks to build on the data available about the enforcement of the AHA 2023 from 30th May 2023 to date.

2. Methodology

This report provides an overview of cases of violence and human rights violations on the basis of SOGIE that were reported to the HRAPF legal aid clinic in July 2024. The data for this report was collected using both qualitative and quantitative methods of data collection, and it was independently verified and analysed to ensure its accuracy.

Quantitative data was obtained from a review of case files, which method yielded data on the number of cases handled and the number of cases in which acts of violence or other human rights violations were identified. This data was then subjected to a further in-depth qualitative analysis to ascertain the circumstances under which the incidents occurred, in order to ascertain that only cases in which such acts were perpetrated purely or primarily on the basis of real or presumed SOGIE are included in the report.

The data presented in this report is limited by the fact that it covers only cases reported through the HRAPF legal aid network. The report presents a fair picture of the situation for LGBTIQ persons across the country as reported to HRAPF's countrywide network of community paralegals, regional legal aid centres, specialized legal aid desks and the main legal aid clinic, but it may not be representative of all LGBTIQ persons' lived realities during the month, as we acknowledge the possibility that not all cases that occurred in July 2024 were reported to HRAPF's network.

3. Nature and number of cases reported

HRAPF handled a total of 72 cases in the month of July 2024, marking a reduction from the 81 cases handled in June 2024. Out of the 72 cases handled, 34 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 47.2% of all the cases handled during the month of July 2024. There was a slight increase in the number of cases in which individuals were targeted for negative treatment on the basis of their SOGIE, from 32 cases in June 2024 to 34 cases in July 2024 (a 6.25% increase), and the number of victims of these incidents increased from 34 persons in June to 40 persons in July 2024 (a 17.6% increase).

Out of the 34 cases in which LGBTIQ people were specifically targeted for detrimental treatment during the month of July 2024, 13 cases involved violence and threats of violence against persons on the basis of their SOGIE, 11 cases involved arrests based on sexual orientation and/or gender identity, while 10 were eviction cases.

This section of the report provides detailed data on these cases.

3.1 Cases involving actual and threatened violence

Cases involving violence and threats of violence against individuals on the basis of their real or presumed SOGIE were the highest category of cases registered during the month of July 2024 at 14 verified cases affecting 15 persons. This is a slight reduction from the 15 cases affecting 16 victims reported in June 2024.

i. Cases of actual violence on the basis of sexual orientation/gender identity

There were 9 cases of actual violence against persons on the basis of their real or presumed SOGIE in July 2024, affecting 10 persons. This violence was perpetrated by unknown persons in 6 cases, members of the general community in which the victims resided in 2 cases and the neighbours in 1 case. All the cases involved physical violence and the clients sustained injuries, some of which were serious. 3 of these cases were reported in Wakiso, 2 in Kampala, 2 in Busia and 1 case each in Omoro and Isingiro districts.

ii) Cases involving threats of violence based on sexual orientation and/or gender identity

A total of 4 cases involving threats of violence against persons on the basis of their real or presumed SOGIE were reported in July 2024. These directly affected 4 persons. All the 4 cases were threats of physical violence. The threats were perpetrated by family and religious leaders in 1 case, community leaders in 1 case, friends in 1 case and unknown persons in 1 case. Two cases happened in Wakiso and 1 case each in Gulu and Mbarara districts.

3.2 Cases of arrests

There was a drastic increase in the number of arrests on sexuality related charges from 5 arrests in June affecting 5 individuals to 11 arrests in July affecting 14 individuals.

In 8 of these cases, the persons arrested were charged under the AHA 2023; in 5 cases the clients were charged with homosexuality, in 2 cases the clients were charged with promotion of homosexuality and in 1 case the client was charged with attempted homosexuality. In 3 cases the clients were charged under the Penal Code Act, in one case each, the clients were charged with impersonation, and unnatural offences. In 3 cases where the clients had been charged under the AHA, the charges were sanctioned by the Office of the Director of Public Prosecutions and the clients were arraigned in courts of law, 2 on charges of promotion of homosexuality and 1 on charges of homosexuality. 2 cases were handled at Busia Chief Magistrate's Court while 1 case was handled

at the Mengo Chief Magistrate's Court. In 8 cases, the clients were released on police bond and these cases are still under investigation.

4 of these cases were registered from Kampala, 3 cases from Busia, 2 cases from Wakiso and 1 case each from Isingiro and Mukono districts.

3.3 Evictions

In July 2024, there were 10 cases of evictions from rented property that were reported to HRAPF's legal aid clinic, affecting 11 individuals. This was a reduction from the 12 cases recorded in July 2024, affecting 14 individuals. The cases were reported from the districts of Kampala (4), Wakiso (2), Mbarara (2) and 1 case each in Gulu and Kitgum. The evictions were perpetrated primarily by the property owners/ landlords (6), landlords working with the LC leadership in 2 cases and in 1 case each by neighbours and a friend.

4. Comparison with June 2024

Although there was a reduction in the overall number of cases reported, the number of cases involving actions that deliberately targeted persons for negative treatment on basis of their real or presumed SOGIE slightly increased and the number of victims also increased. In June 2024, a total of 81 cases involving LGBTI persons were reported as compared to 72 cases reported in July 2024. In terms of cases where individuals were specifically targeted on the basis of their real or presumed SOGIE, there was an increase from 32 cases affecting 35 persons in June 2024, to 34 cases affecting 39 persons in July 2024.

In both months, the highest number of recorded cases were cases involving violence and threats of violence against individuals on the basis of their real or presumed sexual orientation, with 15 cases affecting 16 individuals in June and 14 cases involving 15 persons in July 2024. For the first time ever, cases of arrests overtook cases of evictions as there were 11 such cases in July 2024 affecting 14

individuals, increasing from 5 cases affecting 5 individuals in June 2024. There cases of evictions continued to reduce to 9 evictions affecting 10 persons in July 2024 from 12 cases affecting 14 individuals in June 2024.

A worrying trend is the increase in the number of arrests and the use of charges under the AHA. 11 cases of arrests for sexuality related offences were recorded. Surprisingly, in nine of these cases, the individuals were never caught in any sexual act or any semblance of were individuals caught in the sexual act but were rather found at their work places, or the police plied into their phones, or there were accused by neighbours without evidence. Nevertheless, the police arrested then and in some instances the Office of the Director of Public Prosecutions preferred charges.

Anal examinations also resurfaced in at least one case – yet it is very clear that they are evidentially worthless and yet they greatly undermine the dignity, privacy and bodily autonomy of the victim.

Also pre-trial detention continues to be a big issue with those arrested spending more than 48 hours in police custody contrary to the provisions of the Constitution. In three of the cases, the persons were only released upon the police being served with applications for unconditional release that HRAPF lawyers had filed before courts of law.

5. Comparison with July 2023

In July 2023, two months after the AHA came into force, a total of 84 cases were handled involving LGBTIQ persons, of which 53 cases involved actions that directly targeted persons on the basis of their real or presumed SOGIE (63.1%) of all cases handled. The actions in these cases affected a total of 67 people and included 24 eviction cases, 21 cases of real or threatened violence and 6 arrests on sexuality related charges.

In contrast, 72 cases involving LGBTIQ persons were handled in July 2024, of which 34 cases involved actions of targeted/ deliberate homophobia (48.6% of all cases handled) and 39 persons were affected.

The number of cases in which individuals were specifically targeted for detrimental treatment purely on the basis of their SOGIE has reduced significantly between the two months, from 63.1% of all cases handled in July 2023, to 47.2% of all cases handled in July 2024, the 14th month of implementation of the AHA and the fourth consecutive month following the decision of the Constitutional Court doing away with some provisions of the Act.

6. The first 14 months of the AHA 2023 in Uganda

In the first 14 months of the AHA 2023, a total of 1,238 cases involving LGBTIQ persons have been handled across the legal aid network, of which 667 (53.9%) targeted LGBTIQ people on the basis of their sexuality, affecting a total of 850 persons. The breakdown of cases so far is as follows:

Although evictions still have the highest number of cases of overall and the highest number of victims, there has been a noticeable reduction in their number since the Constitutional Court decision nullifying provisions criminalizing the letting of premises for purposes of homosexuality. This shows the power of decriminalization in reducing the numbers of violations. It is also clear that the

numbers of violations recorded are way above the pre-AHA period, against showing the effect of criminalisation on increasing the number of violations against LGBTIQ persons.

7. Conclusion

While the continued implementation of the AHA remains a major challenge for the LGBTIQ community in Uganda, it is evident that the position of the law has a huge bearing on the human rights situation for LGBTIQ persons, as it is now clear that the modification of the law by the Constitutional Court led to a reduction in some types of violence and violations on the basis of SOGIE in a trend that has more or less held steady over the past months. Those provisions of the law which were not nullified continue to be a big source of violence and violations against LGBTIQ persons, specifically arrests.
