# **COI QUERY RESPONSE**

# 1. Exit from Ethiopia

Article 32 (1) of the Constitution of Ethiopia provides the following:

'Any Ethiopian or foreign national lawfully in Ethiopia has, within the national territory, the right to liberty of movement and freedom to choose his residence, as well as the freedom to leave the country at any time he wishes to'<sup>1</sup>.

According to a UN report on Ethiopia dated March 2015, 'Previously, it was not possible for every person to freely go abroad unless he/she got an exit visa. As this was found to limit the constitutional right to move from country to country, the Government has lifted the restriction to harmonize practices, laws and procedures with the constitution. These days, any Ethiopian is free to reside anywhere of his/her choice'<sup>2</sup>. A 2009 UN report on civil and political rights further specifies that 'A person may only be prevented from leaving the country by an explicit court order given in accordance with the law'<sup>3</sup>.

According to the Ethiopian Criminal Code (article 243) of 2004:

'Whoever intentionally: (a) departs from, enters into or resides in the territory of the State in violation of the national law; or (b) causes any of the acts specified in (a) above to be committed, is punishable with simple imprisonment or fine or with both'<sup>4</sup>.

The Law does not specify, however, the meaning of 'in violation of the national law'. Furthermore, no additional information could be found on this specific article of the criminal code.

In practice, freedom to leave the country has been restricted on several occasions, as illustrated below.

In **October 2013**, the BBC informs that Ethiopia's government had temporarily banned its citizens from travelling abroad to look for work to 'safeguard the well-being of citizens'<sup>5</sup>. The US Department of State (US DoS) notes that the 2013 ban on unskilled workers travelling to the Middle East for employment, continued in the **year 2016**<sup>6</sup>. In **November 2017**, the Migrant-Rights.org, an advocacy

organisation that aims to advance the rights of migrant workers, stated that the 'blanket ban on Ethiopian women migrating for domestic work' was still in place'<sup>7</sup>. On **30 January 2018**, however, the Ethiopian News Agency (ENA), a local news provider, announced that the Ethiopia had lifted the ban on Ethiopian citizens traveling to the Middle East in search of jobs<sup>8</sup>.

Sources also report on the travel limitations imposed on certain political figures. In **November 2015**, the passport of Zelalem Kibret, an Ethiopian blogger writing about politics, was confiscated when he was attempting to leave the country for the United States, a few months after he was released from prison. He had been detained for more than a year on terrorism charges related to his blog posts<sup>9</sup>. His passport was returned on 1 June 2016 and he was later permitted to travel abroad<sup>10</sup>. In **March 2016**, authorities prevented opposition leader Merera Gudina to leave the country. He was permitted to leave on June 2016<sup>11</sup>. According to the BBC, Mr Merera was arrested in **November 2016** at the airport in, Addis Ababa, after he returned from Brussels. Mr Merera had criticized the state of emergency in an address to the European parliament<sup>12</sup>. The same source informs that he was released on **17 January 2018**<sup>13</sup>.

Freedom of movement has also been restricted by the national state of emergency. The first national state of emergency lasted from October 2016 until August 2017<sup>14</sup> while the second was announced in February 2018 for a duration of six month<sup>15</sup>.

2. Treatment of returnees, in particular failed asylum seekers who exited the country illegally, by the government

### **Treatment of returnees**

Article 32 (2) of the Ethiopian Constitution specifies the following:

'Any Ethiopian national has the right to return to country' 16.

The governmental body responsible for receiving returnees is the Administration for Refugee & Returnee Affairs (ARRA)<sup>17</sup>. The European Union (EU) supports the Government of Ethiopia via different projects, and particularly the ARRA, in the sustainable reintegration of Ethiopian citizens returning from Europe<sup>18</sup>.

The US DoS, in its annual report on human rights practices for the year **2016**, states that 'the [Ethiopian] government cooperated with the Office of the UN High Commissioner for Refugees (UNHCR) and other humanitarian organizations in providing protection and assistance to internally displaced persons (IDPs), refugees, returning refugees, asylum seekers, stateless persons, and other persons of concern'<sup>19</sup>.

In **2016**, the International Committee of the Red Cross (ICRC) assisted returnees in Ethiopia with rebuilding of their homes and provided family-links services to the members of separated families among refugees and returnees<sup>20</sup>. The Ethiopian Red Cross Society (ERCS) indicates that it cooperates with the Ethiopian authorities in receiving returnees from abroad, although the source does not specify whether the returnees included failed asylum seekers<sup>21</sup>. The United Nations Office for the Coordination of Humanitarian Affairs (UN OCHA) notes that 'more than 14,000 undocumented Ethiopian migrants residing in Saudi Arabia have returned to Ethiopia between **15 November and 21 December 2017** [emphasis added]'<sup>22</sup>.

In **January 2018**, the EUObserver, an independent online newspaper, informs that Ethiopia was negotiating a deal with the European Union to deport to Ethiopia its nationals without the proper paperwork<sup>23</sup>. According to the same source, every Ethiopian residing without legal means in Europe will have their names submitted to the Ethiopia's National Intelligence and Security Services (NISS)<sup>24</sup>. Teshome Toga, Ethiopia's ambassador to the European Union, explained that 'The fundamental human rights of our citizens and of course the migrants will be respected', noting that there were around 3,000 Ethiopians in Europe<sup>25</sup>. In the same month, sources indicated that the admission procedures for the return of Ethiopians from the EU member states were agreed between the EU and Ethiopian authorities<sup>26</sup>.

# Treatment of failed asylum seekers who exited the country illegally

No information on the treatment of failed asylum seekers who exited the country illegally could be found amongst all sources consulted and within the timeframe allocated for this query.

On the treatment of failed asylum seekers in general, the below information was found.

In report dated **April 2015**, Landinfo, the Norwegian country of origin information centre, summarizes the situation of returnees to Ethiopia as follows:

'There is limited specific information about what has happened with Ethiopians who have returned to Ethiopia. Therefore, it is very difficult to give reliable information about what will happen with Ethiopians in exile who may be returned to Ethiopia by force and who are critical to the Ethiopian regime. Landinfo has experienced that the sources are vague and cautious in its statements about what may happen when Ethiopians are returned. The sources we have met differ on what may happen. Landinfo's assessment is that those who will be under the Ethiopian authorities' suspicion are, first and foremost, people they apprehend as a threat and who may mobilize and are prepared to use military force for change'<sup>27</sup>.

The Australian Department of Foreign Affairs and Trade (DFAT), in a September **2017** report on Ethiopia, notes that:

'Authorities typically welcome voluntary returnees to Ethiopia who are not outspoken opponents of the government. The government has on occasion publicised voluntary returns, in recognition of the Ethiopian diaspora's contribution to the economy through remittances. There have been some reports of authorities monitoring voluntary returnees for a period following their return, but DFAT is not aware of any credible reports of voluntary returnees who are not active opponents of the government facing problems stemming from their status as failed asylum seekers<sup>28</sup>.

On 2 February **2017**, the Immigration and Refugee Board of Canada (IRB) cites a senior Human Rights Watch researcher on the question of failed asylum claimants returned to Ethiopia:

'The Human Rights Watch Senior Researcher stated that, both in the case of dissidents who return home to visit or failed asylum claimants who are sent back to Ethiopia, "individuals who are known dissidents are at high risk of detention. Mistreatment and torture in detention are common" (Human Rights Watch 27 Jan. 2017). The same source added, without providing

further detail, that "higher profile individuals are sometimes treated better" (Human Rights Watch 27 Jan. 2017)<sup>29</sup>.
