The total number of victims SHRC was able to document in Syria on Wednesday 16-8-2018 reached 6 including 4 persons died under torture.

In Daraa province, 2 persons were killed by the explosion of a landmine at Tseel dam in the western suburbs.

Four persons died under torture in the regime's forces prisons including 2 from Rif Dimashq province and 1 from each of Raqqa and Hama.

The total number of victims SHRC was able to document in Syria on Thursday, 23-8-2018, reached 3 persons including 1 child and 1 died under torture.

In the province of Deir ez-Zor, a child was killed by a landmine left by ISIS in the village of al-Kushma in the south-eastern suburb.

In Idlib province, a man was killed while working when his bulldozer was targeted by a thermal missile near the village of al- Zarzur in the eastern suburbs.

A man from Jisreen in the province of Rif Dimashq died under torture in the regime prisons

The Syrian Human Rights Committee documented the name and details of the following victim:

1 – Amer Omar Darwish / Rif Dimashq – Jisreen / died under torture in a prison of the regime forces.

The other was a child who died due to an explosion of a "Dushka" machine gun left by ISIS while playing with it in the village of Sharabi in the Ein al-Arab/ Cobani.

Beware of Crossing Turkish Borders

The total number of victims SHRC was able to document in Syria on Sunday, 26-8-2018, reached 3 persons including: a child and a woman and (1) under torture.

In the province of Idlib, a woman and a girl from the Rif Dimashg were killed by Turkish border guards when they tried to cross the border illegally from the Agrabat area.

A man from Deir ez-Zor died under torture in the prisons of the regime forces after his arrest for almost 6 months.

The Syrian Human Rights Committee documented the names of the following victims:

- 1 Sidra Qarabash, girl / Rif Dimashq / shot dead by Turkish border guards (Gendarme)
- 2 Reham Saleh, woman / Rif Dimashq / shot dead by Turkish border guards (Gendarme).
- 3 Mahmoud As'ad Haj / Deir ez-Zor, Zabari / died under torture in the prisons of the regime forces after 6 months of his arrest.

The total number of victims SHRC was able to document in Syria on Wednesday, 29-8-2018, reached (4) people including: (1) under torture.

In the province of Aleppo (2) were killed in a bomb explosion near the roundabout Niroz in Afrin city, north of the province.

In Hama province, a person died under torture in the prisons of the regime forces.

In addition, a person from Swaida province was kidnapped and then a ransom was demanded to free him, then he was killed. It was thought that ISIS organisation was behind this act.

The Syrian Human Rights Committee documented the names of the following victims:

- 1 Mahmoud Hussein Subai / Hama Kurnaz / under torture in the prisons of the regime forces.
- 2 Khalaf al-Nader / Swaida / was killed after being kidnapped by members who are likely to be from ISIS.

The total number of victims SHRC was able to document in Syria on Thursday, 30 - 8, 2018, reached (2) persons, both of them were killed under torture in the regime prisons.

The nurse Daifallah Abdul Karim al-Khaswani, from the city of Sheikh Maskin in the province of Daraa died under torture in the prisons of the regime forces after over five years and a half years of arrest. Fadi Hamdou al-Ahmad, from the village of al-Ghadafa in Idlib province, was also tortured to death after six years of detention in the prisons of the regime's forces.


In Idlib province, 4 people died, 2 of them due to the bombing of the town of Badama, 1 died in a bomb explosion in the city of Sarmada, and 1 was assassinated by two persons driving a motorcycle in the village of Aglas in the northern suburbs of Sarqeb.

A person was also killed in the province of Aleppo by a car bomb that targeted a gathering of the people of Azaz in front of the local council in the city.

The Syrian Human Rights Committee documented the names of the following victims:

- 1 Mohammed Adel Al-Nashab / Aleppo province Talil Al Sham / as a car bomb exploded in front of the local council in the city of Azaz.
- 2 Abdul Rahman Fawaz al-Awad (an investigator in the village of Zerba south of Aleppo) / Aleppo countryside / was assassinated by two unknown men driving a motorcycle in the village of Eglas.

The total number of victims SHRC was able to document in Syria on Sunday 9-9-2018, reached 9 including two children and two persons who were tortured to death.

In the province of Hama, 3 people were killed in the bombing of the village of Al-Karkat and the town of Kfar Zita.

In the province of Idlib (2) persons were killed as a result of the shelling on the town of Habeet. A person in the province of Raqqa was also shot dead by the Kurdish militia SDF during the raid on the village of Qasra Srour.

A person was killed in Deir ez-Zor province by unidentified gunmen in the desert of al-Jazeerah.

Two persons from Al-Hasakah province died under torture in the prisons of the regime forces.

The Syrian Human Rights Committee documented the names of the following victims:

- 1 Mohammed Saleh al-Madaan / Raqqa / as a result of shooting at him by the elements of the Kurdish militia SDF during the raid on the village of Kasra Srour south of Raqqa city centre.
- 2 Riad Swadi Al-Junaid / Deir ez-Zor -Darnej / shot by unknown the desert of al-Jazeerah.
- 3 Arif Mohammed Hamada / Hama suburbs / due to the bombing of the explosive barrel on the city of Kafr Zita
- 4 Mohammed al-Hassan / Hama-Karnaz / from his wounds sustained as a result of the artillery shelling that targeted the village of Karakat in the western Hama suburbs.
- 5 Khaled al-Hasan / Hama-Karnaz / as a result of artillery shelling that targeted the village of Karakat in the western Hama suburbs.
- 6 Ahmad Hamoud al-Tabur / Hasaka Dashaisha / under torture in a prison of the regime forces.
 - 7. Abdullah Masik al-Ahmad / al-Hasakah al-Dashaisha / under torture in a prison of the regime forces.

In the province of Idlib (3) people were killed by a bomb explosion in front of a police office in the city of Salgin in the northern suburbs.

In the province of Aleppo, a girl was killed by the targeting her house by the regime's artillery in the town of Birna.

In the province of Ragga, a person was shot by the Kurdish militia SDF in the village of Rtala.

A person was also shot dead by unknown assailants in the town of Ghariba al-Sharqiya in Deir ez-Zor province.

The Syrian Human Rights Committee documented the names of the following victims:

- 1 The girl Marwa Shalash / Aleppo province Birna / due to the shelling of the town.
- 2- Mahmoud Taha al-Jada'an / Deir ez-Zor Mayadeen / after an explosive device was detonated at the gate of the Selqin police office in the northern suburbs of Idlib.
- 3 Khalaf al-Mukhlif al- Asaad Al-Daham / Deir ez-Zor Al-Husain / Killed by unknown gunmen in the town of Gharibaha Al-Sharqiya, which is under the control of SDF.

A person in Daraa province was also tortured to death in a regime prison.

The Syrian Human Rights Committee documented the names of the following victims:

- 1 Amer Ayash al Ahmad / Hama Kirnaz / injured by the shelling on al- Habit town in Idlib province few days ago.
- 2 Alaa Madallah al-Jundi / Daraa Nawa / died under torture in a prison of the regime forces

In Deir ez-Zor province, 2 people were killed, one by the Kurdish militia artillery shelling of the village of Baguz Faqani and the other under torture in one of the regime's prisons.

In the province of Hasaka, a person was killed by an explosion in his car for an unknown reason in the town of Tal Hamis.

A person in Rif Dimashq province died under torture in a prison of the regime forces.

In Idlib province, one person died in clashes between two families in the city of Hass.

In the province of Raqqa one person died in dispute with members of the Kurdish party "PYD".

The Syrian Human Rights Committee documented the names of the following victims:

1 – pharmacist Ahmad Yousef al-Bakkour / Idlib / as a result of clashes between two families in the town of Hass.

- 2) Issa al-Hajj Abdullah / Raqqa village of Khalidiyah / by members of "PYD" in a dispute with one of the elements of the party.
 - 3. child/Mohammed Al-A'tar, Homs, Miheen/ due to lack of health care and lack of medical supplies in Al-Rukban Desert Camp

The Syrian Human Rights Committee documented the names of the following victims:

- 1 Aiham al-Haka/ Raqqa province the village of al-Dhili / as a result of a landmine explosion planted by ISIS before withdrawing from the village.
- 2 Yaser Abdullah al-Musallat / Deir ez-Zor Khasham / due to the explosion of a landmine from the remnants of ISIS.

The names of the victims are:

- 1- Mudar Ibrahim al-Ajeel |Ar-Raqqah| Died under torture after being detained for almost four years
- 2- Abdul Razzaq Deebo, a "Comandos" policeman from Akhtarin |Rural Aleppo| Assassinated by unknown people on the Arshaaf-Akhtarin road in northern rural Aleppo.

SHRC documented the deaths of two people on Monday 24-09-2018, one a child and the other a victim of torture.

One person was killed in the town of Sweidan Jazeera (Deir Azzour province) when a curfew was imposed and the militia began to arbitrarily fire bullets. The other victim was from the Yarmouk camp in Damascus, and was killed under torture in a Syrian regime prison.

The number of victims documented by SHRC on Tuesday 25-09-2018 were four people, including a child.

Two were killed in Al-Hassaka province after they were kidnapped and subjected to torture. Their bodies were found on the Tal Tamar-al'aam road. In Aleppo, one person was killed by artillery bombing from the Syrian regime, during its bombardment of Kafar Hamra. In addition, one person was killed in Idlib when a device exploded in Saragib.

Names of the victims are:

- 1- Mohammed Nur bin Ali Dawalibi | Aleppo- Kafar Hamra | Killed during artillery bombing on his town
- 2- Iyad Majbaas (17 years) | Al-Hassaka | Was kidnapped by an unknown group and tortured and killed after the demand for ransom money
- 3- Omar Rashaad (18 years) | Al-Hassaka | Was kidnapped by an unknown group and tortured and killed after the demand for ransom money

The number of victims documented by SHRC on Wednesday 26-09-2018 were three people, including a victim of torture.

Two were killed in al-Hassaka when a land mine left by ISIS exploded in the town of Markada. Another person was killed by a landmine in Ar-Raqqah in the village of Abu Daali whilst doing farm work. In Latakkia, one person was documented to have been killed under torture in a Syrian regime prison.

1- Hammoud al-Faris | Ar-Raqqah | Killed during the explosion of an explosive device left by ISIS in the western Raqqah city.

The number of victims documented by SHRC on Monday 01-10-2018 were four people, including one who died under torture.

The four were killed in the Deir Azzour province, three of whom were summarily executed by ISIS under the accusation of recruiting and smuggling civilians. The fourth was killed in a Syrian regime prison.

The names are:

- 1- Badee' Janaa' al-Ghadwi | Deir Azzour- al-Susah | Executed by ISIS
- 2- Muhannad Zuheir ar-Ruwaili | Deir Azzour | Killed under torture in a Syrian regime prison after being detained for six years
