US Air Forces attack civilian targets in Deir ez-Zor

The total number of victims SHRC was able to document in Syria on Thursday, 22-11-2018, reached 10 persons including two children and one woman.

In the province of Deir ez-Zor, 7 people were killed the international coalition air force bombing of village Baq'an Aljazeera on 17-11-2018.

In the province of Idlib, two people were killed by unknown persons, one near the city of Sarqib and the other shot by HTS near the town of Kafrouma.

A person in the province of Aleppo has also been killed by unknown assailants.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Ahmad Hasan al-Na'asan / Idlib – Kafrouma / from his wounds sustained by bullets.

2 – Osman Daaboul / Aleppo – Batbo / was assassinated by unknown persons

The total number of victims SHRC was able to document in Syria on Friday 23-11-2018, reached 9 persons including 4 children and a woman.

In Deir ez-Zor province, 7 people were killed, including 6 by the bombing of Al-Shou'fa village at dawn, and 1 by a landmine explosion in Al-Basira city.

In the province of Idlib (2) were shot dead by unidentified persons after Friday prayers in the city of Kafranbel which is under the control of HTS.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Media activist Raed Al-Fares / Idlib-Kafranbel / by unknown gunmen in the city after Friday prayers

2- Media activist Hamoud Juneid / Idlib- Kfarnbel / by unknown gunmen in the city after Friday prayers

3. Khalif al-Karbouli / Deir ez-Zor/ Abokmal / in a landmine explosion in the town of al-Basira.

Jarjanaz massacre caused by the regime shelling at school home time

The total number of victims SHRC was able to document in Syria on Saturday, 24-11-2018, reached 17 people including 11 children and 2 women.

In Idlib province, 12 people of whom 8 were killed by the shelling of the town of Jarjanaz by the forces of the regime at school home time, while other 4 whose bodies were found between the city of Idlib and the village of Batanta, to the north of Idlib, where they were executed in the field without knowing their charges.

In Aleppo province, 5 children were killed in the explosion of a landmine left by ISIS in the town of Tal Al-Hawa.

US led coalition bombing of towns in north east Syria

The total number of victims SHRC was able to document in Syria on Sunday 25-11-2018, reached 4 persons including 2 children.

In Deir ez-Zor province, 3 persons were killed, 2 of whom were shot dead by an armed group and 1 by the bombing of the international coalition air force of the town of al-Hajin.

In the Idlib province 1 was killed by the artillery shelling on the town of Jarjanaz by the regime forces.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Child/ Nimr Maher Al-Asidah 10 years / Deir ez-Zor / by stray shot as a result of clashes between elements ISIS and the militia SDF in the town of al-Bahra.

2- Mohammed Al-Karhout, nicknamed Hawalli / Deir ez-Zor, following the attack of the international coalition aircraft to his home in al-Hajin city.

3 – Thib Isma'il Al-Talq / Deir ez-zor / shot by ISIS during their raid of the town of Garanige.

4 – Infant/ Amina Alaa Dibo 3 years / Idlib – Jarjanaz / due to the regime artillery shelling on the town.

Seidnaya military prison

The total number of victims SHRC was able to document in Syria on Monday 26-11-2018 was 1 person.

The family of the detainee Leila Shaukani, who came from the capital Damascus and has US citizenship, was informed via the Civil Registry Department of her death two years ago. It was believed that she died under torture in Seidnaya prison after her transfer from Adra Prison at the end of 2016.

The total number of victims SHRC was able to document in Syria was 3 persons on Saturday 1-12-2018, including 1 who died under torture.

In the Idlib province, a person was killed by unknown assailants in front of his house in the town of Tal Adeh, it is worth to be mention that he started to work an investigator at the Afrin court.

In the province of Hama, a person was killed by the regime forces artillery shelling on the town of Kafr Zita.

In the province of Rif Dimashq, a person was tortured to death in Seidnaya Military Prison.

The Syrian Human Rights Committee documented the names of the following victims:

1 – Mehran Hossam Daaboul / Rif Dimashq – Tall / died under torture in Seidnaya prison

2- Munir Abdul Hamid Kamel (an investigator at the Afrin Court) / Idlib / was assassinated in front of his house in the town of Tal Adeh

3. Samer Mohammed al-Yaqub / Hama Suburbs / due to the shelling of Kafr Zita
